1 The sums appropriated shall be expended by the department 2 of transportation, highways division, for the purposes of this 3 Act. 4 PART III 5 SECTION 3. The sums hereinabove may be paid to the 6 respective persons, firms, corporations, or entities for the 7 satisfaction or settlement of the respectively identified cases, and in several amounts hereinabove set forth or in lesser 8 9 amounts deemed appropriate, upon checks issued by the comptroller; provided that departments shall obtain the approval 10 11 of the attorney general before payment of any claim may be made. 12 SECTION 4. Notwithstanding the sums hereinabove stated as interest upon judgments against the State, payment of interest 13 shall be limited to the period from the date of the judgment, if 14 15 applicable, to thirty days after the effective date of this Act, as provided in section 662-8, Hawaii Revised Statutes, for those 16 17 cases to which the statute applies. SECTION 5. All unexpended and unencumbered balances of the 18 appropriations made in this Act as of the close of business on 19 20 June 30, 2024, shall lapse.
