# A BILL FOR AN ACT

RELATING TO CORRECTIONS.

**BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:**

1           SECTION 1. The legislature finds that a civil lawsuit in  
2 federal court alleged that a group of women at the women's  
3 community correctional center were sexually assaulted at least  
4 fifty-three times from 2013 to 2016. A similar case, *Smith v.*  
5 *State of Hawaii*, resulted in a \$100,000 settlement, with \$50,000  
6 coming from the State and another \$50,000 coming from the guard  
7 who pled guilty. These lawsuits pointed specifically to the  
8 lack of cameras in the correctional center's control rooms,  
9 where a majority of the sexual assault allegedly occurred.  
10 According to court documents, in some cases, staff offered food,  
11 makeup, crystal meth, and special privileges to inmates in  
12 return for compliance with sexual demands, and punishments for  
13 noncompliance. Any sexual contact between an inmate and staff  
14 is a felony under existing law because prisoners cannot legally  
15 give consent.

16           The legislature further finds that additional cameras in  
17 control rooms and body cameras for all guards would help deter



1 sexual assaults and contraband, thereby building a defense  
2 against future lawsuits and protecting inmates from rogue  
3 guards.

4 The purpose of this Act is to:

5 (1) Require the department of public safety to install  
6 cameras at the women's community correctional center;

7 (2) Require guards to wear functioning body cameras while  
8 on duty at the women's community correctional center;

9 and

10 (3) Appropriate funds.

11 SECTION 2. On or before July 1, 2024, the department of  
12 public safety shall install digital cameras in all guard control  
13 rooms in the women's community correctional center and require  
14 all guards to wear functioning body cameras while on duty at the  
15 women's community correctional center. There shall be  
16 sufficient coverage to ensure the health and safety of all staff  
17 and inmates. The department of public safety shall ensure the  
18 documentation and accessibility of video evidence that may  
19 pertain to misconduct by staff or inmates, negligent or abusive  
20 treatment of inmates, or criminal activity within the women's  
21 community correctional facility.



1 SECTION 3. There is appropriated out of the general  
 2 revenues of the State of Hawaii the sum of \$100,000 or so much  
 3 thereof as may be necessary for fiscal year 2023-2024 and the  
 4 same sum or so much thereof as may be necessary for fiscal year  
 5 2024-2025 for the department of public safety to purchase and  
 6 install digital cameras in all guard control rooms of the  
 7 women's community correctional center and to purchase body  
 8 cameras for guards to wear while on duty at the women's  
 9 community correctional center.

10 The sums appropriated shall be expended by the department  
 11 of public safety for the purposes of this Act.

12 SECTION 4. On January 1, 2024, all responsibilities and  
 13 appropriations under this Act shall transfer from the department  
 14 of public safety to the department of corrections and  
 15 rehabilitation, as established by Act 278, Session Laws of  
 16 Hawaii 2022.

17 SECTION 5. This Act shall take effect on July 1, 2023.

**Report Title:**
