A BILL FOR AN ACT

RELATING TO FOOD SAFETY.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. The legislature finds that, according to the
- 2 Pacific Regional Integrated Sciences and Assessments Program,
- 3 Hawaii is the most geographically isolated state in the country
- 4 and imports approximately ninety-two per cent of its food. Each
- 5 food product imported to Hawaii is a lost opportunity for
- 6 building economic growth in the agricultural sector, increasing
- 7 resiliency in the face of future supply chain disruptions, and
- 8 attaining state goals for local food production, including
- 9 benchmarks for Hawaii's farm-to-school program, food purchasing
- 10 by state agencies, and food hubs.
- 11 The United States Department of Agriculture created the
- 12 GroupGAP program in 2015 to assist small farms with attaining
- 13 Good Agricultural Practices (GAP) certification. GroupGAP
- 14 reduces the cost of food safety certification by spreading the
- 15 training, technical assistance, and auditing costs between all
- 16 farms in the group. Hawaii GroupGAP is the only comprehensive
- 17 farm food safety training program in Hawaii that results in

- 1 United States Department of Agriculture harmonized GAP
- 2 certification, the standard most closely aligned with the Food
- 3 and Drug Administration's food safety guidelines.
- 4 In recognizing the need for more locally produced food, the
- 5 legislature passed Act 136, Session Laws of Hawaii 2022, which
- 6 required the department of agriculture to partner with the
- 7 agricultural community to establish a food safety certification
- 8 training program, and appropriated funds for the training
- 9 program. However, the funds appropriated were directed in full
- 10 to the University of Hawaii college of tropical agriculture and
- 11 human resources, which does not have a United States Department
- 12 of Agriculture GroupGAP food safety training and certification
- 13 program. The legislature finds that in order for a GroupGAP
- 14 food safety training and certification program to be
- 15 established, an additional appropriation must be made.
- 16 Accordingly, the purpose of this Act is to appropriate
- 17 funds for the establishment of a GroupGAP food safety training
- 18 and certification program.
- 19 SECTION 2. There is appropriated out of the general
- 20 revenues of the State of Hawaii the sum of \$1,000,000 or so much
- 21 thereof as may be necessary for fiscal year 2023-2024 and the

- 1 same sum or so much thereof as may be necessary for fiscal year
- 2 2024-2025 for the department of agriculture to establish and
- 3 implement, under general administration for agriculture, a
- 4 GroupGAP food safety training and certification program.
- 5 The sums appropriated shall be expended by the department
- 6 of agriculture for the purposes of this Act.
- 7 SECTION 3. This Act shall take effect on July 1, 2023.
