## A BILL FOR AN ACT

RELATING TO PUBLIC WORKS.

#### BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

SECTION 1. Section 104-24, Hawaii Revised Statutes, is
amended to read as follows:

3 "\$104-24 Violations; penalties. (a) Where the department 4 finds that a first violation of this chapter has been committed, 5 the department, after proper notice and opportunity for hearing, 6 shall assess and order the person or firm in violation to be 7 jointly and severally liable for a penalty equal to twenty-five 8 per cent of the amount of back wages found due or \$250 [per] for 9 each offense, up to \$2,500, whichever is greater.

10 (b) Where the department finds that a second violation of 11 this chapter has been committed, whether on the same or another 12 contract, within two years of the first notification of 13 violation, the department, after proper notice and opportunity 14 for hearing, shall assess and order the person or firm in 15 violation to [pay] be jointly and severally liable for a penalty 16 equal to the amount of back wages found due or \$500 for each 17 offense, up to \$5,000, whichever is greater.

#### Report Title:

Wages and Hours of Employees on Public Works; Violations; Penalties; Suspension; DLIR

#### Description:

Orders the person or firm found to be in violation of the state law governing wages and hours of employees on public works to be jointly and severally liable for the penalty, with the penalty increasing for repeat violations. Requires each notice of violation to contain the names of the person and the firm. Defines a "person" and "firm" for purposes of violations of the state law governing wages and hours of employees on public works, and related penalties and suspension. Requires the director of labor and industrial relations to suspend the person and firm under specified conditions. (CD1)
