A BILL FOR AN ACT

RELATING TO EMERGENCY MEDICAL RESPONSE.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. The legislature finds that in critical medical
- 2 emergencies, each minute matters. Long-term injury, brain
- 3 damage, and even death can occur within just a few minutes in
- 4 some types of emergencies. Whether it is a student choking or a
- 5 teacher experiencing cardiac arrest, help provided within four
- 6 minutes, rather than eight minutes, can save a life.
- 7 The legislature further finds that while the department of
- 8 education currently has basic emergency response guidance, there
- 9 is a gap between the guidance provided to "administer first aid"
- 10 and the training and preparedness of personnel in the case of an
- 11 unforeseen critical medical emergency.
- Accordingly, the purpose of this Act is to supplement the
- 13 department of education's emergency procedures guide,
- 14 RS 10-0431, by requiring that each public school's
- 15 administration appoint critical emergency response team members
- 16 and establish procedures to respond immediately to critical
- 17 medical emergencies.



1	SECT	ION 2. Chapter 302A, Hawaii Revised Statutes, is
2	amended b	y adding a new section to part III, subpart F, to be
3	appropria	tely designated and to read as follows:
4	" <u>§30</u>	2A- Critical medical emergency response. (a) Each
5	public sc	hool shall establish a critical emergency response team
6	that shal	l consist of critical emergency response team members.
7	(b)	On each school day, the number of critical emergency
8	response	team members on each school campus shall not be less
9	than the	greater of:
10	(1)	The total number of staff and students on campus
11		divided by fifty; or
12	(2)	The square footage of the campus divided by five
13		hundred.
14	<u>(c)</u>	Each critical emergency response team member shall:
15	(1)	Maintain active certifications in first aid,
16		cardiopulmonary resuscitation, and automated external
17		defibrillator from organizations approved by the
18		department; provided that any certification more than
19		two years old shall not be valid for purposes of this
20		paragraph;
21	(2)	Respond in good faith when activated; and

1	(3) Participate in drills, table-top exercises, and all		
2	critical emergency response team activities in		
3	accordance with the school's existing continuous		
4	quality improvement practices and reviews.		
5	(d) Each school shall develop a known, practiced, and		
6	maintained communication method to activate their critical		
7	emergency response team members, including through phone,		
8	short-wave radio, or intercom system, in addition to an internal		
9	incident command and activation system to provide the location		
10	of the critical medical emergency.		
11	(e) Each school shall run no less than two critical		
12	medical emergency drills during each school year. The drills		
13	shall be run by an administratively designated drill captain who		
14	shall monitor response times with a timer. All drills shall be		
15	run during a high-activity period on campus to support		
16	assessment of a real case scenario.		
17	(f) Any drills with a response time longer than three		
18	minutes shall require an internal table-top exercise and review,		
19	as well as a corrective action plan. Any school with three or		
20	more drills resulting in a response time longer_than_three		

- 1 minutes, shall receive support in their corrective actions by
- 2 their complex superintendent.
- 3 (g) Critical emergency_response team member drill reports
- 4 and reviews shall be published on the school's and department's
- 5 website.
- 6 (h) For purposes of this section:
- 7 "Critical" means a situation in which a person is in
- 8 immediate danger of loss of life, including as cardiac arrest,
- 9 choking, or uncontrolled bleeding.
- 10 "First aid" means lifesaving help given in a critical
- 11 emergency, including providing abdominal thrusts when someone is
- 12 choking, performing cardiopulmonary resuscitation when someone
- 13 is unconscious and does not have a pulse, or applying pressure
- 14 or a tourniquet in an uncontrolled bleeding."
- 15 SECTION 3. There is appropriated out of the general
- 16 revenues of the State of Hawaii the sum of \$ or so much
- 17 thereof as may be necessary for fiscal year 2023-2024 and the
- 18 same sum or so much thereof as may be necessary for fiscal year
- 19 2024-2025 for public schools to implement critical medical
- 20 emergency teams.

- 1 The sums appropriated shall be expended by the department
- 2 of education for the purposes of this Act.
- 3 SECTION 4. New statutory material is underscored.
- 4 SECTION 5. This Act shall take effect on July 1, 2023.
