A BILL FOR AN ACT

RELATING TO EMERGENCY MEDICAL RESPONSE.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

SECTION 1. The legislature finds that in critical medical
emergencies, each minute matters. Long-term injury, brain
damage, and even death can occur within just a few minutes in
some types of emergencies. Whether it is a student choking or a
teacher experiencing cardiac arrest, help provided within four
minutes, rather than eight minutes, can save a life.

7 The legislature further finds that while the department of 8 education currently has basic emergency response guidance, there 9 is a gap between the guidance provided to "administer first aid" 10 and the training and preparedness of personnel in the case of an 11 unforeseen critical medical emergency.

Accordingly, the purpose of this Act is to supplement the department of education's emergency procedures guide, RS 10-0431, by requiring that each department school's administration appoint critical emergency response team members and establish procedures to respond immediately to critical medical emergencies.

1	SECTION 3. There is appropriated out of the general				
2	revenues of the State of Hawaii the sum of \$ or so				
3	much thereof as may be necessary for fiscal year 2023-2024 and				
4	the same sum or so much thereof as may be necessary for fiscal				
5	year 2024-2025 for department schools to implement critical				
6	medical emergency response teams.				
7	The sums appropriated shall be expended by the department				
8	of education for the purposes of this Act.
