Your Committee on Conference on the disagreeing vote of the House of Representatives to the amendments proposed by the Senate in H.B. No. 278, H.D. 1, S.D. 2, entitled:

"A BILL FOR AN ACT RELATING TO HEALTH,"

having met, and after full and free discussion, has agreed to recommend and does recommend to the respective Houses the final passage of this bill in an amended form.

The purpose of this measure is to appropriate funds for the Executive Office on Aging to create an Alzheimer's disease and related dementias public health campaign.

Your Committee on Conference has amended this measure by:

- (1) Inserting an appropriation amount of \$1,000,000 for the Alzheimer's disease and related dementias public health campaign;
- (2) Adding the requisite information for making an appropriation in excess of the general fund expenditure

- (3) Changing the effective date to July 1, 2023; and
- (4) Making technical, nonsubstantive amendments for the purposes of clarity, consistency, and style.
