S.B. No. 547 entitled:

"A BILL FOR AN ACT RELATING TO THE BOARD OF REGENTS,"

begs leave to report as follows:

The purpose and intent of this measure is to amend the law  
relating to the Board of Regents.

Prior to the hearing on this measure, your Committee posted  
and made available for public review a proposed S.D. 1, which  
amends this measure by deleting its contents and replacing it with  
language that requires the University of Hawaii's Board of Regents  
to approve by majority vote any designee selected to serve or  
participate for the Board of Regents' Chairperson as a voting or  
nonvoting member of any legislatively established board,  
commission, working group, or task force.

Your Committee has amended this measure by adopting the  
proposed S.D. 1.

As affirmed by the record of votes of the members of your  
Committee on Higher Education that is attached to this report,  
your Committee is in accord with the intent and purpose of S.B.  
No. 547, as amended herein, and recommends that it be recommitted  
to your Committee on Higher Education, in the form attached hereto  
as S.B. No. 547, S.D. 1, for further consideration.
