SB 690 Status & Testimony	RELATING TO ENERGY EFFICIENCY. Prohibits the sale of certain fluorescent lamps as a new manufactured product, with certain exemptions.	EET, CPN
SB 817 Status & Testimony	RELATING TO STATE ENTERPRISE ZONES. Amends the definition of "eligible business activity" to include the processing of value-added agricultural products grown within an enterprise zone and the development or production of renewable energy.	EET, WAM
SB 1231 Status & Testimony	RELATING TO DIGITAL EQUITY. Establishes the Digital Equity Grant Program to award grants to applicants to deploy digital equity projects to covered populations in the State. Appropriates funds.	EET, WAM
SB 837 Status & Testimony	RELATING TO THE DEPARTMENT OF BUSINESS, ECONOMIC DEVELOPMENT, AND TOURISM. Authorizes the Department of Business, Economic Development, and Tourism to acquire real, personal, or mixed property; to clear, improve, and rehabilitate and to sell, assign, exchange, transfer, convey, lease, dispose, or encumber the property; and acquire property by condemnation.	EET, JDC

- Testifiers for this hearing will be limited to **1 minutes** each.
