### RELATING TO THE GENERAL EXCISE TAX.

HLT/ECD, FIN

Exempts medical services provided by health care providers to patients who receive Medicaid, Medicare, or TRICARE benefits from the general excise tax. Applies to taxable years beginning 1/1/2024.
