HB 1097, HD2 (HSCR1081) Status & Testimony	RELATING TO THE UNIFORM CONTROLLED SUBSTANCES ACT. Updates the Uniform Controlled Substances Act by adding substances scheduled under federal law. (HD2)	JDC
HB 1100, HD1 (HSCR944) Status & Testimony	RELATING TO CONFORMITY TO THE INTERNAL REVENUE CODE. Conforms Hawaii income and estate and generation-skipping transfer tax laws to the Internal Revenue Code of 1986, as amended as of December 31, 2022. Effective 6/30/3000. (HD1)	JDC, WAM
HB 1294, HD1 (HSCR826) Status & Testimony	RELATING TO ELECTIONS. Requires every candidate for public office in Hawaii to use their legal name for election purposes. Effective 6/30/3000. (HD1)	JDC
HB 1344, HD2 (HSCR1061) Status & Testimony	RELATING TO ANGER MANAGEMENT. Requires certain criminal offenders to be ordered by a court to complete an assessment and either a domestic violence intervention or anger management course as part of their sentence. (HD2)	JDC

While submitting your written testimony, you will be prompted to indicate if you would also like to testify at the hearing in-person or remotely via videoconference.

Please note the following:

- The number of oral testifiers and/or time allotted to each testifier may be limited by the Chair when necessary to adhere to the committee hearing schedule. We may not be able to accommodate everyone who requests to testify orally.
- Testifiers for this hearing will be limited to **2 minutes** each.
