Establishes procedures for the Department of Transportation to assist and enable a person to voluntarily purchase a verified carbon offset for carbon dioxide emissions resulting from the person's air travel to or from an airport in the State. <u>SB 1006</u> Status & Testimony	RELATING TO COASTAL ROADS. Appropriates funds for the Department of Transportation to engage climate change adaptation measures for the State's low-lying roads and highways.	TCA/AEN, WAM
<u>SB 1024</u> Status & Testimony	RELATING TO TRANSPORTATION. Establishes long-term goals for zero-emissions transportation in Hawaii and abroad to reduce and eliminate transportation emissions. Establishes the ground transportation and interisland and transpacific transportation working groups. Requires annual reports to the Hawaii Climate Change Mitigation and Adaptation Commission and the Legislature.	TCA/AEN, WAM
