The Senate Committee on Ways and Means and the House Committee on Finance will conduct a joint informational briefing on Chapter 42F, Hawaii Revised Statutes, grant applications. This information gathering briefing will be conducted in-person at the State Capitol Auditorium and via Zoom.

- 6. Zoom participants will be called on after all in-person participants have spoken;
- 7. As this is an informational briefing, no written testimony is being accepted;
