RELATING TO TAX CREDITS.

WAM

Establishes a state income tax credit for qualified expenses incurred by certain individuals employed by DOE, the Hawaii state public library system, or as part of a head start program in a school. Effective 6/30/3000. (HD2)

- Testifiers for this hearing will be limited to **ONE minute** each.
