Chair Rhoads, Vice Chair Gabbard, and members of the Senate Committee on Judiciary:

I respectfully ask for your favorable consideration of Governor's Message No. 502, the appointment of Anne Lopez to be Attorney General for the State of Hawaii.

From May 2015 through December 2022, Anne held numerous roles within the Hawaii Health Systems Corporation (HHSC), including as Vice President, General Counsel, and Chief Operating Officer. In these roles, she was responsible with leading the in-house legal department, which includes the corporate director of risk management, a staff of attorneys, and legal support staff in providing legal counsel and healthcare risk management services for Hawaii's state-owned healthcare system and all its affiliates. She was also responsible with working to facilitate the passage of healthcare legislation and ensured system-wide compliance with federal and state laws.

In addition to her work at HHSC, Anne also has a diverse background of public and private service. She served as a Special Assistant to Attorney General David Louie, a Transaction and Litigation Associate/Of Counsel at the Law Firm of Chun, Kerr, Dodd, Beaman and Wong, a Litigation Associate at the Law Firm of Kobayashi, Sugita and Goda, and was a Law Clerk for Hawaii State Supreme Court Justice Paula Nakayama. Governor's Message 502 submits for consideration as the Attorney General, Department the Attorney General, Anne Lopez for a term to expire on December 7, 2026. The Department of Land and Natural Resources (Department) supports this nomination.

Ms. Lopez has spent the last eight (8) years with the Hawaii Health Systems Corporation (HHSC), most recently as the Vice-President and General Counsel. She started with HHSC as the Chief Operating Officer and General Counsel in May of 2015.

Prior to her work with HHSC, Ms. Lopez was a Special Assistant to the Attorney General, State of Hawaii, for three years, where she worked on facilitating passage of the Administration's legislative agenda, including marriage equality and medical marijuana legislation. Ms. Lopez' work at the Department of the Attorney General afforded her an opportunity to work with most state administrative agencies and legislators and provided her familiarity with the legislative process.

Ms Lopez gained litigation experience in private practice at two of Hawaii's top law firms. She clerked for Hawaii Supreme Court Justice Paula Nakayama and served as a summer Law Clerk for Dwyer, Imanaka, Kudo, Meyer and Fujimoto in 1999 and for Kobayashi, Sugita and Goda in 2000. From 1985 through 1999 Ms Lopes worked mainly in the area of Occupational Health mainly in Hawaii, but also in Denver, Colorado. During the latter part of this period, Ms. Lopez also attended the William S. Richardson Law School, graduating summa cum laude in May 2001.

TESTIMONY IN OPPOSITION

Nominee Anne Lopez has exhibited gross negligence when submitting testimony on pending legislation this year, in the role of Attorney General. Her negligence disqualifies her from this office.

Ms. Lopez' testimony totally ignored explicit language in at least two bills, SB32 and SB52, that would enact new laws violating a highly publicized decision by the U.S. Supreme Court, and another decision by the U.S. District Court in Honolulu which was upheld by the 9th Circuit Court of Appeals. By discussing other Constitutional issues while ignoring these two Constitutional decisions pertaining to the 15th Amendment, her testimony implicitly endorses proposed new laws about voting which are blatantly and notoriously unconstitutional according to federal court rulings.

SB32 pdf version page 6 lines 18-20 says that OHA board members shall be "elected by qualified voters who are Hawaiians, as provided by law. The board members shall be Hawaiians."

SB52 pdf version page 1 lines 14-16 says "No person shall be eligible for election or appointment to the board unless the person is Hawaiian ..."

Those racist requirements were written into the 1978 amendment to the Hawaii Constitution that created OHA; but because OHA is an agency of the State government, the federal courts ruled them contrary to the U.S. Constitution and stripped them out of the State Constitution.

The racial restriction regarding who can vote for candidates for the OHA board was ruled unconstitutional by the U.S. Supreme Court in Rice v. Cayetano, 528 U.S. 495 (2000), by vote of 7-2.

Later in year 2000 the U.S. District Court in Honolulu, Judge Helen Gillmor presiding, ruled that there can be no racial restriction on who can run as a candidate for OHA trustee. The case was CV 00-00514 HG-BMK Arakaki et. al. vs. State of Hawaii et. al, and OHA as intervenor. I was honored to be among the multiracial group of 13 plaintiffs including 3 Native Hawaiians.

Governor Cayetano ousted all nine OHA trustees on grounds they had been illegally elected. In the election of November 2000 I ran as a candidate for OHA trustee, along with 95 other candidates for the 9 seats. There were at least a dozen so-called "non-Hawaiians" [Hawaii citizens with no native blood] among the 96 candidates; and one of them, Charles Ota, won the Maui seat. Judge Gillmor's civil rights racial desegregation decision was appealed to the 9th Circuit Court of

Appeals, and was upheld by the three-judge panel, with the final judgment filed on July 1, 2003 by Honolulu clerk Walter Chinn.

The judgment concludes: "... The State is ordered to permit otherwise qualified non-Hawaiians to run for office and to serve, if elected, as trustees of the Office of Hawaiian Affairs. Section 5 of Article XII of the State Constitution and HRS \hat{A} § 13D-2 violate the Fifteenth Amendment and the Voting Rights Act, to the extent that they require persons running for OHA trustee positions and serving, if elected, to be Hawaiian."

Ms. Lopez' testimony on SB32 and SB52 discussed difficulties regarding the 14th Amendment requirement often referred to as "one person one vote", but so far as I am aware she has never testified on the clear violation of another aspect of the 14th Amendment often referred to as the "equal protection clause" -- despite the large number of bills appropriating huge sums of money, or providing special benefits, for one favored racial group to the exclusion of all other racial groups.

I believe Ms. Lopez is disqualified from being confirmed as Attorney General because of her egregious negligence in failing to object to the unconstitutional racial restrictions on voting and candidacy in SB32 and SB52, even while her testimony discussed other constitutional issues.

But if this committee chooses to vote in favor of confirming her nomination, I believe such approval should be given only after she does two things: (1) apologize for her negligence in failing to object to the proposed racial restrictions on voting and candidacy in SB32 and SB52; and (2) promise to warn against violations of the 14th Amendment equal protection clause on all bills in 2024 which provide money or benefits that are exclusively for one racial group.

I submit this letter in strong support of Anne E. Lopez for the position of Attorney General, Department of the Attorney General, State of Hawaii.

I am the former Attorney General of the State of Hawaii, having served under Governor Neil Abercrombie from 2011 through 2014. I have been a practicing lawyer for the past 45 years, since 1978. I served as the President and Director of the Hawaii State Bar Association, Lawyer Representative for the U.S. Court of Appeals of the Ninth Circuit, Northwest Regional Governor of the National Asian Pacific American Bar Association, Vice Chair of the Hawaii Supreme Court Rule 19 Committee on Judicial Performance, Chair and Director of the Aloha Tower Development Corporation, and on numerous Bench Bar Committees. I served as a Co-Vice Chair on the recent Task Force on Civil Justice Improvements, which revised the Civil Rules for Hawaii's Circuit Courts.

I have worked with and observed many state Attorneys General on numerous occasions, both in Hawaii and nationally. I have also worked with many lawyers and judges during my career. appeared before the Hawaii Supreme Court and the U.S. Court of Appeals of the Ninth Circuit. I am very familiar with how the justice system works and the role of the Attorney General.

I strongly recommend that you select Ms. Lopez for this position. I have known Ms. Lopez for the past ten (10) years. I first met Ms. Lopez at the end of 2012 when I served as the Attorney General for the State of Hawaii. Ms. Lopez was hired by me to serve as the Special Executive Assistant to the Attorney General. I worked with her frequently on numerous matters and interacted with her while she served as Special Executive Assistant. Ms. Lopez handled special projects, assisted with the preparation and vetting of legislative testimony and served on numerous departmental committees. I had many discussions with her, consulted with her on a daily basis and saw her perform on many occasions. She was always well prepared, intelligent, articulate and reasonable.

After I left the Attorney General position and returned to private practice, I was retained on several occasions by Ms. Lopez to serve as litigation counsel for the Hawaii Health Systems Corporation (HHSC) where Ms. Lopez served as General Counsel. I worked closely with her on the handling of various lawsuits filed against HHSC. Ms. Lopez has been in public service for the past decade and has served admirably. I have thus observed Ms. Lopez in a variety of settings and find her to be a person who would make an excellent Attorney General.

Ms. Lopez is very well qualified to serve as Attorney General. First, Ms. Lopez is an excellent lawyer who understands law and policy from a practical experiential perspective and is familiar with many legal issues that apply to the State of Hawaii. She has the intelligence, legal knowledge and experience to guide the Department of the Attorney General. During her time as Special Executive Assistant, she handled major initiatives in the Department, such as the legalization of same sex marriage by the Legislature. Ms. Lopez was part of the small team of deputy attorneys general who were involved in drafting the legislation that resulted in the legalization of same sex marriage in Hawaii and providing legislative strategy to ensure that the bill became law. When she was General Counsel of HHSC, she handled the sale of certain hospitals to private insurers, and managed the transition of those hospitals to ensure better financial solvency and patient care.

My name is Joshua Wisch and I am testifying in my individual capacity **in support of Anne Lopez** to be confirmed as Attorney General.

I have known Anne for almost twenty years, and I have had the good fortune of being able to work with her often during that period. Anne and I first worked together while we were fellow associates at the Chun Kerr¹ law firm. I worked at Chun Kerr from 2005 through 2008 during which time I was a litigator and Anne did transactional work. Because it was a mid-sized firm, all the attorneys worked together closely, and transactional attorneys and litigators frequently collaborated. As a result, I got to see Anne's legal work up close for years and was consistently impressed by the clarity of her legal thinking, her creative problem-solving approaches to our clients' problems, and her great partnership as a fellow attorney.

After leaving the firm I served in several different roles, eventually going to work as Special Assistant to the Attorney General under then-Attorney General David Louie in 2011. Anne and I maintained our friendship during this time, and I would regularly seek her advice and counsel. In 2013 Governor Abercrombie asked me to move from the Department of the Attorney General (ATG) to become Deputy Director of the Department of Taxation (DOTAX). This counsel ranges from constitutional interpretation, to review of complex contracts and litigation, to legislative analysis. The Attorney General must be able to delegate and assemble a team with the big picture in mind. They must have the acumen to determine which lawyers in the department should handle legislative or administrative briefings, which may need to be assigned to specific litigation, and have the situational leadership skills to know when to pivot.

I write in <u>strong support</u> of the nomination of Anne Lopez to the position of Attorney General of the State of Hawai'i.

I currently serve as First Deputy Attorney General of the State of Hawai'i. In that capacity, I work very closely with AG Lopez on matters concerning the day-to-day operations of the Department as well as important legal issues faced by the State. I am writing in my personal capacity.

I first met AG Lopez when she served as Special Assistant to then-Attorney General David Louie. I was a deputy attorney general at the time and worked with her on legislative issues and several substantive legal matters involving my then-client, the Department of Hawaiian Home Lands. At that time, I found AG Lopez to be bright, quick-thinking, and professional when faced with thorny legal and policy issues. Her work as Special Assistant brought her in contact with the Legislature, the Judiciary, as well as just about every State agency, and she was able to speak fluently about all of them. When she decamped to the Hawai'i Health Systems Corporation, word quickly spread of AG Lopez's good work transitioning several hospitals to private entities, which ensured their continued solvency without disrupting patient services.

In her relatively short time at the Department as Attorney General, AG Lopez has demonstrated that she possesses the leadership qualities required of the job. There are two areas where this is most evident: (1) her initiative to improve the way the Department interacts with the Legislature; and (2) her approach to litigation management.

In the past, the Department has taken a largely <u>reactive</u> approach to legislation, with legislators learning for the first time that a bill has constitutional or other legal problems through written and oral testimony at committee hearings. AG Lopez has committed herself and the Department to being <u>proactive</u> when it comes to such issues, which means working with legislators before and during the legislative session to ensure that their bills can withstand legal scrutiny. I believe this initiative is already bearing fruit, resulting in stronger bills and a healthier working relationship with the Legislature.

AG Lopez also brings to the Department a wealth of litigation management experience from her time as General Counsel and Chief Operating Office at the Hawai'i Health Systems Corporation. The Department faces a steady stream of litigation involving diverse subject matter and it is very important that the Attorney General be able to manage litigation at a high level, rather than practice in the courtroom. In meetings with experienced litigation deputies, I have observed AG Lopez's ability to ask insightful questions, recommend litigation strategies to move cases forward, and make difficult executive decisions regarding whether cases settle or go to trial.

One of AG Lopez's top priorities is reducing the amount of litigation against the State by proactively working with clients to avoid legal trouble before it arises. This means having the Department's attorneys get involved with client projects in their infancy to provide advice and ensure that legal problems are headed off at a project's inception, rather than solving them on the back end, by which time litigation may inevitable. This is an often-overlooked aspect of litigation management and has the potential to significantly reduce litigation, which will save the State time, staff resources, and money.

Above all of these qualities, though, AG Lopez possesses the one attribute most critical to being a good Attorney General: integrity. In my conversations with her, she has stressed the need to do the right thing in every situation, even if some people may not be happy with the result. She is serious about her ethical obligations as a State employee under the Hawai'i Ethics Code, as well as her responsibilities as an attorney under the Hawai'i Rules of Professional Conduct. AG Lopez has made it clear to the Department that as public servants, we must always hold ourselves to the highest ethical standards. I have full confidence that she will continue to act with the utmost integrity, without exception, if she is confirmed by the Senate.

I wholeheartedly support Anne Lopez for Attorney General of the State of Hawai'i and urge this committee to look favorably on her nomination. Thank you for the opportunity to testify.

I am testifying in my personal capacity in <u>strong support</u> of Anne Lopez to be confirmed as Attorney General. I currently serve as the Special Assistant to the Attorney General Lopez, a unique position under Hawai'i law. *See* HRS § 28-8.5. In this position, I have had the best possible vantage point for observing Attorney General Lopez's first months on the job and can say, without equivocation, that she is not only highly qualified for the position of Attorney General, but that she was made for it.

A bit on my perspective: I love the Department of the Attorney General because it has given me numerous unbelievable opportunities so early in my career. Since joining the Department in 2015, I have been blessed with opportunities to prevail in multi-million-dollar trials, to argue cases before the Hawai'i Supreme Court and Ninth Circuit Court of Appeals, and to serve as the Hearings Officer in the December 2021 emergency contested-case hearing on the Red Hill crisis. But beyond such matters, the Department of the Attorney General provides one-of-a-kind opportunities for public service and does a multitude of good work unseen by the public on a day-to-day basis.

Attorney General Lopez sees the immense potential for the Department to serve all branches of government and the public at large in her important role. I would like to emphasize four points: (1) Attorney General Lopez's background, which prepared her for her current role; (2) her desire to overhaul the way the Department works and interfaces with the Legislature; (3) her belief in elevating the Department's morale and its public perception; and (4) her character.

First, the diversity of Attorney General Lopez's background has prepared her to be Attorney General, with a breadth of experience perhaps unseen in recent times. Specifically, she has worked in the judiciary (law clerk to Justice Paula Nakayama), in private practice as a transactional and litigation attorney, at the Department of the Attorney General as then Attorney General David Louie's Special Assistant, and as an executive leading the Hawai'i Health Services Corporation. Attorney General Lopez knows how to manage and lead a large department, to work with legislators and the media, and to direct litigation, from trial to the Supreme Court.

The wide scope of Attorney General Lopez's experience exhibits itself in numerous positive ways, but, as an example, she has shown herself to be an excellent decision-maker with respect to litigation. An Attorney General's primary role in litigation is not to take depositions, review box files of documents, or go to trial—it is instead to make the tough litigation decisions, based upon the totality of the circumstances and considering the advice of her deputies. In this role, Attorney General Lopez has excelled: she quickly understands the issues, makes sensible decisions, and provides clear directives that the trial attorneys can then use to effectuate the decision.

Attorney General Lopez has excellent instincts and is decisive, a product of her experience. Nowhere was this better seen in her public decision to not re-prosecute the thirty kapuna who were arrested in 2019 on the Mauna Kea Access Road. Whatever one thinks about this highly contentious issue, the re-prosecution of the kapuna was not in the best interest of anyone. And while she took some criticism, her decisive action to end the prosecutions was in the best interest of the State and has created conditions allowing for the State to move forward without being mired in the past.

Second, Attorney General Lopez's desire to drastically overhaul the way the Department of the Attorney General interfaces with the Legislature is among her top priorities. In the past, the Department has perhaps been perceived by the Legislature as the Department of "No," a wet blanket thrown on legislative prerogatives without the provision of helpful alternatives. This way of doing business is anathema to Attorney General Lopez.

Instead, Attorney General Lopez believes in supporting legislative initiatives and working constructively with the Legislature or individual legislators on their bills before and during session to help overcome legal defects. We want the legislators to come to us with their ideas as soon as this session is over with an eye toward next session, and we can work together to formulate bills that will pass legal scrutiny. Attorney General Lopez hopes to build trust with the Legislature, an organization that she believes is not only the Department's client, but one that stands at the heart of our democracy in this State. Third, Attorney General Lopez wishes to improve the wellbeing and morale of ATG employees and to better promote their good work in public. I have seen numerous instances of Attorney General Lopez trying to emphasize that deputies need to find the joy in their work and to balance their work obligations with their family lives and physical and mental wellbeing. The work of a deputy attorney general, like any attorney, is one that is often stressful, with litigation deadlines and important client obligations. Attorney General Lopez believes that by improving the quality of ATG employees' dayto-day lives, the quality of legal work product will improve along with it.

As Special Assistant, I have also had the opportunity to put Attorney General Lopez's media philosophy into action: to promote the good work of deputies over her own notoriety. In my experience under previous administrations, a litigation attorney could do all of the work and win the big case, and the attorney general could take full credit in the press—with the litigation attorney who won the case remaining anonymous. This is not so with Attorney General Lopez. And even a cursory review of press releases and news stories show our news coverage is filled with the good work of individual deputies. The Department of the Attorney General is where attorneys can make a name for themselves if they so desire, and Attorney General Lopez wants to promote deputies and help them achieve their professional goals.

Fourth, Attorney General Lopez is a good person. She believes in doing the right thing, even if it is difficult. Her sense of ethics is high, and she demands those same ethical standards from everyone in the Department. She is cool under pressure and does not get angry. Attorney General Lopez has compassion for everyone and tries to see the best in people. She has a calm temperament, with a good sense of humor, which is ideally suited to the position of Attorney General.

I have been a litigation attorney for more than 35 years, 32 of which have been with the law firm of Cronin, Fried, Sekiya, Kekina & Fairbanks. I have been a partner/shareholder in our firm for more than 20 years. Periodically over the last several decades, my law firm and I have been honored to be appointed Special Deputy Attorneys General to represent the State in large, complex litigation against national and multinational corporations for unfair or deceptive trade practices and/or the sale and distribution of dangerously defective products. In that capacity, I have known Anne Lopez professionally for approximately 10 years. During that time, Anne has worked with me while serving in several different roles: (1) as Special Assistant to former Hawai'i Attorney General David M. Louie; (2) as Chief Operating Officer and General Counsel of the Hawai'i Health Systems Corporation ("HHSC"); and (3) as Attorney General while her confirmation is pending.

I first met Anne when my partner, Rick Fried, and I were engaged to represent the State in litigation against the manufacturers of the antiplatelet medication Plavix (hereinafter "Plavix Litigation"). As Special Assistant to Attorney General David Louie, Anne participated in strategy sessions leading up to the filing of the Plavix Litigation. Shortly after suit was filed, Anne became Chief Operating Officer and General Counsel for HHSC. In that position she met with me and other attorneys and department heads regarding the Plavix Litigation in order to prepare responses to the Defendants' discovery requests. Also, I personally met with Anne, one-

on-one, on numerous occasions to obtain documents and interrogatory answers, and to prepare her for her deposition in the case. As a result, I had an opportunity to observe firsthand her integrity, diligence, efficiency, legal knowledge and ability, professionalism, and demeanor. I found her to be bright, thoughtful, witty (as appropriate), and diligent in gathering and compiling information and documents from personnel in the various regions under the HHSC umbrella. In preparing Anne for her deposition, I found her to be highly professional, savvy, a quick study, and appropriately cognizant of the legal implications of the questions she was asked and the importance of candor, clarity and accuracy in her answers. She easily understood the factual and legal issues being discussed, and often had thoughtful questions and comments.

More recently, I have had additional contact with Anne in her capacity as Attorney General, in both the Plavix Litigation and the State's civil enforcement action against opioid manufacturers (hereinafter "Opioid Litigation"). As Attorney General, I have found her to be tough, no-nonsense, and a committed, articulate advocate for the interests of the State and its citizens. I have also found her to be an independent thinker who listens carefully to her advisors but ultimately makes her own decisions regarding the best course of action to be pursued.

Over the roughly 10 years that I have known Anne, I have served under five other Attorneys General and/or Acting Attorneys General – David Louie, Russell Suzuki, Douglas Chin, Clare Connors, and Holly Shikada. In my view, Anne compares favorably with each of them, in terms of her integrity, intelligence, demeanor, professionalism, and the many other attributes that make for an effective and formidable Attorney General. I understand that some have suggested Anne lacks extensive experience as a trial attorney in the courtroom. I am not in a position to speak to that issue. What I can say is that, in my personal experience, Anne readily understands and appreciates the evidence, arguments, and strategies that matter in litigation – including some very complex litigation – whether or not she has extensive experience in personally cross-examining witnesses or laying the foundation for admission of evidence in court (which, for all I know, she may have).

In my humble opinion, the public and the Hawai'i legal community would be well-served (and are being well-served) with Anne Lopez as their Attorney General. I oppose the confirmation of Anne Lopes to Attorney General.

I recently found out that on March 21st AG Lopez submitted a motion Pro Hac Vice to have a lobby organization attorney, Wayne J. Taylor Jr., defend the state against a lawsuit from the National Association of Gun Rights, challenging Hawaii's assault weapons ban and their magazine ban. To no surprise, the motion was approved on March 23rd.

Wayne J. Taylor is an attorney for the lobbyist organization "Everytown for Gun Safety," a dark money funded group.

I find this to be a serious conflict of interest by having an attorney for the same group that lobbied legislators for the passage of the same law to be deputized by AG Lopez to defend it in Federal court.

Additionally, in one of her first acts after her appointment by Governor Green on December 5, 2022, AG Lopez signed on to an Amicus Brief brought forth by 17 other State AGs in support of a lawsuit by private citizens (parents) in Florida against the State's Parental Rights in Education Act. Not only does this lawsuit have nothing to do with Hawai'i, in my opinion it violates her basic enumerated responsibilities as the chief legal officer and chief law enforcement officer of the State of Hawaii, which are:

- 1. appears for the State in civil and criminal cases when the State is a party;
- 2. investigates violations of state laws, and initiates civil and criminal actions to enforce the laws or prosecute persons who violate them;
- 3. prepares legal opinions for the Governor, the Legislature, and the heads of state departments;
- 4. advises state officials on legal matters so that they may faithfully execute their duties and responsibilities; and
- 5. defends and represents state officials and employees when they are sued for actions they have taken or are about to take in connection with their state positions.

I write in **strong support** of Anne E. Lopez's nomination for the position of Attorney General, State of Hawai'i.

I'm a practicing attorney with more than 20 years' experience and am currently a partner at Goodsill Anderson Quinn & Stifel. I write in my personal capacity to offer my strongest recommendation in favor of Ms. Lopez. I started my current job in the private sector in 2018. Before that, I was a deputy attorney general at the Department of the Attorney General for 14 years. It was in that capacity that Anne and I worked together, during the Abercrombie administration, when she worked alongside David M. Louie, then-attorney general. David assigned both Anne and myself, and two other deputies, James Walther and Jill Nagamine, to take the lead on drafting the bill that would eventually become Hawaii's Marriage Equality Act, 2013 Haw. 2nd Sp. Sess. L. Act 1.

Although I worked with Anne on other matters during those years, the Marriage Equality Act was by far the largest project we worked on together. Our team of four understood then and understands to this day, just shy of 10 years later—that the Marriage Equality Act was very likely the most important thing we would ever do in our professional lives. Together we embraced the privilege of serving in that moment, and wrote, rewrote, edited, vetted, and debated the bill, line by line and provision by provision. Every single piece of it was tested, numerous times, over and over, in an unrelenting process that went on for months before the special session began. At the same time, and through the special session, we advised legislators and leadership, fielded comments, and answered complex and challenging legal questions. Eventually the bill passed and we celebrated together when it was signed into law.

That was the public process. The insights I offer here about Anne's skills and character are from behind the scenes. Anne is consistently calm in the face of challenge and stress. As a lawyer, she is whip-smart, insightful, and strategic. She is able to constructively discuss challenging topics in heated moments with a wide variety of people—the Governor's staff, legislative leadership, the press—without avoiding either the challenge of a difficult conversation *or* the underlying legal questions. She is unafraid to seek advice from the most knowledgeable people around her. In fact, she conscientiously gathers the people who can collectively add to the knowledge of a team. Based on the 40+ years I served as a deputy attorney general, and more specifically the 12+ years I worked with her while she served as Attorney General David Louie's special assistant, and as the General Counsel and Chief Operating Officer of the Hawaii Health Systems Corporation thereafter, I believe Anne is more than capable and qualified to serve as the State's Attorney General and direct all the legal and other work the Department of the Attorney General is responsible for performing.

Having worked for four years as the AG's special assistant, Anne knows first-hand what the Attorney General, personally or through the 180+ deputy attorneys general the Attorney General appoints, is responsible for knowing and doing – (1) representing and protecting the interests of the State in the state and federal courts, (2) providing legal opinions and legal advice to the Governor, members of the Legislature, department heads, and state officers, to allow them to perform their duties faithfully, and (3) serving as the State's chief law enforcement officer to enforce all of the State's civil and criminal statutes and the common law, on behalf of the State and the public. She was principally

responsible for negotiating, drafting and implementing the terms included in the Transfer Agreement and Fixed Term Lease that HHSC and Kaiser were required to enter into by Act 103.

As Attorney General Anne will not do all detailed legislative, public information, contract, tort, labor management, real property, procurement, document review, and substantive and procedural federal and state administrative work she did as special assistant to the AG and HHSC's general counsel. However, she assuredly will know what the Department's attorneys, investigators, and other professional and support staff need to do, and how to direct and guide them to complete those tasks.

- Meeting of the President, the Executive Director, and the nominee prior to the scheduled interview of the nominee by the Board.
- Interview of the nominee by the HSBA Board.
- Deliberation of the HSBA Board.
- Submittal of the HSBA Board's recommendation to the confirming authority.

The HSBA President and the Executive Director met with Ms. Lopez on March 22, 2023, to discuss the subcommittee's findings. On March 23, 2023, Ms. Lopez was interviewed by the HSBA Board of Directors in executive session.

Documentation submitted by Ms. Lopez was reviewed and the references listed were contacted for their personal opinions and observations. The comments and letters received from HSBA members reflected an affirmation of Ms. Lopez in all categories of the HSBA criteria which include:

- Integrity
- Diligence
- Legal knowledge and ability
- Professional experience
- Temperament
- Financial responsibility
- Public service
- Ability to fulfill the responsibilities and duties of the position

Anne E. Lopez is best known as the Vice President and General Counsel for the Hawaii Health System Corporation (HHSC) and for her role in the transfer of Maui Memorial Medical Hospital, Kula Hospital, and Lanai Community Hospital from HHSC to Maui Health Systems. In these roles the Nominee was called upon to handle a myriad of issues ranging from healthcare laws and regulations, state laws and governance, state and private labor and employment issues, litigation and claims, finance, management of outside counsel, ceded lands, real property, insurance, and risk management. During this period of time Ms. Lopez was called upon to manage resources to effectively achieve the ultimate goal of a smooth transition to ensure that the healthcare needs of Maui residents were met without interruption.

The Nominee began her professional life as an occupational therapist in health care settings and as a business owner. She sought out a different career path and was accepted into the William S. Richardson School of Law where she graduated *summa cum laude*. After serving as a judicial law clerk in the Hawaii Supreme Court, Ms. Lopez transitioned to the private practice of law. In 2013 the Nominee was appointed Special Assistant in the Department of the Attorney where her philosophy of government making things better for the citizens of Hawaii was further solidified. The Nominee came to appreciate the vast responsibilities of the Attorney General's Office which is constitutionally tasked with serving as legal counsel for the Executive, Legislative, and Judicial branches of government when needs arise, especially during the annual legislative sessions. As one of the few Attorney General nominees who have served in the Department before appointment, Ms. Lopez understands the need for interaction among the Department's different divisions in order to efficiently and effectively manage the Office's large legal and support staff appointed as well as those in collective bargaining units, and the dynamics of managing staff on all islands. Ms. Lopez is well respected in the legal community for her integrity, diligence, and strong work ethic. Colleagues have indicated that she provides guidance on a wide variety of issues from small to complex, and explains her rationale so that all levels of management and staff understand. Her guidance is reportedly always based on sound legal analysis. The Nominee's experience in large organization management is invaluable because the Attorney General for the State of Hawaii is the managing partner of one of the State's largest law firms.

After the interview of the nominee, which included dialogue and questioning relating to her background, experiences, and reasons for pursuing the position of Attorney General of the State of Hawaii, the Board of the Hawaii State Bar Association found Ms. Anne Lopez to be **QUALIFIED** for the position of Attorney General of the State of Hawaii.
