In consideration of GOVERNOR'S MESSAGE 660 SUBMITTING FOR CONSIDERATION AND CONFIRMATION TO THE COMMISSION ON WATER RESOURCE MANAGEMENT, GUBERNATORIAL NOMINEE, LAWRENCE MIIKE, FOR A TERM TO EXPIRE JUNE 30, 2027

# The Department of Land and Natural Resources (Department) strongly supports the Governor's appointment of Dr. Lawrence H. Miike to serve on the Commission on Water Resource Management (Commission) for a term to expire June 30, 2027.

The Commission is required under Section 174C-7, Hawaii Revised Statutes, to select commissioners through an open, competitive process. An independent nominating committee composed of two members selected by the Governor, one by the Senate President and one by the House Speaker solicits candidates typically by placing an ad in the papers across the State, in the monthly bulletin of the Commission, and on the Commission's website. The Nominating Committee reviews the applications, conducts interviews, and sends the Governor the names of at least three individuals for consideration.

The nominees, by law, must have "substantial experience in the area of water resource management." In accordance with this nominating process and careful consideration of the nominees' qualifications, Governor Josh Green selected Dr. Lawrence H. Miike, M.D., J.D.

Dr. Miike is highly qualified for this appointment and served as an ex-officio member of the Commission from 1994 to 1998 while he held the post of State of Hawai'i Director of Health. He retired from this position at the end of 1998. Dr. Miike once again served as a member of the Commission from 2004 through 2012 as the commissioner having "substantial experience or expertise in traditional Hawaiian water resource management techniques and in traditional Hawaiian riparian usage such as those preserved by section 174C-101 (of the State Water Code)."

He also served as the hearings officer when the Commission issued its Nā Wai 'Ehā, Maui, decision in 2010 and participated in the Commission's 2010 decision on 27 East Maui streams diverted by the East Maui Irrigation Company. Opining on these two Maui decisions, Dr. Miike relied on his keen knowledge of Hawai'i water law, expertise in water resource management, and experience with complex water issues, and was the lone dissenting member on the Commission. His insights and prescience were validated when the Hawai'i Supreme Court and Hawai'i Intermediate Court of Appeals, respectively, remanded these Maui decisions back to the Commission.

Dr. Miike's educational and professional experiences weave together perspectives of both public and environmental health that will add value and insights into the existing Commission's set of expertise on water.

Dr. Miike is an accomplished author who penned the treatise *Water and the Law in Hawai'i* (University of Hawai'i Press, 2004) and co-authored *Dichotomies of the Mind: A Systems Science Model of the Mind and Personality* (John Wiley & Sons, Inc. 1984), updated in 2007 as *Personality Types: A Systems Science Explanation*. Dr. Miike also authored numerous publications on wide-ranging health policy issues.

Dr. Miike is married and resides in Kāne'ohe, O'ahu. His 'ohana includes three married stepsons, their spouses, and six grandchildren.

The Department strongly supports the nomination and appointment of Dr. Lawrence H. Miike to the Commission on Water Resource Management.
