- 2 **Department Testimony:** Thank you for the opportunity to testify in STRONG SUPPORT of
- 3 this administration bill to strengthen the ability of the Department of Health and its Office of
- 4 Health Care Assurance (OHCA) to protect the public against uncertified or unlicensed health
- 5 care facilities.

- The purpose of this bill is to better safeguard the public by repealing HRS §321-486.3
 - and avoid conflict with HRS §321-20. In short, this is a housekeeping bill and HRS §321-20
- 8 contains the more appropriate remedial enforcement tool.
- 9 HRS §321-486 authorizes OHCA to conduct investigations on uncertified or unlicensed
- care facilities and HRS §321-486.3 allows OHCA to assess administrative penalties of no more
- than \$100 per day for the 1st violation, \$500 per day for the 2nd violation, and \$1,000 per day for
- the 3rd and each succeeding violation.
- However, HRS §321-20 also lists remedies at the department's disposal. It includes the
- assessment and payment of "an administrative penalty not to exceed \$1,000 for each day of
- 15 violation."

1 Uncertified or unlicensed care facilities charge thousands of dollars per month to multiple

2 vulnerable *kupuna*. These facilities are not inspected for quality of care, caregiver qualifications

including background checks, and an inspection of care home to ensure safe and appropriate

4 living conditions. Fees charged to *kupuna* can be as high as \$8,000 per person per month. As a

5 result, HRS §321-20 is the better enforcement tool, and \$1,000 per day is a more appropriate

6 remedial approach to prevent unlicensed operators from profiting at the hands of vulnerable or

frail elderly. A \$100 per day fine for the 1st violation would be meaningless to an operator

making tens of thousands of dollars per month.
