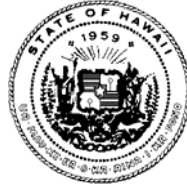

DEPARTMENT'S POSITION: The Department of Human Services (DHS) supports this bill, and defers to the Department of Agriculture (DOA) as to administrative and budget needs. DHS respectfully requests that any appropriation not reduce or replace priorities identified in the executive budget bill HB 300, GM1, and GM2.

PURPOSE: The bill's purpose is to appropriate funds to DOA for the continued administration of the Hawaii healthy food incentive program and to provide matching funds to beneficiaries who participate in the Supplemental Nutrition Assistance Program (SNAP). Effective 6/30/3000. (HD1). The HD1 amended this measure by:

- (1) Changing the effective date to June 30, 3000, to encourage further discussion; and
- (2) Making technical, nonsubstantive amendments for the purposes of clarity, consistency, and style.

The Hawaii healthy food incentive dollar-for-dollar matching program helps SNAP participants double their purchasing power. Especially during this time of elevated food costs,

continuing the program doubles the value of SNAP participants' benefits spent on Hawaii-grown fresh fruits and vegetables. This supports local farmers and keeps food dollars in the local economy.

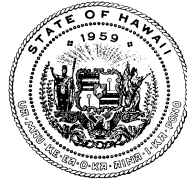
Chairperson Dela Cruz and Members of the Committee:

1 **Fiscal Implications:** The Department of Health (DOH) defers to the Department of Agriculture
2 (DOA) for fiscal implications of implementation.

3 **Department Testimony:** The DOH supports House Bill 1248, House Draft 1 (H.B. 1248, H.D. 1)
4 that appropriates funds to DOA for the continued administration of the Hawaii healthy food
5 incentive program and to provide matching funds to beneficiaries who participate in the
6 supplemental nutrition assistance program (SNAP).

7 The DOH strongly supports Hawaii's DA BUX Double Up Food Bucks Program (DA
8 BUX) as one component of a comprehensive approach to improve the availability and
9 accessibility of healthy foods to improve health outcomes for people in Hawaii, especially for
10 people who face greater health disparities. The DA BUX, allows a dollar-for-dollar match on
11 locally produced fresh fruits and vegetables for SNAP recipients.

12 Major health authorities including the U.S. Department of Agriculture, Centers for
13 Disease Control and Prevention, and the World Health Organization recommend increasing fruit

1 and vegetable intake as a means to prevent chronic disease and improve overall health.^{1,2,3}
2 However, access to fresh produce for income-limited individuals can be difficult and is one of
3 the reasons why they often have poorer diets and higher rates of chronic disease than middle
4 class and wealthy individuals.^{4,5} Hawaii has the highest cost of living in the nation with food
5 costs that are 82% higher than the national average.⁶ In Hawaii, less than one in five adults
6 reported eating five or more fruits and vegetable a day (2019 Behavioral Risk Factors
7 Surveillance System).⁷

8 Nutrition incentive programs similar to the DA BUX are prevalent around the United
9 States and are often touted as a “win-win-win” for farmers, families, and local businesses. Data
10 from these interventions have shown improvements in dietary behaviors, reduction in household
11 hunger and food insecurity, and increased sales of local produce by more than their dollar value
12 alone.^{8,9,10}

13 The DOH urges the passage of H.B. 1248, H.D. 1 which will allow for continued
14 funding and the possible expansion of this extremely important program that provides much
15 needed support to Hawaii’s families, local farmers, and the economy.

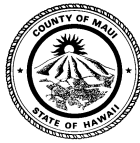

Thank you for the opportunity to testify in **support** of this important measure. The measure's purpose is to appropriate funds for the Hawai'i Food Incentive Program and provide matching funds to beneficiaries who participate in the Supplemental Nutrition Assistance Program.

The Maui County Council adopted Resolution 23-43, "URGING THE STATE LEGISLATURE TO SUPPORT AND ADOPT THE PRIORITY FOOD POLICIES RECOMMENDED BY THE TRANSFORMING HAWAII'S FOOD SYSTEMS TOGETHER INITIATIVE," in support of this measure. Therefore, I offer this testimony on the Council's behalf.

The Maui County Council **supports** this measure for the following reasons:

1. This measure facilitates the consumption of fresh fruits and vegetables, which is an integral part of a healthy diet and central to the prevention of obesity and chronic disease.
2. The Hawai'i Healthy Food Incentive Program, also known as DA BUX, incentivizes beneficiaries who participate in the Supplemental Nutrition Assistance Program with a dollar-for-dollar match on locally produced fresh fruits and vegetables. This measure provides the essential funding to continue this valuable program.
3. This measure advances the following Maui County General Plan policy: "Expand public awareness and promote programs to achieve healthy eating habits . . ."

For the foregoing reasons, the Maui County Council **supports** this measure.

A BILL FOR AN ACT

RELATING TO SUPPLEMENTAL NUTRITION ASSISTANCE PROGRAM
INCENTIVES.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1 SECTION 1. The legislature finds that consumption of fresh
2 fruits and vegetables is an integral part of a healthy diet and
3 central to the prevention of obesity and chronic disease. The
4 legislature also finds that every community should have access
5 to fresh and healthy dietary options, but the high cost of fresh
6 produce often makes that difficult. This challenge is felt
7 acutely by participants in the federal supplemental nutrition
8 assistance program, which serves a low-income population that
9 struggles to afford healthy food.

10 The legislature further finds that the State faces an
11 estimated \$83,000,000 in annual costs related to food insecurity
12 and hunger. Due to the COVID-19 pandemic and rising inflation,
13 households are facing increasing food costs. Compared to the
14 rest of the nation, households in the State spend the highest
15 percentage of their annual budget on food.



1 The legislature further finds that through the national
2 Double Up Food Bucks Program, Hawaii has the opportunity to
3 expand access to healthy foods for low-income residents who are
4 eligible for supplemental nutrition assistance program benefits.
5 Currently implemented in more than twenty states, the Double Up
6 Food Bucks Program provides matching federal grant moneys to
7 state programs that incentivize the use of supplemental
8 nutrition assistance program benefits for the purchase of fresh
9 produce. Provided by both the United States Department of
10 Agriculture National Institute of Food and the United States
11 Department of Agriculture food insecurity nutrition incentive
12 grants program, these federal matching funds increase access to
13 healthy dietary options while also invigorating local economies
14 and addressing food insecurity.

15 The enactment of Act 153, Session Laws of Hawaii 2019,
16 created the Hawaii healthy food incentive program, now commonly
17 known as the DA BUX double up food bucks program. The DA BUX
18 double up food bucks program began first with a pilot program in
19 2012 by Kokua Kalihi Valley Comprehensive Family Services on
20 Oahu and The Kohala Center on Hawai'i island. The program
21 provides a dollar-for-dollar match to supplemental nutrition



1 assistance program beneficiaries who purchase locally grown
2 fruits, vegetables, and proteins at participating farmers'
3 markets, grocery stores, and community-supported agriculture
4 projects. By the end of 2021, the pilot program was available
5 at fifty-seven food retailers across ninety-eight market sites
6 and pick-up locations that include grocery stores, farmers'
7 markets, community-supported agriculture programs, and other
8 farm direct retailers. From 2020-2021, DA BUX supported four
9 hundred seventy farm producers and eight distributors. Each
10 dollar reimbursed to participating DA BUX food retailers for
11 their issued discounts on local produce has an economic
12 multiplier of 2.1. This means that each program dollar issued
13 for local produce incentives contributes \$2.10 to Hawaii's
14 economy. A \$3,000,000 investment by the State in this program
15 would allow for a federal funding match that will contribute at
16 least \$12,600,000 to our local economy annually. This result is
17 a triple win for the State because it supports families,
18 farmers, and the local economy. Additional funding will allow
19 the statewide program coordinator, led by The Food Basket on
20 Hawai'i island, to obtain matching federal funds to continue to
21 support the program.



1 The purpose of this Act is to appropriate funds to the
2 department of agriculture for the continued administration of
3 the Hawaii healthy food incentive program and to provide
4 matching funds to beneficiaries who participate in the
5 supplemental nutrition assistance program.

6 SECTION 2. There is appropriated out of the general
7 revenues of the State of Hawaii the sum of \$ or so
8 much thereof as may be necessary for fiscal year 2023-2024 and
9 the same sum or so much thereof as may be necessary for fiscal
10 year 2024-2025 for the continued administration of the Hawaii
11 healthy food incentive program and to provide matching funds to
12 beneficiaries who participate in the supplemental nutrition
13 assistance program.

14 The sums appropriated shall be expended by the department
15 of agriculture for the purposes of this Act.

16 SECTION 3. This Act shall take effect on June 30, 3000.

The Obesity Prevention Task Force (OPTF), a program of the Hawai'i Public Health Instituteⁱ (HIPHI), is in **Strong Support of HB1248 HD1**, which provides continued funding for the Hawai'i Healthy Food Incentive Program.

Double Up Food Bucks is a triple win for families, farmers, and the local economy.

The Hawai'i Healthy Food incentive program, also known as DA BUX, provides a dollar-for-dollar match on locally produced fresh fruits and vegetables for SNAP recipients. Through this program, SNAP recipients can bring home healthy food, local farmers gain new customers and increased income, and more money goes into and grows our local economy.

Incentivizing SNAP dollars for fresh fruits and vegetables stretches food dollars for families, especially with increasing food costs. Furthermore, the doubling effect that DA BUX has on SNAP dollars gives families more room in their budgets for other necessary expenses.

Double Up Food Bucks demand has risen significantly over the last several years.

Year after year, this program has grown its impact making a significant impact on SNAP recipients. In 2019, SNAP shoppers spent \$87,359 through the DA BUX program; by 2022, SNAP shoppers spent \$2,275,460 through the DA BUXⁱⁱ. That money has brought healthy foods to homes while positively impacting our local economy.

Double Up Food Bucks provides a strong return on investment.

SNAP is proven to stimulate the economy by being an economic multiplier. For every SNAP dollar spent, it generates \$1.79 in economic activity. These dollars ripple out throughout the supply chain, supporting farmers, retailers, and food distributor employees; these people, in turn, spend their dollars to help support economic activity further and so on. If the state provides \$3 million in funding for this program, the federal

government could provide up to an additional \$3M of matching funds. This \$6M would result in over \$9.9M of total economic activity. In other words, the \$3M investment has a return of over 230%.

Health and food security are positively impacted.

Double Up Food Bucks' focus on locally grown produce helps to bring healthy foods to homes and supports the local agricultural industry. Studies have found that a lack of food security is associated with diet-related chronic diseases such as diabetes and high blood pressureⁱⁱⁱ. Supporting local agriculture also aligns with the renewed calls to increase local food production and decrease Hawai'i's dependence on imported goods for a more sustainable and resilient food system.

A \$3 million investment can help expand the program to more stores.

The Double Up program has seen significant growth. It started with KTA in Hawai'i County and is now accessible statewide through Times, KTA, Foodland, and participating farmers' markets. These stores are locally based and operated, ensuring the economic impact is amplified. There are still ways for the program to grow its impact.

The \$3M will increase the program's reach and participation by engaging more people through educational campaigns in areas where there has been stalled growth, as well as provide the ability to engage more retail outlets that were unable to participate due to a limit of SNAP funding for participants.

Double Up Food Bucks is a triple win for health, agriculture, and the local economy and is a lifeline for many during the pandemic. We strongly support this measure and respectfully ask you to **pass HB1248 HD1**.

Chair Dela Cruz, Vice Chair Keith-Agaran, and Members of the Committee:

The Hawaii Primary Care Association (HPCA) is a 501(c)(3) organization established to advocate for, expand access to, and sustain high quality care through the statewide network of Community Health Centers throughout the State of Hawaii. The HPCA **SUPPORTS** House Bill No. 1248, House Draft 1, RELATING TO SUPPLEMENTAL NUTRITION ASSISTANCE PROGRAM INCENTIVES.

By way of background, the HPCA represents Hawaii's Federally Qualified Health Centers (FQHCs). FQHCs provide desperately needed medical services at the frontlines to over 150,000 patients each year who live in rural and underserved communities. Long considered champions for creating a more sustainable, integrated, and wellness-oriented system of health, FQHCs provide a more efficient, more effective and more comprehensive system of healthcare.

This bill, as received by your Committee, would appropriate an unspecified amounts of general funds for fiscal years 2023-2024, and 2023-2025, to be expended by the Department of Agriculture, for the continued administration of the Hawaii Healthy Food Incentive Program and to provide matching funds to beneficiaries who participate in the Supplemental Nutrition Assistance Program (SNAP).

This bill would take effect on June 30, 3000.

SNAP, formally known as the "Food Stamps Program", is the largest federal food assistance program that is currently in operation. It provides food-purchasing assistance for low- and no-income people. SNAP provided assistance to approximately 40 million persons in 2018, at an expenditure of \$57.1 billion. Approximately 9.2% of American households received SNAP benefits at some point during 2017, with approximately 16.7 of all children living in households receiving SNAP benefits.

Founded during the height of the Great Depression, SNAP is the cornerstone of our national social safety net. It is intended to prevent mass starvation precipitated from unemployment and homelessness. The program was also seen as a way of helping the poor while boosting the economy and ensuring that America's farmers would obtain a fair price for their labors by allowing government to purchase and distribute excess goods in time of crisis.

The COVID-19 Pandemic demonstrated how food scarcity and poverty threatened the health and welfare of our citizens in times of dire crisis. With so many people unemployed, entire families struggled to put food on the table on a consistent basis. Lines at the food bank and food drives stretched for miles and people waited for hours to receive surplus food.

The HPCA has strongly endorsed this Program in previous years and we continue to urge your support. Additional SNAP benefits for a recipient can mean the difference between having to decide whether someone's last amount of cash will go for food or rent or medications or other necessities.

My name is Michael Robinson, and I am the Vice President of Government Relations & Community Affairs at Hawai'i Pacific Health. Hawai'i Pacific Health is a not-for-profit health care system comprised of its four medical centers – Kapi'olani, Pali Momi, Straub and Wilcox and over 70 locations statewide with a mission of creating a healthier Hawai'i.

HPH writes in SUPPORT of HB 1248, HD1 which appropriates funds to the Department of Agriculture for the continued administration of the Hawai'i healthy food incentive program, and to provide matching funds to beneficiaries who participate in the supplemental nutrition assistance program (SNAP).

HPH recognizes the strong connection between access to healthy foods with health and wellness. Adults who eat a healthy diet live longer and have a lower risk of obesity, heart disease, type 2 diabetes, and certain cancers. Healthy eating can help people with chronic diseases manage these conditions and avoid complications. However, many low income families continue to struggle to put food on the table.

HPH has supported the Double Up food bucks program since 2019 to both foster strengthening local food systems and allow SNAP recipients to access good nutrition. The program has been successful in encouraging SNAP recipients to make healthy food choices. Fresh fruits and vegetables are an integral part of a healthy diet and central to the prevention of obesity and chronic disease. While every community should have access to fresh and healthy dietary options, the high cost of fresh produce often makes that difficult. This challenge is felt acutely by participants in the federal supplemental nutrition assistance program, a low-income population that struggles to afford healthy food. The double up food bucks program is a viable model that supports local farmers, helps low-income families that receive double the purchasing power for healthy, Hawaii-grown produce, and benefits Hawaii by keeping dollars in the local economy.

On behalf of Hawai'i Children's Action Network Speaks!, I am writing in **SUPPORT of HB 1248, HD1**. This bill appropriates funds to DOA for the continued administration of the Hawai'i healthy food incentive program ("DA BUX") and to provide matching funds to beneficiaries who participate in the supplemental nutrition assistance program (SNAP).

Investing DA BUX is investing in our keiki, as more than 60% of SNAP (formerly known as food stamps) participants in Hawai'i are in families with children,¹ and the program has been shown to increase the fruit and vegetable consumption of its participants.²

Especially with high inflation and the most expensive groceries in the nation,³ it is nearly impossible for the low-income families in Hawai'i who qualify for SNAP to afford to buy healthy food, such as fresh fruits and vegetables.

That's where DA BUX comes in. It is designed to help low-income families afford fresh produce, by doubling the value of their SNAP benefits when they purchase Hawai'i grown fruits and vegetables.

DA BUX truly is a triple-win for our state. First, it helps families afford fresh produce, which benefits their health and well-being.⁴ Second, it helps local farmers by increasing their sales. And third, it helps our local food stores and markets by bringing more dollars to them and keeping those dollars in the local economy.

SNAP shoppers' local produce purchases at DA BUX grocery stores nearly tripled in January 2022 compared to 2019, and at DA BUX farm direct retailers those sales were more than five times larger.⁵ In addition, every \$1 spent on DA BUX is estimated to create \$2.30 in local economic activity.⁶

We are in strong support of HB1248, HD1 and the appropriation of \$3 MM for the continued administration of the Hawai'i Healthy Food Incentive Program, otherwise known as DA BUX Double Up Food Bucks, or DA BUX.

In keeping with The Food Basket's (TFB) overarching mission to "end hunger", we are the statewide administrator for DA BUX. TFB established DA BUX as a statewide program upon receiving a \$985 K federal grant through the USDA Gus Schumacher Nutrition Incentive Program (GusNIP). Additionally, we secured the 100% non-federal matching funds that GusNIP requires. We scaled the program in 2021 after receiving two additional GusNIP awards totaling \$7.6 MM in federal dollars. Today, TFB administers DA BUX at 58 food retailers across 100+ locations statewide, including grocery stores, farmers markets and food hubs. DA BUX partner retailers continue to offer 50% discounts on Hawai'i grown fruits and vegetables solely to low-income customers paying with SNAP food dollars (formerly known as food stamps).

Philanthropy has largely carried the weight of our GusNIP match needs over the years; however, we cannot expect philanthropy to meet this need over the long term. We are humbly requesting the State to invest \$3 MM per year in DA BUX to support program sustainability and continuous affordable healthy food access to SNAP recipients.

I am Brian Miyamoto, Executive Director of the Hawai'i Farm Bureau (HFB). Organized since 1948, the HFB is comprised of 1,800 farm family members statewide and serves as Hawai'i's voice of agriculture to protect, advocate and advance the social, economic, and educational interests of our diverse agricultural community.

The Hawai'i Farm Bureau supports HB 1248, HD1, which appropriates funds to DOA for the continued administration of the Hawai'i healthy food incentive program and to provide matching funds to beneficiaries who participate in the supplemental nutrition assistance program.

SNAP offers nutrition assistance to eligible, low-income individuals and families, increasing their food purchasing power and improving their nutrition. SNAP also provides economic benefits to farmers participating at farmers' markets, roadside stands, CSA programs, grocery stores, and other food retailers.

Some of HFB's farmers' markets participate or have participated in the SNAP program. We believe that access to locally grown fresh fruits, vegetables, and protein to low-income individuals and families provides benefits to both SNAP participants and Hawai'i farmers and ranchers.

We are a Hawai'i-focused impact investment firm that strives to improve the quality of life throughout the islands by helping our communities become more resilient and self-sufficient through locally produced food, renewable energy and clean transportation choices, and better management of freshwater resources.

Ulupono strongly supports HB 1248 HD1, which appropriates funds to the State Department of Agriculture (DOA) for the continued administration of the Hawai'i Healthy Food Incentive Program and to provide matching funds to beneficiaries who participate in the supplemental nutrition assistance program.

Ulupono strongly supports the Hawai'i Healthy Food Incentive Program within the DOA. The "DA BUX" Double Up Food Bucks Program, administered by The Food Basket, Hawai'i Island's food bank, is a triple-win solution for our communities as SNAP-eligible recipients double their spending power at point of purchase with healthy local produce, local farmers are able to expand their markets, and all money spent is kept right here in our state. In addition, this program leverages federal funding at a 1:1 match.

From 2020-2021, DA BUX has supported more than 470 farm producers and eight distributors through farm product sales. With rising inflation and Hawai'i's high cost of living, SNAP participation and benefits continue to climb since 2019 levels.¹ These numbers substantiate the need to support our local community as food insecurity continues to increase.

We are hopeful that the State can consider a \$3 million appropriation, per year, for the DOA program to support the continued efforts of DA BUX. A \$3 million investment by the State would receive a direct match of \$3 million in federal funding. Furthermore, our analysis shows that with that level of state funding in place, the potential economic impact created by DA BUX in Hawai'i reaches nearly \$19 million.

DA BUX Double Up Food Bucks provides a Triple-Win

HAWAII IMPORTS APPROXIMATELY 85-90% of its food and has food costs that are 91% higher than the national average. Dependence on food imports threatens the sustainability of food producers throughout the islands and places the entire population directly at risk of food shortages in the event of pandemics, natural disasters, and economic disruptions. Furthermore, with the highest cost of living in the nation, Hawaii is challenged with growing food costs and food insecurity, and 12% of its population receives Supplemental Nutrition Assistance Program (SNAP) in 2022.

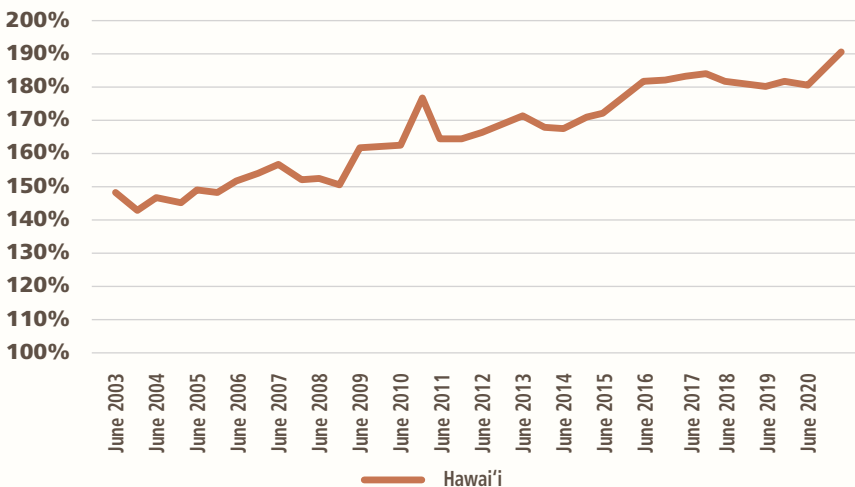
THE PROBLEM

Overall, Hawaii faces an estimated \$83 million in annual costs related to food insecurity and hunger. Due to the COVID-19 pandemic and the rising inflation, Hawaii households are facing increasing food costs. Compared to the rest of the nation, Hawaii households spend the highest percentage of their annual budget on food. This is compounded with the rising inflation that has increased food prices and overall cost of living in Hawaii by 6.6% and 7.4%, respectively. Increasing food prices reinforces many residents' reliance on cheaper, less healthy fast food options that have long-range impacts on health and wellbeing. This situation creates a significant need to help feed low income families AND support local agricultural food producers.

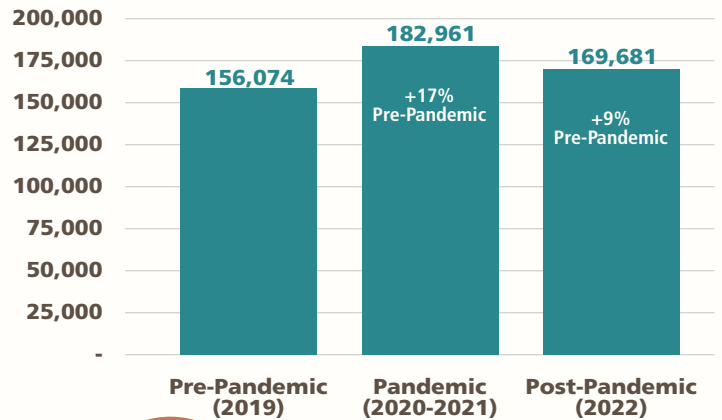

THE SOLUTION

DA BUX Double Up Food Bucks is a triple-win solution because it doubles the purchasing power of low-income SNAP families for healthy, Hawaii-grown produce; it supports local farmers with an increased customer base; and it benefits the entire island community by keeping dollars in the local economy.

An appropriation of up to \$3 million in state funds will bring in additional federal funds to sustain, expand and extend the statewide DA BUX Double Up Food Bucks program. Given the broad benefits of DA BUX for our state, it is imperative to secure sustained funding for DA BUX and ensure it is a staple service providing economic relief to SNAP households and directly supporting local agricultural food producers across the state. Based on the projected spend down rate, current funding of the DA BUX program will only last through August 2024.

HOW IT WORKS

The program offers SNAP participants a DA BUX Access Card or voucher at point of sale that doubles their purchasing power when they buy locally

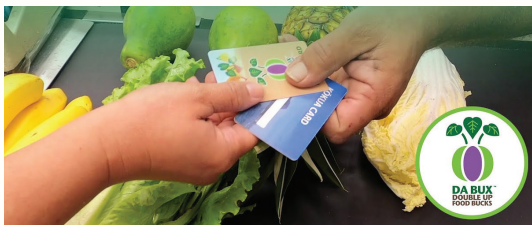


grown fruits and vegetables — \$10 of SNAP benefits would be worth \$20 of Hawaii grown produce. Thus, each \$1 funded into the program provides \$2 worth of local food purchases.

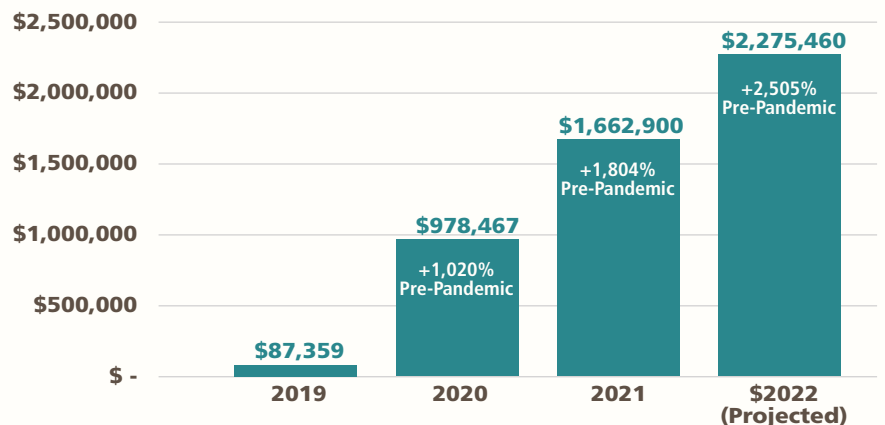

Over the course of the pandemic, DA BUX has become a critical service for low-income SNAP beneficiaries struggling with economic hardship and food insecurity. There has been significant growth and demand for the program due to the increase in SNAP participation and participating DA BUX retail locations across the state.

- From 2020 through 2021, DA BUX supported 470 farm producers and 8 distributors by incentivizing the sale of their farm products sold at participating farm direct retailers.
- In January 2022, local produce sales to SNAP shoppers at participating farm direct retailers increased an average of 531% from 2019
- DA BUX gives farmers the opportunity to feed local residents (rather than exporting product to the mainland) and to increase production towards a self-sufficient local food supply for the state. The program strengthens the relationship between local residents and food producers. Increasing local food production capacity can help to bring prices down, making healthy local food accessible and affordable to more people.

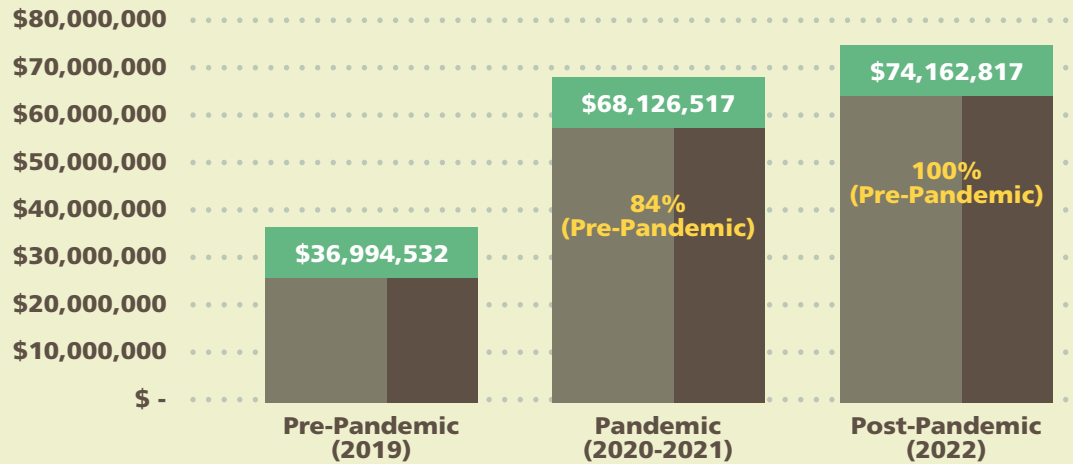

More Impact for State 'BUX'

Due to rising inflation and higher cost of living, SNAP participation and SNAP benefits in Hawai'i continue to be significantly higher compared to 2019 levels.

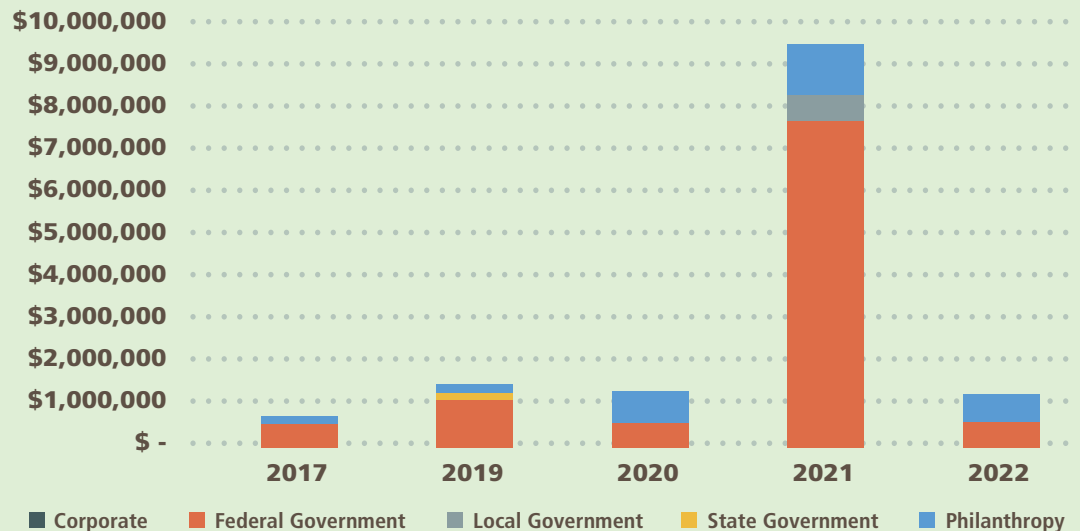
- 8th highest poverty rate (10.5% of the population living at or below the poverty line)
- 9% increase in the number of individuals in Hawai'i receiving SNAP benefits
- 100% increase in the annual total amount of SNAP benefits paid in Hawai'i
- 26x increase the annual total of DA BUX discounts issued to SNAP shoppers

Historically, the DA BUX program has been primarily funded by Federal grants and philanthropic/private funding (representing almost all of total program funds). To date, the State of Hawaii has only provided \$94,000 in General Funds, and allocated \$500,000 in Federal CARES Act funds to the program.

DA BUX Fundings by Source (2017-2022)



Secure and sustained state funding for DA BUX program is the key to federal and philanthropic funding matches. State funds can generate significant leverage:

- Stimulate economic activity of \$19 million (6.3x of state funding) while increasing local food production for local consumption.
- \$3 million can be matched by \$3 million in federal dollars from a Gus Schumacher Nutrition Incentive Program (GusNIP) grant, as well as \$6 million from SNAP purchases, resulting in \$12 million going toward local food purchases and supporting local farmers
- Given the impact achieved and successful track record, state funding will be a worthwhile investment and position the DA BUX program for future federal funding.
- Other states have recognized the benefit and impact of double up food bucks programs by investing state funds in expanding and sustaining their programs. There are nine states that have invested state funds in their double up food bucks programs, totaling approximately \$94.5 million from 2015 through 2021.

Subject: **Testimony in Strong Support of HB1248, Relating to Supplemental Nutrition Assistance Program Incentives**

I am in strong support of bill HB1248 and the appropriation of funds for the continued administration of the Hawai'i healthy food incentive program, otherwise known as DA BUX Double Up Food Bucks, or DA BUX.

DA BUX benefits the state's food system through three different ways. First, DA BUX offers discounts on Hawai'i grown fruits and vegetables to low-income recipients of the Supplemental Nutrition Assistance Program, allowing them to purchase more, healthy food. Second, DA BUX helps farmers increase their customer base and compete with imported produce. And third, DA BUX supports the local economy, generating increased revenue for 57 participating food retailers across 100+ statewide locations.

DA BUX has proven to be beneficial for Hawai'i's economy. According to a study conducted by Colorado State University, each program dollar used to incentivize the purchase of local produce contributes \$2.10 to Hawai'i's economy. Additionally, if DA BUX was further scaled to food retail locations statewide, the potential economic contribution would be \$14-\$22 million in one year.

Furthermore, a \$3 million State investment will serve as significant match funds needed to unlock federal grant dollars from the USDA Gus Schumacher Nutrition Incentive Program (GusNIP). As the GusNIP only accepts proposals that secure 100% non-federal matching funds, a State investment will strengthen the program's FY '23 GusNIP application.

State investment is critical to the long-term sustainability of DA BUX and its ability to provide positive, lasting impact both economically and for the well-being of individuals across the state.

I am in strong support of bill HB1248 and the appropriation of funds for the continued administration of the Hawai'i healthy food incentive program, otherwise known as DA BUX Double Up Food Bucks, or DA BUX.

Maui Hub's mission is two-fold: create a reliable farm-to-market pipeline that supports our local farmers in ways that allow them to focus on rapidly increasing production, and ensure equitable access to locally produced food for all Maui residents, even our most vulnerable.

DABUX benefits have been a major reason that many of Maui Hub's EBT customers switched to Maui Hub. There is such a prevalent conception that "locally grown food is too expensive" many folks automatically avoid it and just shop at big box stores. Processed, shelf stable foods are cheaper, and that's what we see folks consuming. **DABUX benefits actually incentivize EBT customers to buy local, and make it as, if not more affordable to eat fresh local produce.** Maui Hub's staff interacts with our regular customers weekly when they come to pick up their groceries and the feedback from folks who have been able to incorporate fresh food and vegetables into their family's diets is nothing short of inspiring.

"I could never afford kalo before. Now we eat it every week."

"My keiki never liked tomatoes until I bought locally grown ones!"

"It's cheaper to make luau stew for my family than it is to grab MacDonalds."

These are just a few things I personally have heard from regular customers who have made the switch to Maui Hub and locally grown food, almost entirely motivated by DABUX benefits. These are habits that will stick, that will change the pallets of the kids in the family, and will give them a healthy relationship with food and set them up for better health outcomes in the future.

Please continue to fund and support this program.

Founded in 1994 by Hawai'i's community health centers, AlohaCare is a community-rooted, non-profit, safety net health plan serving over 80,000 Medicaid and dual-eligible health plan members on all islands. Approximately half of our membership are keiki. We are Hawai'i's only health plan exclusively dedicated to serving Medicaid and Medicaid-Medicare dually-eligible beneficiaries. Our mission is to serve individuals and communities in the true spirit of aloha by ensuring and advocating for access to quality health care for all. We believe that health is about supporting whole-person health needs.

AlohaCare's commitment to whole person care includes addressing a variety of social determinants of health, including housing, economic stability, and nutrition among other factors. We understand that without access to affordable healthy food, the health and well-being of our members is negatively impacted. For example, researchers from the Centers for Disease Control and Prevention found that food insecurity is associated with obesity among US adults in Hawai'i and 11 other states.¹

AlohaCare has provided grant funding to Kokua Kalihi Valley and others to support this program, and we endorse continued State investment. The Hawai'i Healthy Food Incentive Program is an innovative and successful solution, which supports local farmers, low-income families who receive double the purchasing power for Hawai'i-grown fresh fruits and vegetables, and our entire community by keeping dollars in the local economy. This program is particularly important during this time of rising costs for food among other necessities.

DA BUX benefits Hawai‘i’s food system in three vital ways:

1. Offers discounts on Hawai‘i grown fruits and vegetables to low-income SNAP recipients, allowing them to purchase more healthy food
2. Empowers farmers compete with lower cost imported produce and increase their sales
3. Supports the local economy, generating increased revenue for participating retailers

Farm Link’s mission is to create a thriving, equitable local food system by empowering local farmers and improving access to good local food. We work with over 170 Hawai‘i farmers, ranchers, and food makers, to serve more than 1,000 customers with over 500 local products. Over 18% of our revenue is derived from customers using Supplemental Nutrition Assistance Program (SNAP-EBT) and DA BUX to purchase their groceries. Last year FLH saw transactions associated with the DA BUX program grow by over 300%. We see this as a clear sign that DA BUX is motivating families to purchase and consume more healthy produce, and providing a steady market for Hawai‘i farmers.

State investment is critical to the long-term sustainability of DA BUX and its ability to provide positive, lasting economic and well-being impact. A \$3 million State investment will serve as significant match funds to unlock federal grant dollars from the USDA Gus Schumacher Nutrition Incentive Program (GusNIP). As the GusNIP only accepts proposals that secure 100% non-federal matching funds, a State investment is critical to the program’s FY ‘23 GusNIP application.

We are writing to voice our strong support of HB1248 and the appropriation of funds for the continued administration of the Hawai'i Healthy Food Incentive Program, otherwise known as DA BUX Double Up Food Bucks, or DA BUX.

My name is Harmonee Williams, and I am the Executive Director of the Hawai'i Good Food Alliance (HGFA). Our mission is that we join together—with a sense of urgency—to raise community voice and support one another in the belief that each and every person in Hawai'i can share in healthy, locally produced food.

DA BUX benefits the state's food system through three different ways. First, DA BUX offers a 50% discount on Hawai'i grown fruits and vegetables to low-income recipients of the SNAP program (formerly known as food stamps), allowing them to purchase more, healthy food. Second, DA BUX helps farmers increase their customer base and compete with imported produce. And third, DA BUX supports the local economy, generating increased revenue for the participating food retailers across 100+ statewide locations. Several of our member organizations offer DA BUX through their retail operations, allowing them to offer affordable local produce to all of their SNAP customers.

A \$3 million State investment will serve as significant match funds needed to unlock federal grant dollars from the USDA Gus Schumacher Nutrition Incentive Program (GusNIP). As the GusNIP only accepts proposals that secure 100% non-federal matching funds, a State investment will strengthen the program's FY '23 GusNIP application. Thank you for the opportunity to testify in **SUPPORT** of H.B. 1248 – Relating to Supplemental Nutrition Assistance Program Incentives, which would appropriate funds to the department of agriculture for the continued administration of the Hawai'i healthy food incentive program (also known as DA BUX) and to provide matching funds to beneficiaries who participate in the supplemental nutrition assistance program (SNAP).

DA BUX helps local producers thrive and sets beginning farmers up for success.

In FY21, DA BUX supported *470 farm producers and 8 distributors statewide* by incentivizing the sale of their farm products sold at participating farm direct retailers.¹ This support resulted in a 531% average increase in local produce sales at participating retailers.² DA BUX provides a new market for local producers and helped many keep their doors open during the pandemic when the tourism industry was no longer a viable customer. A study conducted by the USDA Economic Research Service found that beginning farmers accepting SNAP incentives were more likely to continue farming over time.³

Nutrition incentive programs are a lifeline to Hawai'i's struggling families.

The ending of the public health emergency and SNAP emergency allotments has resulted in *more than 83,000 of Hawai'i's low-income households* experiencing the greatest SNAP benefit cliff in history. With SNAP participating households losing at least \$95 per month (with some of our most vulnerable losing up to \$238), DA BUX has become even more vital to improve access to healthy food for these communities as their purchasing power decreases. Our emergency food system alone cannot fill this gap and meet the need.

DA BUX sustainability requires state investment, which the federal government can match.

A \$3 million state investment will provide significant match funds required to unlock federal grant dollars from the USDA Gus Schumacher Nutrition Incentive Program (GusNIP), which the state applicant—The Food Basket—has successfully applied for and received previously. With an economic multiplier of 2.3 for every \$1 spent in Hawai'i on incentives, a \$3M investment by the state will result in \$12.6M generated in Hawai'i's local economy.⁴

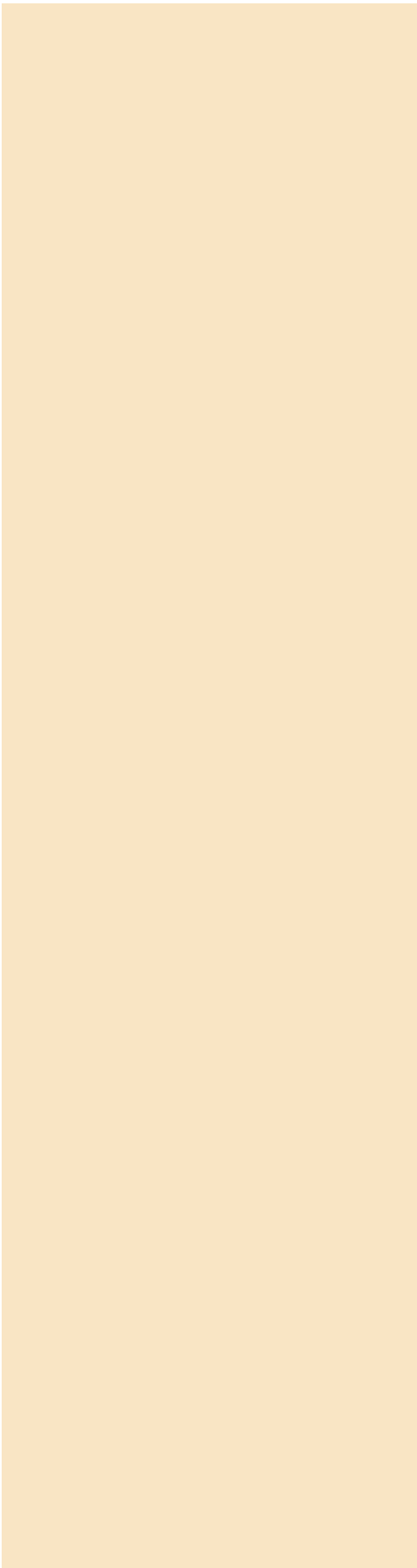

Dear Chair Dela Cruz, Vice Chair Keith-Agaran, and members of the Committee:

Thank you for the opportunity to submit testimony in support of **H.B. 1248**, which would provide matching funds to appropriate funds to the Hawai'i Department of Agriculture (DOA) for the continued administration of the Hawai'i healthy food incentive program and beneficiaries who participate in the supplemental nutrition assistance program (SNAP).

SNAP is a proven economic stimulus. In fact, the [USDA estimates](#) that every dollar in SNAP generates an additional \$0.54 in economic activity. **In 2022, nearly 170,000 Hawai'i residents drew down over \$900 million in federal SNAP funds to purchase food—an estimated \$1.4 billion dollar investment in Hawai'i's food system after applying the economic multiplier.**

While SNAP is an important program for ensuring the food security of low-income Hawai'i households, the individual household benefit is often still not enough to afford fresh fruits and vegetables. This results in most of these economic stimulus funds leaving the islands—right into the pockets of major mainland food companies, rather than getting recirculated locally into our local agriculture industry.

SNAP incentives like those proposed in H.B. 1248 address this concern by providing an additional subsidy for SNAP users when they purchase local fruits and vegetables. The federal program that funds this incentive requires a one-to-one match, meaning that every dollar the state invests will be matched by federal funding. **Therefore, a \$3 million investment by the state would be doubled with matching federal funds. Factoring in the \$1.54 multiplier mentioned earlier would ultimately result in \$9.24M million in economic impact.** Passing this bill would be an impact investment for the State, channeling much-needed capital into local businesses and farms.

Hawai'i's existing SNAP incentive program, known as DA BUX, has already been enormously successful and popular among SNAP users, retailers, and farmers alike. According to the latest [program outcomes report](#), DA BUX has already directly supported 470 farm producers, eight distributors, and increased local produce sales by 531% at farm-direct retailers.

SNAP incentives are a win for everyone—families, farmers and local businesses. There is no downside. Thank you for the opportunity to provide testimony.

The Hawaii Food Industry Association is comprised of two hundred member companies representing retailers, suppliers, producers, and distributors of food and beverage related products in the State of Hawaii.

The Double Up Food Bucks program is important as a means to combat food insecurity, support healthy eating, and as a way to support Hawaii's agricultural sector. During the COVID-19 pandemic and economic crisis, food insecurity in our state soared to unprecedented levels, at the same time the local agricultural sector suffered disproportionate economic losses. The Double Up Food Bucks program has been a vital tool to increase the produce buying power of Hawaii consumers who use the Supplemental Nutrition Assistance Program (SNAP), and helps grow our local agricultural sector. Continuing to fund this important program will ensure that the many benefits continue.

Fruits, vegetables, and healthy proteins tend to be more expensive per calorie than less healthy foods, which makes eating healthy a challenge for those with limited food budgets. Doubling the purchasing power for SNAP users makes it easier to choose fruits, vegetables, and healthy proteins when shopping. Data has shown that families use the Double Up Food Bucks Program eat more fruits and vegetables, a greater variety of fruits and vegetables, and fewer unhealthy foods. Getting more fruits and vegetables for each SNAP dollar also means

that low-income families will have more in their budget to spend on things like housing and healthcare.

By prioritizing locally grown agricultural products this program also helps Hawaii farmers and encourages retailers to stock Hawaii grown produce and protein. This helps promote a resilient food economy where local farmers are selling to local stores that sell to local customers.

Each dollar spent in this program goes into Hawaii's agricultural sector and circulates from there into the larger local economy. This is a win for SNAP users, a win for Hawaii farmers, a win for Hawaii retailers, and a win for Hawaii's economy.

We urge you to vote yes on this measure and we thank you for the opportunity to testify.

On behalf of Hawai'i Foodbank, I **support HB 1248**, which would appropriate funds to Department of Agriculture for the continued administration of the Hawai'i healthy food incentive program and to provide matching funds to beneficiaries who participate in the supplemental nutrition assistance program.

Food security is a critical issue in Hawai'i, where one in six residents lacks comprehensive access to healthy, nutritious food. SNAP is one of our most important anti-hunger programs, offering choice and healthy options for families who need extra support putting food on the table. We strongly support DA BUX, which doubles the purchasing power of SNAP when it is used for locally produced food.

- **DA BUX increases consumer purchasing power.** Locally grown produce is often more expensive than imported items. DA BUX stretches dollars farther and makes it possible for more people to choose local.
- **DA BUX advances nutrition, health and well-being.** Healthy food can also be more expensive, and we consistently hear requests for more produce and healthy proteins from our distribution partners and the people we serve. DA BUX makes these desired, healthier food items more affordable.
- **DA BUX invests in farmers and statewide food security.** With an estimated 85%-90% of our food imported, programs that support Hawai'i farmers are important to us all. The Hawai'i Foodbank regularly purchases from local farmers, and programs that invest in local production capacity help us better support those we serve.

The Hawai'i Foodbank gathers donated, rescued, and purchased food and distribute it to those in need through our network of more than 200 agency partners. We also advocate for policies and programs that end hunger, and we strongly support DA BUX as a critical food security effort that advances the health and well-being of the people we serve.

DA BUX helps local producers thrive and sets beginning farmers up for success. DA BUX supports over 450 farm producers and our local economy by incentivizing the sale of their farm products sold at participating farm direct retailers. DA BUX provides a new market for local producers and helped many keep their doors open during the pandemic when the tourism industry was no longer a viable customer. The ending of the public health emergency and SNAP emergency allotments has resulted in more than 83,000 of Hawai‘i’s low-income households experiencing the greatest SNAP benefit cliff in history. With SNAP participating households losing at least \$95 per month (with some of our most vulnerable losing up to \$238), DA BUX has become even more vital to improve access to healthy food for these communities as their purchasing power decreases. Our emergency food system alone cannot fill this gap and meet the need. DA BUX sustainability requires state investment, which the federal government can match.

A \$3 million state investment will provide significant match funds required to unlock federal grant dollars from the USDA Gus Schumacher Nutrition Incentive Program (GusNIP), which the state applicant—The Food Basket—has successfully applied for and received previously. With an economic multiplier of 2.3 for every \$1 spent in Hawai‘i on incentives, a \$3M investment by the state will result in \$12.6M generated in Hawai‘i’s local economy.

Those items tend to be healthier produce and fresh foods and being locally sourced directly supports Hawai'i's food economy.

Even before the pandemic DA BUX program was succeeding. Now more than ever, it is changing lives for the better in four very tangible and important ways including:

It's putting more food on the tables of local families in need.

It's providing incentives that encourage people to buy locally grown and produced food.

It's strengthening the local economy by keeping more dollars in the Islands.

It's improving local health by providing incentives to eat fresher, unprocessed foods.

The DA BUX program works and should be continued and expanded upon where possible. The program is a tangible solution to supporting local food production and helping families have access to quality fresh food.
