**STATEMENT OF THE ILWU LOCAL 142 ON HB 704 --
RELATING TO MOTOR VEHICLE REGISTRATION**

The ILWU Local 142 strongly supports H.B. 704, HD1, which expands the existing exemptions for marine terminal equipment moving cargo between terminals. The bill provides an exemption for registration renewals and initial registration for flatbed trucks when used as marine terminal equipment moving within and between certain terminals. The expansion would include new terminal locations and roadways covered under the exemption.

Removing current restrictions would create greater efficiency in the flow of cargo by allowing marine terminal equipment to access new roadways and terminals.
