Testimony in SUPPORT of SB1370 SD1 RELATING TO LICENSES TO SOLEMNIZE MARRIAGES.

- 1 **Department Testimony:** The Department of Health (DOH) strongly supports this
- 2 Administration Proposal. The preceding measures on the topic of persons authorized by law to
- 3 solemnize marriages stemmed from a lawsuit (Weinberger v Char, 1:20-CV-00405), and with the
- 4 assistance of the Legislature the DOH was able to rectify the inequity for non-religiously
- 5 affiliated and non-judicial performers (Act 221 SLH 2021). However, a well-intentioned
- 6 amendment to establish a fee created a new issue since religious and judicial performers
- 7 previously paid no fee.
- 8 This measure proposes an across-the-board fee for persons wishing to solemnize marriages of
- 9 any kind. State resources are required to process these licenses and the department absorbs the
- 10 cost. It is common for many license holders to subsequently charge couples for solemnization
- services that range from \$100 \$500 per ceremony, so it is reasonable for the State to recover
- 12 costs.
- 13 Currently, there are over 11,000 performers listed on the department's website prior to enactment
- of Act 221 SLH 2021. Performers with local addresses are commissioned for 5 years, and those
- with non-local addresses are commissioned for 1 year.
- 16 DOH expects wedding industry professionals will quickly recover this cost, given the
- approximately 20,000 marriage licenses issued each year. However, for an individual seeking a
- 18 license for which profit is not a motive, for example they wish to solemnize the marriage of a

- 1 close friend or family member, the Legislature may consider a shorter term license such as \$25
- 2 for two months.
