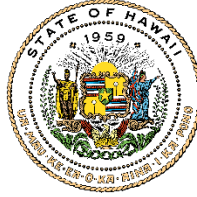

THE LAHAINA PUBLIC LIBRARY MAKAI LAWN

Senate Concurrent Resolution 222/Senate Resolution 160 request the Department of Land and Natural Resources (Department) to transfer to the County of Maui the Lahaina Public Library makai lawn. **The Department offers the following comments.**

The Lahaina Public Library's makai lawn is situated on an unused portion of Wharf Street. Because it is part of a county road, it falls under the jurisdiction of the County of Maui, not the Department or the Board of Land and Natural Resources (Board). Therefore, the County of Maui already has the authority to lease this land to the Lahaina Restoration Society.¹ These resolutions are therefore not necessary.

¹ If the County wishes to lease the lawn to the Lahaina Restoration Society but needs or desires a chain of title to issue the lease, the Board can issue a quitclaim deed to the County of Maui for the area pursuant to Act 288, Session Laws of Hawaii, 1993.
