A BILL FOR AN ACT

RELATING TO THE EXECUTIVE OFFICE ON AGING ADMINISTRATIVE  
CLAIMING SPECIAL FUND.

**BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:**

1           SECTION 1. The purpose of this Act is to clarify the  
2 allowable revenues to be deposited into the executive office on  
3 aging administrative claiming special fund.

4           SECTION 2. Section 349-5.5, Hawaii Revised Statutes, is  
5 amended to read as follows:

6           " ~~[+]~~ §349-5.5 ~~[+]~~ **Executive office on aging administrative**  
7 **claiming special fund.** (a) There is established in the state  
8 treasury the executive office on aging administrative claiming  
9 special fund into which shall be deposited:

10           (1) All revenues from medicaid administrative claiming  
11           designated for the department of health that are  
12           allowable for operating the aging and disability  
13           resource centers ~~[+]~~ and programs within the executive  
14           office of aging;

15           (2) Appropriations made by the legislature to the fund;  
16           and

17           (3) Grants and gifts made to the fund.

1 (b) The executive office on aging administrative claiming  
2 special fund shall be administered and expended by the  
3 department of health to administer and implement [~~section 349-32~~  
4 ~~for~~] services for kupuna and individuals with disabilities who  
5 need long-term services and supports."

6 SECTION 3. Statutory material to be repealed is bracketed  
7 and stricken. New statutory material is underscored.

8 SECTION 4. This Act shall take effect upon its approval.

JUSTIFICATION SHEET

DEPARTMENT: Health

TITLE: A BILL FOR AN ACT RELATING TO EXECUTIVE OFFICE ON AGING ADMINISTRATIVE CLAIMING SPECIAL FUND.

PURPOSE: To clarify the allowable revenues to be deposited into the Executive Office on Aging (EOA) Administrative Claiming Special Fund and the purposes for which the fund may be used.

MEANS: Amend section 349-5.5, Hawaii Revised Statutes.

JUSTIFICATION: Programs within EOA are eligible to receive Medicaid administrative claiming moneys. The current wording is overly narrow in scope and unnecessarily restricts the use of funds to provide broader services to more clients.

Impact on the public: Aging and disability populations may benefit from additional program monies for direct services and supports.

Impact on the department and other agencies: The EOA will be able to use the additional program monies for direct services and supports.
