
A BILL FOR AN ACT

RELATING TO PUBLIC EMPLOYEE COMPENSATION.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1 SECTION 1. Section 78-13, Hawaii Revised Statutes, is
2 amended by amending subsection (a) to read as follows:
3 "(a) Unless otherwise provided by law, all officers and
4 employees shall be paid at least semimonthly except that
5 substitute teachers, part-time hourly rated teachers of adult
6 and evening classes, and other part-time, intermittent, or
7 casual employees may be paid once a month [~~and that the~~
8 ~~governor, upon reasonable notice and upon determination that the~~
9 ~~payroll payment basis should be converted from predicted payroll~~
10 ~~to after-the-fact payroll, may allow a one-time once a month~~
11 ~~payroll payment to all public officers and employees to effect a~~
12 ~~conversion to after-the-fact payroll as follows:~~

13 ~~(1) The implementation of the after-the-fact payroll will~~
14 ~~commence with the June 30, 1998, pay day, which will~~
15 ~~be delayed to July 1, 1998;~~

16 ~~(2) The July 15, 1998, pay day will be delayed to July 17,~~
17 ~~1998;~~



- 1 ~~(3) The July 31, 1998, pay day will be delayed to August~~
2 ~~3, 1998;~~
- 3 ~~(4) The August 14, 1998, pay day will be delayed to August~~
4 ~~19, 1998;~~
- 5 ~~(5) The August 31, 1998, pay day will be delayed to~~
6 ~~September 4, 1998;~~
- 7 ~~(6) The September 15, 1998, pay day will be delayed to~~
8 ~~September 18, 1998; and~~
- 9 ~~(7) Thereafter, pay days will be on the fifth and the~~
10 ~~twentieth of every month. If the fifth and the~~
11 ~~twentieth fall on a state holiday, Saturday, or~~
12 ~~Sunday, the pay day will be the immediately preceding~~
13 ~~weekday.]; provided that the payroll payment basis~~
14 ~~shall be converted from after-the-fact payroll to~~
15 ~~predicted payroll and shall commence with the~~
16 ~~August 5, 2024, pay day, which shall be paid on~~
17 ~~July 31, 2024, and thereafter pay days shall be on the~~
18 ~~fifteenth and last day of every month. If the~~
19 ~~fifteenth or the last day of the month falls on a~~
20 ~~state holiday, Saturday, or Sunday, the pay day shall~~
21 ~~be the immediately preceding weekday.~~



1 The implementation of the [~~after-the-fact~~] predicted
2 payroll shall not be subject to negotiation under chapter 89."

3 SECTION 2. In accordance with section 9 of article VII, of
4 the Constitution of the State of Hawaii and sections 37-91 and
5 37-93, Hawaii Revised Statutes, the legislature has determined
6 that the appropriations contained in this Act will cause the
7 state general fund expenditure ceiling for fiscal year 2024-2025
8 to be exceeded by \$, or per cent. The reasons
9 for exceeding the general fund expenditure ceiling are that the
10 appropriations made in this Act are necessary to serve the
11 public interest and to meet the needs provided for by this Act.

12 SECTION 3. There is appropriated out of the general
13 revenues of the State of Hawaii the sum of \$ or so
14 much thereof as may be necessary for fiscal year 2024-2025 to
15 establish six full-time equivalent (6.0 FTE) positions to
16 perform tasks related to payroll processing, including training,
17 expanded monitoring and auditing, expanded overpayment analysis,
18 and overpayment collection.

19 The sum appropriated shall be expended by the department of
20 accounting and general services for the purposes of this Act.



1 SECTION 4. There is appropriated out of the general
2 revenues of the State of Hawaii the sum of \$ or so
3 much thereof as may be necessary for fiscal year 2024-2025 to
4 pay for costs necessary to convert employees from an
5 after-the-fact payroll schedule to a predicted payroll schedule.

6 The sum appropriated shall be expended by the department of
7 accounting and general services for the purposes of this Act.

8 SECTION 5. This Act does not affect rights and duties that
9 matured, penalties that were incurred, and proceedings that were
10 begun before its effective date.

11 SECTION 6. Statutory material to be repealed is bracketed
12 and stricken. New statutory material is underscored.

13 SECTION 7. This Act shall take effect on July 1, 3000.

DAGS; Salaries; Public Officers and Employees; Payroll Schedule;
Appropriation; Expenditure Ceiling

Description:

Repeals payroll day for public officers and employees by requiring them to be paid pursuant to a predicted payroll schedule, rather than an after-the-fact payroll schedule. Provides that the predicted payroll schedule shall not be subject to negotiation under Chapter 89, Hawaii Revised Statutes. Makes appropriations to establish six full-time equivalent positions and to cover the costs of converting to a predicted payroll schedule. Effective 7/1/3000. (HD1)
