# A BILL FOR AN ACT

RELATING TO COMMERCIAL DRIVER'S LICENSES.

**BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:**

1           SECTION 1. Section 286-239, Hawaii Revised Statutes, is  
2 amended by amending subsection (b) to read as follows:

3           "(b) Commercial drivers' licenses may be issued with any  
4 one or more of the following endorsements and restrictions:

5           (1) "H" - Authorizes the driver to drive a vehicle  
6 transporting hazardous materials;

7           (2) "L" - Restricts the driver to vehicles not equipped  
8 with air brakes;

9           (3) "T" - Authorizes driving double and triple trailers;

10          (4) "P" - Authorizes driving vehicles carrying passengers;

11          (5) "N" - Authorizes driving tank vehicles;

12          (6) "Q" - Restricts the driver from operating a commercial  
13 motor vehicle in excess of eighteen thousand pounds  
14 gross vehicle weight rating;

15          (7) "R" - Restricts the driver to operating a commercial  
16 motor vehicle on Lanai and Molokai only;

- 3        [~~(7)~~] (9) "S" - Authorizes driving school buses;
- 4        [~~(8)~~] (10) "V" - Indicates there is information about a
- 5                    medical variance on the commercial driver's license
- 6                    information system driver record;
- 7        [~~(9)~~] (11) "K" - Restricts the driver from operating in
- 8                    interstate commerce as defined in title 49 Code of
- 9                    Federal Regulations section 390.5;
- 10       [~~(10)~~] (12) "Z" - Restricts the driver to vehicles not
- 11                    equipped with full air brakes;
- 12       [~~(11)~~] (13) "E" - Restricts the driver to vehicles not
- 13                    equipped with any manual transmission;
- 14       [~~(12)~~] (14) "O" - Restricts the driver to non-tractor
- 15                    trailer commercial motor vehicles;
- 16       [~~(13)~~] (15) "M" - Restricts the driver from operating a
- 17                    class A passenger vehicle; and
- 18       [~~(14)~~] (16) "N" - Restricts the driver from operating a
- 19                    class A and B passenger vehicle."

20        SECTION 2. If any provision of this Act, or the  
21 application thereof to any person or circumstance, is held



1 invalid, the invalidity does not affect other provisions or  
2 applications of the Act that can be given effect without the  
3 invalid provision or application, and to this end the provisions  
4 of this Act are severable.

5 SECTION 3. Statutory material to be repealed is bracketed  
6 and stricken. New statutory material is underscored.

7 SECTION 4. This Act shall take effect on July 1, 3000.
