
A BILL FOR AN ACT

RELATING TO HEALTH.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

PART I

SECTION 1. The purpose of this Act is to:

- (1) Require the department of health and Oahu regional health care system to develop a strategic plan for the utilization of all Oahu regional health care system facilities and report to the legislature prior to the regular session of 2024;
- (2) Extend the assimilation of the Daniel K. Akaka state veterans home from the department of defense to the Oahu regional health care system to June 30, 2024; and
- (3) Require the Oahu regional health care system to provide a progress report to the legislature regarding construction of and the hiring of an operator for the Daniel K. Akaka state veterans home.

PART II

SECTION 2. Act 212, Session Laws of Hawaii 2021, is amended as follows:



1 1. By adding a new part to read:

2 **"PART IX**

3 SECTION 12A. The department of health and Oahu regional
4 health care system shall develop a strategic plan for the
5 utilization of all Oahu regional health care system facilities.
6 The department of health and Oahu regional health care system
7 shall submit a report of their findings and recommendations,
8 including any proposed legislation, to the legislature no later
9 than twenty days prior to the convening of the regular session
10 of 2024."

11 2. By renumbering part IX to read:

12 **"[PART IX] PART X"**

13 PART III

14 SECTION 3. Act 285, Session Laws of Hawaii 2022, is
15 amended by amending section 2 to read as follows:

16 "SECTION 2. (a) No later than June 30, ~~[2023,]~~ 2024, the
17 Daniel K. Akaka state veterans home on Oahu shall be assimilated
18 into the Oahu regional health care system in a manner and to an
19 extent that may be negotiated between the Oahu regional health
20 care system and the department of defense. After assimilation,
21 the physical assets and the ground lease of the Daniel K. Akaka



1 state veterans home shall become the property of the Oahu
2 regional health care system and the Daniel K. Akaka state
3 veterans home shall be managed by the Oahu regional health care
4 system.

5 (b) None of the liabilities of the Daniel K. Akaka state
6 veterans home in existence at the time the Daniel K. Akaka state
7 veterans home is assimilated into the Oahu regional health care
8 system shall become liabilities of the Oahu regional health care
9 system.

10 (c) The Oahu regional health care system shall submit a
11 report on the progress of construction of and hiring of an
12 operator for the Daniel K. Akaka state veterans home to the
13 legislature no later than twenty days prior to the convening of
14 the regular session of 2024."

15 PART IV

16 SECTION 4. Statutory material to be repealed is bracketed
17 and stricken. New statutory material is underscored.

18 SECTION 5. This Act shall take effect upon its approval.
