
A BILL FOR AN ACT

RELATING TO AQUACULTURE.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1 SECTION 1. Chapter 141, Hawaii Revised Statutes, is
2 amended by adding one new section to part IV to be appropriately
3 designated and to read as follows:

4 "§141-A Aquatic livestock assessment and approval process;
5 permits. (a) The division shall administer an assessment and
6 approval process to import and move aquatic livestock in the
7 State. This process shall:

8 (1) Be based on the framework maintained by the
9 aquaculture program pursuant to section 141-52; and

10 (2) Include pre-arrival disease-free verification, point-
11 of-entry inspection, post-arrival inspection, and the
12 quarantine of any aquatic animals, plants, and
13 microorganisms, as necessary.

14 (b) The division may issue permits for the purposes of
15 subsection (a).

16 (c) As used in this section, "division" means the animal
17 industry division of the department."



1 SECTION 2. Section 141-51, Hawaii Revised Statutes, is
2 amended by adding three new definitions to be appropriately
3 inserted and to read as follows:

4 "Aquatic biorisk" means the combination of the probability
5 of occurrence of harm and the severity of that harm where the
6 source of harm is an escaped aquatic livestock species.

7 "Aquatic livestock" means various species of domestic and
8 non-domestic fish, crustaceans, and mollusks that are propagated
9 and raised for food, restorative activities, or similar
10 commercial purposes.

11 "Biocontainment" means the safety practices and procedures
12 used to prevent unintended infection of animals from external
13 pathogens or the release of high-consequence species or
14 pathogens into the environment."

15 SECTION 3. Section 141-52, Hawaii Revised Statutes, is
16 amended by amending subsection (a) to read as follows:

17 "(a) There is established within the department an
18 aquaculture program that shall:

19 (1) Monitor actions taken by industry and by federal,
20 state, county, and private agencies in activities



- 1 relating to aquaculture, and promote and support
2 worthwhile aquaculture activities;
- 3 (2) Serve as an information clearinghouse for aquaculture
4 activities;
- 5 (3) Coordinate development projects to investigate and
6 solve biological and technical problems involved in
7 raising selected species with commercial potential;
- 8 (4) Actively seek federal funding for aquaculture
9 activities;
- 10 (5) Undertake activities required to develop and expand
11 the aquaculture industry[+], which include:
- 12 (A) Maintaining an aquatic biorisk-based framework
13 for an assessment and approval process for
14 aquatic livestock that categorizes aquatic
15 livestock species based on the probability and
16 consequence of the establishment of a feral
17 population; and
- 18 (B) Maintaining a biocontainment standards framework
19 that certifies discrete levels of operational
20 functions; and



1 (6) Perform other functions and activities that may be
2 assigned by law."

3 SECTION 4. The animal industry division of the department
4 of agriculture shall develop an aquatic biorisk-based framework
5 for the assessment and approval process to import and move
6 aquatic livestock. In developing the framework, the animal
7 industry division shall consider:

8 (1) Relevant standards established by the United States
9 Department of Agriculture;

10 (2) Current aquatic livestock policies and development
11 issues;

12 (3) Best practices of the aquaculture industry; and

13 (4) The protection of indigenous species as defined in
14 section 195D-2, Hawaii Revised Statutes.

15 SECTION 5. Statutory material to be repealed is bracketed
16 and stricken. New statutory material is underscored.

17 SECTION 6. This Act shall take effect on July 1, 3000.

Description:

Requires the animal industry division of the department of agriculture to administer an assessment and approval process to import and move aquatic livestock in the State. Allows the animal industry division to issue permits for such purposes. Requires the animal industry division to develop a risk-based framework for the aquatic livestock assessment and approval process and to undertake certain activities to develop and expand the aquaculture industry.
