A BILL FOR AN ACT

RELATING TO AGRICULTURE.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. The legislature finds that the department of
- 2 agriculture's agricultural land use baseline study has indicated
- 3 that the total amount of agricultural land in the State has
- 4 decreased by twenty-seven thousand fifty acres since 2015, or
- 5 three per cent. Put another way, tens of thousands of
- agriculturally zoned lands have moved out of agricultural 6
- production. The legislature finds that this is a concerning 7
- 8 trend that must be addressed.
- 9 The legislature further finds that lands supporting viable
- agricultural activities should be maintained in agricultural use 10
- by bona fide farmers or ranchers. Unfortunately, the State's 11
- 12 agricultural workforce is aging. A recent article in Hawaii
- Business Magazine indicated that the average age of a farmer in 13
- Hawaii is approximately sixty years. Because younger 14
- generations in farming families are often reluctant to take over 15
- 16 family farms, many farmlands in the State are at risk of falling



- 1 fallow, which would further decrease the amount of
- 2 agriculturally zoned lands in active agricultural production.
- 3 The legislature finds that succession planning is a process
- 4 by which business owners plan to exit their business and
- 5 transition ownership and control of the business to a successor
- 6 owner. Although succession planning can be a difficult process,
- 7 it can be vital to ensuring the success of exiting owners,
- 8 successor owners, and the businesses themselves.
- 9 The legislature further finds that because the agribusiness
- 10 development corporation is one of the primary agencies
- 11 responsible for addressing the business component of the State's
- 12 agricultural sector, it is the most appropriate agency to
- 13 educate farmers and ranchers on the benefits of succession
- 14 planning. The legislature further finds that the agribusiness
- 15 development corporation would also be an ideal agency to
- 16 facilitate involvement in succession planning education
- 17 activities by landowners, county land use and permitting
- 18 officials, state taxation authorities, and other stakeholders to
- 19 ensure a smooth transition of agricultural enterprises between
- 20 exiting owners and their successors.

Report Title:

Agribusiness Development Corporation; Agriculture; Succession Planning; Education Program; Appropriation; General Fund Expenditure Ceiling Exceeded

Description:

Requires the Agribusiness Development Corporation to develop a program to educate and assist farmers and ranchers in the process of transitioning agricultural businesses to new owners. Requires the program to connect individuals interested in entering farming or ranching, or existing farmers or ranchers interested in expanding their business, with farmers and ranchers who have not yet identified a successor owner. Appropriates moneys. Declares that the appropriation exceeds the state general fund expenditure ceiling for 2024-2025.
