A BILL FOR AN ACT

RELATING TO PUBLIC SERVICE.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

I	PART I
2	SECTION 1. The legislature finds that the State is
3	responsible for upholding an ethical position on the deterrence
4	of conflicts of interest, bribery, and corruption in all
5	branches of government. When government is idle about
6	combatting corruption, this can erode public trust and
7	confidence for state leaders and exacerbate social tensions,
8	which could contribute to violence.
9	The purpose of this Act is to:
10	(1) Require that judicial appointees file the same
11	financial disclosures that are required of other state
12	officials, which will help prevent bribery and
13	corruption; and
14	(2) Require the commission on salaries to consider the
15	deterrence of bribery and corruption when making its
16	salary recommendations.

19		agency and department;

- 1 The commission shall not review the salary of any position
- 2 in the department of education or the [University] university of
- 3 Hawaii.
- 4 The commission may recommend different salaries for
- 5 department heads and executive officers and different salary
- 6 ranges for deputies or assistants to department heads; provided
- 7 that the commission shall recommend the same salary range for
- 8 deputies or assistants to department heads within the same
- 9 department; provided further that the appointing official shall
- 10 specify the salary for a particular position within the
- 11 applicable range.
- 12 In making its salary recommendations for each position, the
- 13 commission shall consider the deterrence of bribery and
- 14 corruption.
- 15 The commission shall not recommend salaries lower than
- 16 salary amounts recommended by prior commissions replaced by this
- 17 section."

- 19 SECTION 4. This Act does not affect rights and duties that
- 20 matured, penalties that were incurred, and proceedings that were
- 21 begun before its effective date.

- 1 SECTION 5. Statutory material to be repealed is bracketed
- 2 and stricken. New statutory material is underscored.
- 3 SECTION 6. This Act shall take effect upon its approval;
- 4 provided that that the amendments made to section 84-17, Hawaii
- 5 Revised Statutes, by section 2 of this Act shall not be repealed
- 6 when that section is amended on January 1, 2025, pursuant to
- 7 sections 1 and 4 of Act 123, Session Laws of Hawaii 2023.
