Aloha,

As I conclude my 14th session as your State Representative, I remain committed to working for you and your ohana and we continue to ensure transparency in keeping our constituents informed about the work that is completed every legislative session. As in many sessions in the past, there are very controversial measures that we must address and compromise on, and then there are good bills that are passed to improve the quality of life for our state. I appreciate your good faith and understanding on all policies that are worked on by the Legislature and passed into law.

Our focus for many years has been trying to make living in Hawai'i more affordable for our local residents. Efforts include, increasing the state's affordable housing inventory, adjusting tax brackets to accommodate the increase in minimum wages, addressing construction and maintenance of school facilities, and working with County government to maintain infrastructure and recreational facilities. I'm also happy to report that the Legislature's priority was to ensure funding to assist Maui with their wildfire recovery, and we were still able to craft a balanced budget that will address many of our core services throughout our state.

We were successful in obtaining Capital Improvement Project (CIP) funding, with the commitment of the County to match funds, to resurface tennis/ basketball courts in Kekaha, Waimea and Hanapepe. These facilities have not been resurfaced in over two decades. Our District will receive funding for many facilities and organizations with CIP's and Grants-in-Aid, as highlighted in this newsletter.

Cesspool conversion policy is still a very important issue and with the introduction of many bills, all agencies and the public are aware of how critical it will be for the Counties to make this their top priority. Unless we beef up our infrastructure, we are not able to expand our housing inventory adequately. More importantly, we must provide assistance with sewer and water systems to current homeowners when deemed possible.

2024 completes another legislative session, and I encourage you to reach out to me anytime to share concerns or suggestions.

The State Budget

HB1800, HD1, SD1, CD1 Appropriates supplemental funds for the operating and capital improvement budget of the Executive Branch. The following projects are just a snapshot of the many CIP's approved by the Legislature for Kaua'i.

Capital Improvement Projects for House District 17 approved by the 2024 Legislature

Kekaha Faye Park, Waimea Athletic Field,

Hanapēpē Stadium.....FY25 \$1,650,000

Design and construction for resurfacing of tennis courts at Kekaha Faye Park (including basketball court), resurfacing of basketball courts at Waimea Athletic Field, and resurfacing of tennis courts at Hanapēpē Stadium, provided that no state funds shall be expended unless the County of Kaua'i contributes matching county funds for state funds on a dollar-for-dollar basis.

Kekaha Agricultural Association, Kaua'i......FY25 \$2,000,000 Plans, design, and construction for a post-harvest processing center in Kekaha; ground and site improvements; equipment and appurtenances.

Kekaha Bridge, Kaua'iFY25 \$2,500,000Construction to improve interior access road and Kekaha Ditch Crossing.

Stream Crossings, Na Pali-Kona Forest Reserve, Kaua'iFY25 \$5,000,000 Plans, design, and construction for Kawaikoi stream and Waikoali stream crossing repairs and improvements in the Na Pali-Kona Forest Reserve.

Koke'e State Park Baseyard Improvements......FY25 \$500,000Design and construction for improvements and repair of electrical systems and infrastructure at the historic baseyard.

Koke'e State Park Road Improvements, Phase 2, Kaua'iFY25 \$1,000,000Design and construction for phase 2 road and parking improvements at Koke'e State Park

State Parks – Hazard Mitigation Improvements, Kaua'i.......FY25 \$1,000,000 Plans, design and construction of Waimea Canyon lookouts, hazard mitigation improvements for health and safety (Waimea Canyon Lookout, Pu'u Ka Pele, Pu'u Hinahina).

Kaua'i Veteran's Memorial Hospital

Emergency Department ExpansionFY25 \$3,000,000Design, construction, and equipment for modernization of operating room.

Kaua'i Veteran's Memorial Hospital Rehab RenovationFY25 \$1,183,000 Construction to renovate the rehab department to modernize suites and improve efficiency.

Education Highlights in HB1800, HD1, SD1, CD1

Greater focus on direct student learning was a priority of this budget. Our communities will thrive by investing in quality education and building more resilient education systems.

- \$21M for Summer Learning hubs
- \$12.9M for increases to Weighted Student Formula and English Language Learners program
- \$6M for increases in Weighted Student Formula for Small and Remote schools
- \$2.48M for Workforce readiness
- \$1.65M for Complex areas to address inflation-based costs increases
- \$1.3M for Hawaii Keiki Healthy and Ready to Learn Health Technicians
- \$413,915 for Advanced Placement Exams
- **\$10M** for School night security contracts, Active Threat training and Saferwatch panic buttons in schools.

Notable Bills That Passed The 2024 Legislature

HB 2404, HD1, SD1, CD1

Increases the amounts for the income tax brackets and standard deduction amounts for tax year 2024. Adjusts annually for tax years beginning after 12/31/2024, the income tax brackets and standard deduction amounts by a cost-of-living adjustment factor. In addition, this bill amends the child and dependent care tax credit that will provide tax relief to working families, promote preschool education, and promote labor participation by working parents. Amends the taxable income brackets and income tax rates for each filing status for taxable years beginning after 12/31/2023.

SB 1035, SD2, HD1, CD1

Exempts medical and dental services provided by health care providers to patients who receive Medicaid, Medicare, or TRICARE benefits from the general excise tax. This bill is beneficial in eliminating the disparity in compensation as well as easing the financial burden for primary care providers. This in turn will encourage more physicians to practice and remain in Hawai'i. Applies to taxable years beginning after 12/31/2023.
