
State Budget Bill: HB1700

By law, the Council on Revenues reports its latest tax revenue forecast to the Governor and Legislature four times each year. At the most recent meeting on March 10, 2016, the Council lowered its forecast for growth in the State's General Fund tax revenues in Fiscal Year (FY) 2016 from 6.7% to 5.5% indicating that economic growth is projected to decrease due global economic uncertainty and possible causes of a new recession. The Legislature has an obligation to allocate funds to address short and long term needs of the State of Hawaii, in a fair and prudent manner, while also ensuring that there are sufficient funds in reserve to cover future obligations and challenges.



After weeks of negotiating, the Legislature passed a fiscally responsible budget for the fiscal year 2016 -2017. Thank you to Ways and Means (WAM) Chair Jill Tokuda, Finance (FIN) Chair Sylvia Luke, WAM Vice Chair Donovan M. Dela Cruz, FIN Vice Chair Scott Nishimoto, and the WAM and FIN Committee members for their leadership and hard work.

Highlights of HB1700, CD1 FY 2016-2017

Human Services and Housing

To address the housing shortage the Legislature has a goal of producing at least 22,500 housing units across the state by 2026. Key pieces of the State housing plan include:

- Increasing funding for the Rental Housing Revolving Fund and the Dwelling Unit Revolving Fund for financing more rental housing and infrastructure (roads, water, sewer, sidewalks, etc.)
- Streamlining policies for the Hawai'i Housing Finance and Development Corporation to make building affordable units more feasible.
- Helping more homeless individuals and families transition into emergency and transitional shelters and permanent housing with the social services they need. It is important to combine affordable housing, health and human services outreach, and public safety efforts that treat people with dignity.

HB 1702 HD1 SD1 CD1 Amends the income tax credit for expenses for household and dependent care services necessary for gainful employment. This measure will assist many working class families pay for basic living expenses.

SB 2560 SD2 HD1 CD1 Requires and appropriates funds for the department of health to provide treatment and care for homeless individuals with serious and persistent mental health challenges as a part of a comprehensive mental health system.

SB 2566 SD1 HD1 CD1 Transfers excess moneys from the rental assistance revolving fund to the rental housing revolving fund to build more affordable rental housing.

HB 2305 HD1 SD1 CD1 Authorizes the creation of Regional State Infrastructure Improvement Subaccounts within the Dwelling Unit Revolving Fund and the use of the Dwelling Unit Revolving Fund to provide loans and grants to finance regional state infrastructure improvements in areas of planned growth.

SB 2561 SD2 HD1 CD1 Establishes a goal of developing or vesting the development of at least 22,500 affordable rental housing units ready for occupancy between 01/01/17 and 12/31/26. Establishes a special action team on rental housing to make recommendations to the Governor, Legislature, and other parties to achieve the goal.

Kupuna Issues & Long-Term Care

HB 1878 HD1 SD2 CD1 Appropriates \$1.7 million for Aging and Disability Resource Centers (ADRCs), in addition to the \$1.4 million in the base budget, and \$32,000 for fall prevention and early detection services for the elderly. Requires the Executive Office on Aging to submit a report to the Legislature in order to determine the effectiveness of the ADRCs.

HB 2252 HD1 SD2 CD1 Requires hospitals to allow patients to designate a caregiver and provide designated caregivers the opportunity to participate in discharge planning and receive instruction prior to the patient's discharge from a hospital. Also known as the Care Act.

Health

SB 2886 SD2 HD2 CD1 Reduces barriers to accessing mental health services for minors by lowering the age of consent to receive treatment and services, other than prescription medication or out-of-home or residential treatment, from eighteen years of age to fourteen years.

SB 2330 SD2 HD2 CD1 Extends the hospital sustainability program for an additional year and appropriates \$65 million. These funds assist hospitals in providing important medical services.

SB 2213 SD2 HD1 CD1 Continues the nursing facility sustainability program for one additional year and appropriates \$14 million. These funds assist hospitals in providing important long term care services.

HB 1943 HD1 SD1 CD1 Provides an inflationary adjustment to the methodology used to provide higher reimbursement rates to facilities providing long-term care to Medicaid recipients.

Taxation

HB 1689 HD2 SD2 Establishes an organic foods production tax credit applicable to taxable years beginning after 12/31/2016. This law will support the expansion of organic food crops in Hawaii.

SB 2987 SD2 HD2 CD1 Extends the annual \$103,000,000 allocation of transient accommodations tax revenues to the counties for fiscal year 2016-2017. This supports all four county governments to provide daily services to maintain roads, parks, sewer, refuse and other critical public services statewide.

Education

SB 2476 SD2 HD2 CD1 Enhances early intervention language services for children who are deaf, hard of hearing, or deaf-blind. Requires the DOH, DOE and Executive Office on Early Learning to establish a working group for the purposes of investigating issues related to resources and tools for parents of children who are dear, hard of hearing, or deaf blind and improvements to the statewide system of services that support ageappropriate languages development for children from birth to age five who are deaf, hard of hearing, or deaf-blind.

SB 2387 SD2 HD1 CD1 This law requires a child to provide written documentation of a physical examination performed within twelve months prior to attending seventh grade at a public school.

SB2981 SD1 HD1 CD1 Recognizes American Sign Language as a world language, and allows public school students who pass courses in American Sign Language to receive credit toward world language graduation requirements.

SB 2557 SD2 HD1 CD1 Expands the concussion educational program established under Act 197, Session Laws of Hawaii 2012, and incorporates additional concussion protocol program requirements .

HB 1814 HD1 SD1 CD1 Appropriates funds for a full time position to provide training and track data on public school pupil punishment and use of restraints restrictions

SB 3126 SD2 HD2 CD1 Provides for air conditioning, heat abatement, and related energy efficiency measures at public schools by appropriating \$100 million in general funds to the DOE for these projects.

HB 2569 HD2 SD1 CD1 Requires the Department of Education to establish a goal of becoming net-zero with respect to energy use by 2035. Requires DOE to expedite the cooling of all public school classrooms.

HB 2772 HD1 SD2 CD1- Requires UH to train employees and students on sexual harassment, sexual assault, domestic violence, dating violence, and stalking policies, appoint a confidential advocate to each campus, designate all faculty members as responsible employees under Title IX.

Agriculture

SB 24534 HD1 CD1 Authorizes the court to require a person who violates certain laws pertaining to aquatic resources to: (1) complete an aquatic resources educational class administered by the Department of Land and Natural Resources (DLNR) in addition to or in lieu of paying a monetary fine; and (2) perform community service administered by DLNR in lieu of paying a monetary fine.

SB 2645 SD2 HD1 CD1 Requires the commission on water resource management to establish a program to provide technical assistance to the counties and public water systems to implement standardized water audits of public water systems.

HB 1999 HD1 SD2 CD1 Establishes within the Livestock Revitalization Program a grant program for Qualified Feed Developers.

HB 2582 HD1 SD1 CD1 Requires the Department of Agriculture to develop and implement an Agricultural Food Safety Certification Program that concurrently complies with the FDA Food Safety Modernization Act as it applies to farmers and ranchers. Authorizes and appropriates funds for program staff.

SB 2512 SD1 HD2 CD1 Establishes penalties for the offense of pet animal or equine animal desertion. Imposes a fine not exceeding \$1,000 for each desertion of each pet animal and equine animal and a fine not exceeding \$2,000 for each recklessly caused death of or substantial bodily injury to each pet animal and equine animal, in addition to any other penalties.

Commerce & Consumer Protection

SB 911 SD2 HD2 CD1 Prohibits the use of latex gloves by personnel working in food establishments or by personnel providing ambulance services or emergency medical services beginning on 1/1/2017. Prohibits the use of latex gloves by personnel working in dental health facilities or health care facilities.

HB 1897 HD1 SD1 CD1 Ensures that all insurers in the State, including health benefits plans under chapter 87A, Hawaii Revised Statutes, provide insurance coverage for sexually transmitted disease screenings, including screenings for human immunodeficiency virus and acquired immunodeficiency syndrome.

Transportation

SB2618 SD1 HD2 CD1 Requires the department of transportation to conduct a feasibility study of establishing an interisland and intra-island ferry system.

Environment

HB 1050 SD2 CD1 Mandates the Department of Agriculture to perform specified tasks to address the interisland spread of invasive species

HB 2626 HD1 SD2 CD1 Prohibits the DOH from issuing a permit for a new underground fuel storage tank within 100 yards of the shoreline. Allows DOH to issue a permit to repair or replace existing underground fuel storage tanks. Allows permit holders for existing underground fuel storage tanks located within 100 yards of the shoreline to renew their permits. Prohibits operation of and renewal of a permit for an underground fuel storage tank within one hundred yards of the shoreline, beginning 1/1/2045.

HB 2646 HD2 SD2 CD1 Creates a permanent fuel tank advisory committee to study, monitor, and address fuel tank leak issues.

SB2647 SD1 HD2 CD1 Prohibits the sale, offer to sell, purchase, trade, possession with intent to sell, or barter of any part or product from various animal and marine species. Provides exceptions including for traditional cultural practices protected under the State Constitution. Imposes penalties for violations of the prohibition on trafficking animal parts and products.

Public Safety

SB 2630 SD1 HD1 CD1 Authorizes Hawaii Correctional Industries to sell inmate-made products and services on the open market to the general public. Repeals the prohibition of the sale of such products on the open market.

HB 1907 HD2 SD2 CD1- Requires all law enforcement agencies and departments charged with maintenance, storage, and preservation of sexual assault evidence collection kits to conduct an inventory of all stored kits and report to the Attorney General. Requires the Department of the Attorney General to report to the Legislature on the number of untested sexual assault evidence collection kits being stored, plans and procedures for the disposition of new and untested kits, and related information.

HB 1747 HD1 SD1 CD1 Authorizes a police officer cause to tow a motor vehicle if the operator is arrested or cited for certain intoxicant related offenses.

HB 2632 HD2 SD2 CD1 Requires firearms owners who have been disqualified from owning a firearm and ammunition due to a diagnosis of significant behavioral, emotional, or mental disorder, or due to emergency or involuntary hospitalization to a psychiatric facility, to immediately surrender their firearms and ammunition to the Chief of Police.

Judiciary and Labor

HB 2121 HD3 SD2 CD1 Appropriates \$750,000 from the general fund for civil legal services for low- and moderate-income persons to be purchased by the Judiciary.

HB 1902 HD2 SD1 CD1— The intent of this bill is to adopt a victim- and survivor-centered approach to prosecution of sex trafficking crimes and bring Hawai'i into line with the other forty-nine U.S. States that have adopted comprehensive anti-sex trafficking legislation.
