Update on Legislation

Urban Caucus Legislation

Since last month's update on the Urban Caucus, state lawmakers who are part of the Urban Caucus have introduced a number of measures to address homelessness. Bills to establish or to fund the following initiatives have been introduced:

- Landlord Liaison Project
- Hawaii Interagency Council on Homelessness
- 2-1-1 homeless care coordinator
- Special fund to provide opportunities for private sector matching funds
- Homeless job training programs
- Identify an initial site for building "Housing-First" facilities
- Expand the Uses/Purposes of Existing Special Funds for Housing

Legislative Noise Pollution Task Force

Urban Honolulu residents, living in dense condominium neighborhoods or in close proximity to food and business establishments may experience numerous noise and noise-related disturbances (i.e. mopeds, back-up beepers of trash trucks, lawnmowers, and leaf blowers). To help identify mitigation measures, the Legislature passed Senate Concurrent Resolution No. 183 last year to convene a Legislative Noise Pollution Task Force. Unfortunately, the House and Senate leadership were unable to convene the task force in time. As such, Urban Caucus lawmakers have reintroduced the measures this year, Senate Concurrent Resolution 5: Convening a Legislative Noise Pollution Task Force to review best practices from other states in reducing urban noise pollution. I kindly ask the board to support these two measures.

Confirmation of Alapaki Nahale-a, DHHL Director

On February 2, 2011, the Senate Hawaiian Affairs Committee held its first hearing of the 2011 legislative session. We convened for a confirmation hearing for Alapaki Nahale-a, Governor Neil Abercrombie's nominee to lead the Department of Hawaiian Homelands (DHHL).

Alapaki received tremendous support from the community, with all testimony in support of his nomination to DHHL. Because of his experience as the current Executive Director of the Hawaii Charter Schools Network and roles as a Hawaiian Home Lands Commissioner, a Hawaii County Charter Commissioner as well as his extensive background in community development positions, the committee unanimously supported his appointment to lead DHHL. A full vote by the Senate will occur shortly. Alapaki will be the first DHHL lessee to lead this organization.
