The Senate will now be hearing and deliberating on bills that passed over from the House. This session, the Senate introduced over 1300 bills. Of those, only 384 were approved by the Senate.

Voting by Mail

Enacts voting by mail uniformly across all counties for all elections commencing in 2020 and establishes voter service centers to accommodate

There you can search for measures that are being considered this session based on keywords, the name of a House or Senate member who introduced a measure, or by subject matter committee. When you register for an account using your email address, you can create a clear personalized tracking list for accessing daily updated information to find out when a measure may be scheduled for hearing and electronically submit public testimony for consideration by the committee conducting the hearing.
