This interim, the Senate convened twice for Special Session—in September and November—to Consent to judicial appointments that filled eleven vacancies in the Intermediate Court of Appeals, Family Court, and Circuit Court, including a Circuit Court judge on Maui.

Additionally, the Ways and Means Committee traveled to Maui to visit state agencies, community colleges, hospitals, homeless resource centers, and local businesses that receive funding through the state budget or Grants-in-Aid for non-profits.

The Regular Session of the 30th Legislature opens on January 15, 2020. As the session draws near, our office is preparing measures for introduction. MAUI COMMUNITY CORRECTIONAL CENTER INFO BRIEFING



During the Maui site visit, the Senate Ways and Means and Public Safety, Military, and Intergovernmental Affairs Committees hosted a joint Info Briefing at UH Maui College to hear an update from the State Department of Public Safety. The joint committees received status updates on the emergency appropriation for repairs post-riot at MCCC, the status of additional housing, and the current operations at the facility, including the mental and physical health care of inmates, the purchase and distribution of less than lethal equipment, and overtime payments. The joint committees also heard a final report on changes to existing processes and procedures, vacancies at MCCC, and steps to fill positions. A final report on the March riot remains confidential.
