Chair Gabbard, Vice Chair Richards and Members of the Committee:

Thank you for the opportunity to testify on House Bill 2134, HD2. This bill establishes within the department of agriculture a program specialist position, declares that the general fund expenditure ceiling is exceeded and appropriates funds. The Department is in strong support of this bill.

The program specialist would seek, apply for, and administer grants from federal agencies as well as other sources of funding such as counties, nonprofit organizations, foundations and private organizations. The position would serve as the HDOA representative to the Administration's Federal Grant working group and coordinate opportunities with the applicable divisions within the Department.

There are over 2000 competitive funding opportunities in the Grants.gov database that the specialist can filter through. Using the keywords "Hawaii" and "Pacific", there are over 300 grants and cooperative agreements offered. Searching for "aquaculture", important to Hawaii, displays 60 opportunities. The specialist would have



access to technical assistance offered by the Federal Grant working group and in collaboration with commodity groups, agriculture associations, and other Departments, including UH CTAHR Researchers and Extension Agents, gather content for a robust application.

Due to current capacity limitations, many of the grants HDOA applies for are formula/block grants that are allocated to the states via a formula and are awarded to states that apply for the formula/block grant. The program specialist would be tasked to apply for the competitive grants. The trend for competitive grants in the \$50 to \$100 million range are for regional applications which benefit the Pacific Region. These applications require collaboration and coordination, requiring time and expertise which would be fulfilled by the program specialist. The average salary range of a grant writer in Hawaii is \$78,500 and one grant could more than compensate for the investment in the position. We support this measure so long as it does not impact the budget priorities set forth in the Executive Budget Submittal.

My name is Micah Munekata, and I am the Director of Government Affairs at Ulupono Initiative. We are a Hawai'i-focused impact investment firm that strives to improve the quality of life throughout the islands by helping our communities become more resilient and self-sufficient through locally produced food, renewable energy, clean transportation choices, and better management of freshwater resources.

Ulupono strongly supports HB 2134 HD2, which appropriates funds to establish grant specialist positions within the Department of Agriculture (DOA).

Ulupono supports the State's efforts to actively pursue grant opportunities that help local agriculturalists. Many federal programs are dedicated to state departments or agencies who can apply for funding to support local initiatives. Establishing a position at the DOA for this work is extremely timely, not only to meet the needs of local farmers and ranchers, but also due to the funding that has been made available by the federal government.

The return on investment for the State can be substantial and transformative. For example, from 2014 to 2023, Ulupono provided funding for grant writers with organizations such as The Kohala Center, the O'ahu Agriculture and Conservation Association, and the Hawai'i Farm Bureau. These efforts brought in a total of approximately \$140 million, 100 times the full grant writing investment. Similarly, Ulupono believes that the State should strongly consider general funding DOA grant writers as they will be well worth the investment, and result in millions of dollars in federal funding to further support the State's agricultural efforts.

We appreciate this committee's effort to hear important measures that look to establish long-term support for our local farmers and ranchers.

Investing in a Sustainable Hawai'i

THE STATE DEPARTMENT OF AGRICULTURE REQUEST THAT WILL *BRING MORE MONEY TO HAWAII*

Funding grant writing staff within the Hawai'i Department of Agriculture (HDOA) is a valuable investment that can yield a high return and long-term benefits for the state. The HDOA's operating budget request is \$300,000 in general funds for three currently vacant full-time employee (FTE) positions. Filling these positions follows through on legislators' requests to maximize existing positions toward legislative intent.

HDOA's Ask

HDOA is requesting funding for three existing grant writer positions to be dedicated to securing block and competitive federal grant programs.

- **Examples of block grants:**
 - USDA Specialty Crop Block Grant program (\$500,000)
 - USDA Farm and Ranch Stress Assistance Network program (\$500,000)
 - USDA Micro-Grants for Food Security program (\$3.0 million)
 - USDA Resilient Food Systems Infrastructure Program (\$3.2 million)
- **Additional grants:**
 - Federal State Marketing Improvement Program (\$250,000)
 - Multi-State Specialty Crop Block Grant (\$500,000)
 - Community Wildfire Defense Grant (\$5 million)
 - Readiness and Environmental Protection Integration (\$1 million)

Why Grant Writers?

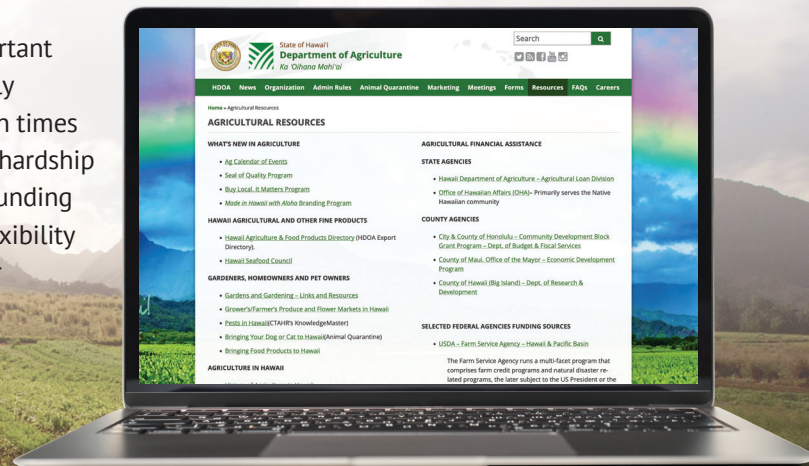
Based on these few examples, this \$300,000 investment could secure \$13.95 million in funding (46.5x return on investment) with more funding available.

Skilled grant writers will help the State to:

- Access federal funds by preparing competitive and compelling grant proposals that align with local farmer needs
- Identify and pursue grants that supplement and leverage existing State resources, maximizing the impact of HDOA's programs

Federal grants will provide:

- Additional means to support important projects and services without solely relying on State funds, especially in times of natural disasters and economic hardship
- A diversified source of long-term funding for HDOA, offering stability and flexibility to address emerging challenges or capitalize on new opportunities

Did You Know That ...

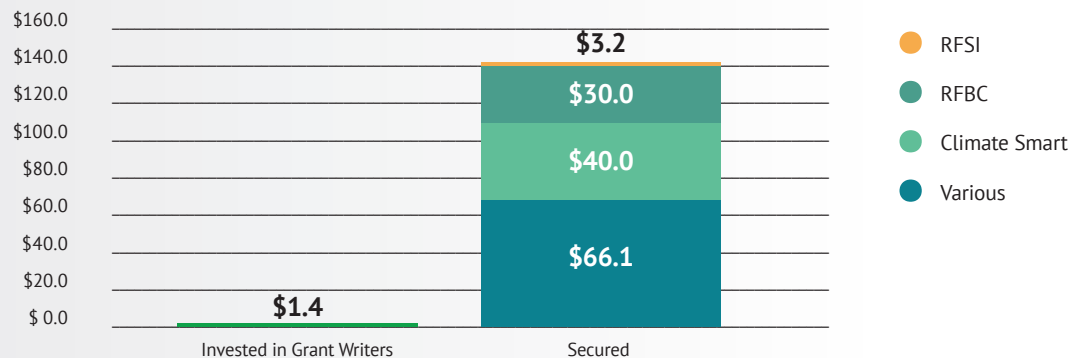
Stimulus bills approved by Congress beginning in 2020 unleashed the largest flood of federal money into the U.S. economy. Roughly \$5 trillion went to households, mom-and-pop shops, restaurants, airlines, hospitals, local governments, schools, and other institutions around the country grappling with the blow inflicted by COVID-19. A number of large USDA grant programs were created. The HDOA needs grant writer support in order to go after these multi-million-dollar opportunities.

Other Benefits for the State

By having grant writers on HDOA's staff, the State will benefit from:

- Grant writing is a specialized skill, and having dedicated grant writers allows other HDOA staff to focus on their core responsibilities leading to better use of resources and expertise.
- Aligned grant-seeking efforts with the HDOA's strategic goals and priorities ensures that all federal funding opportunities will support the agency's long-term objectives.
- Stronger partnership with Hawaii's congressional delegation to better communicate the agricultural industry's needs.

Return on Investment

Grant writers provide a significant return on investment

Investing in grant-writing capacity not only pays for itself but also brings in funds several times the initial investment.

- The Kohala Center, O'ahu Agriculture & Conservation Association, and Hawaii Farm Bureau invested \$1.4 million in grant writers over the past 10 years.
- Secured ~\$140 million for local agriculture (100x return on investment).
- This included unprecedented funding from the USDA.
 - \$40 million from the Climate-Smart Commodities program to help farmers fund climate-smart farming practices that reduce greenhouse gas emissions.
 - \$30 million from the Regional Food Business Centers (RFBC) program to establish regional centers, which provide farmers with grants and connect them with federal programs.
 - \$3.2 million from the newly created USDA Resilient Food Systems Infrastructure (RFSI) program.

Ulupono's Support of Maui Wildfire Efforts

After the Lahaina wildfire, the Hawaii Wildfire Management Organization (HWMO) to support its efforts helping other organizations apply for more than \$60 million from the USDA Community Wildfire Defense Grant (CWDG) program, including the Departments of Land and Natural Resources and Hawaiian Home Lands, non-profit organizations and homeowner's associations.

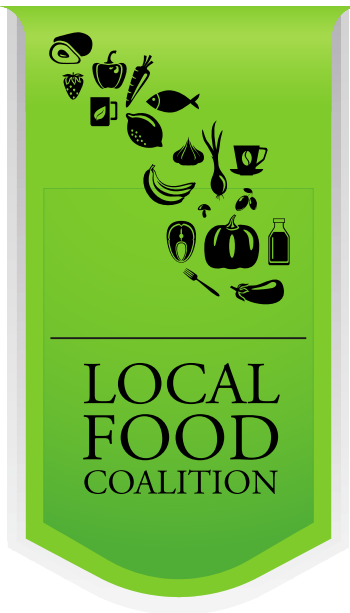
The Hawai'i Farm Bureau supports HB 2134, HD2, which appropriates funds to establish grant specialist positions within the Department of Agriculture.

Access to USDA and other grants can result in increased capacity, new business opportunities, increased employment opportunities and address Hawai'i's goals of increased self-sufficiency and sustainability.

The Land Use Research Foundation of Hawaii (LURF) is a private, non-profit research and trade association whose members include major Hawaii landowners, developers, and utility companies. LURF’s mission is to advocate for reasonable, rational, and equitable land use planning, legislation and regulations that encourage well-planned economic growth and development, while safeguarding Hawaii’s significant natural and cultural resources, and public health and safety.

LURF appreciates the opportunity to express its **support of HB 2134, H.D. 2**, and of the various agricultural stakeholder groups who defend the goals of viable agricultural operations and the conservation and protection of agriculture, including important agricultural lands in Hawaii.

HB 2134, H.D. 2. The purpose of this measure is to establish specialist positions within the DOA to assist farmers and ranchers in applying for, obtaining, and fulfilling the requirements of grants offered by the United States Department of Agriculture, State, counties, or private entities.

LURF’s Position. The Legislature has found that due to the current absence of grant writing and grant administration expertise within the DOA, many federal funding and other grant opportunities for agriculture and related purposes regrettably go unsought or disregarded. The establishment of grant specialist positions to assist farmers and ranchers in applying for, obtaining, and fulfilling the requirements of grants offered by government agencies and private entities, particularly farmers and ranchers who produce local food that is at least partly consumed within the State, is therefore vital.

Many local farmers, ranchers and other agricultural operators struggle to secure financial support and assistance available to help them obtain the financial help required to operate successful businesses. These agricultural stakeholders would also benefit from the assistance of grant specialists who could lend their expertise and provide the informational knowledge and experience necessary to navigate through grant application processes that are sometimes complex. Access to and receipt of such grants could increase production capacity and provide new business and employment opportunities within the local agricultural industry.

Adequate funding is therefore required to address this critical workforce issue, as more expertise, outreach, and support is necessary to assist these farmers, ranchers, and operators to ensure the profitability and long-term sustainability of local agricultural production, as well as to help them work toward the expansion of diversified agriculture and promote the agricultural self-sufficiency of the State.

For the above reasons, LURF **supports HB 2134, H.D. 2** and respectfully urges your favorable consideration.

Hawaii Food+ Policy appreciates the opportunity to testify in strong support of HB2134 HD2 to establish grant specialist positions within the department of agriculture to assist farmers and ranchers in applying for, obtaining, and fulfilling the requirements of grants offered by the United States Department of Agriculture, State, counties, or private entities.

The resources established through HB2134 HD2 will sustain farmers in providing fresh and nutritious food for our communities and boost the state economy. About 9 out of 10 farms in Hawai'i earn less than \$50,000 in annual sales, with farms making less than \$1,000 in annual sales representing 25% of all Hawai'i farms (USDA-NASS, 2017). Financial assistance can be crucial for growers to continue and expand sales, however many farmers lack the time and/or resources to seek out and apply to grants on their own. The grant specialist positions created through HB2134 HD2 would be able to assist farmers and ranchers in successfully obtaining and fulfilling the requirements of grants, ultimately bringing more capital into Hawai'i's agriculture industries.

Importantly, HB2134 HD2 helps level the playing field for farmers and ranchers who lack the technical writing and administrative skills required to apply for and obtain grants, improving equity and producer diversity in the food system. A well-trained and skilled grant writer would be able to assist farmers and ranchers in obtaining USDA, HDOA, County, and other grants by helping them apply for and fulfill the grants' requirements.

Access to USDA and other grants can result in increased capacity, new business opportunities, increased employment opportunities and address Hawai'i's goals of increased self-sufficiency and sustainability.
