Dear Chair Yamashita and members of the Committee,

The State Foundation on Culture and the Arts (SFCA) respectfully provides

COMMENTS on H.B.2246 H.D.1 which transfers the awarding and administration of certain cultural grants from Hawaii tourism authority to the state foundation on culture and the arts and establishes a standing selection committee within the foundation to review and award the cultural grants.

The State Foundation on Culture and the Arts recognizes the importance of government support of Native Hawaiian culture and community and provides support through various granting programs, as funding permits. The SFCA has a history of administering grants since its inception in 1965, administering culture grants, apprentice mentoring grants, biennium grants, Federal relief grants, legislative grants in aid and legislative line items. The SFCA's granting process is outlined in our establishing legislation under HRS [Chapter 9 Part II. Foundation Grant Program sections 9-11 to 9-18](#). SFCA grant review panels are selected per [Hawaii Administrative Rules §3-92](#) and composed of members of the community at large who are knowledgeable and experienced in the subject matter of the panel on which they serve. All panel members serve without compensation.

SFCA has focused in recent years on ensuring unbiased review panels and have concerns a **Standing selection committee** as outlined in HB2246 H.D.1 may create an environment where some grantees could have an unfair advantage.

Grant contracts funded by General, Federal and Special funds are currently administered and monitored by two positions. Should additional granting responsibilities and funding be transferred to SFCA, additional staff would be necessary to administer and monitor the grants.

Aloha Chair Yamashita, Vice Chair Kitagawa, and Members of the Committee,

The Hawai'i Tourism Authority (HTA) offers the following comments on HB2246 HD1 for your consideration. HTA understands the intent of this measure to transfer the awarding and administration of certain cultural grants from HTA to the State Foundation on Culture and the Arts (SFCA).

HTA's work to enhance destination stewardship is bolstered by the work done through our community programs – Community Enrichment, Kahu 'Āina, Kūkulu Ola, the Resort Area Hawaiian Culture Initiative, and Signature Events. These programs follow a specific strategy to sustain Hawai'i as a world-class visitor destination by empowering and developing existing events and efforts into competitive and regenerative tourism experiences. These programs span the gamut from watershed restoration projects with visitor volunteer opportunities, to major festivals and events that draw mindful visitors from our major visitor source markets.

Beyond funding of the event or program, we also provide support such as global promotion of the projects, technical assistance and advice on the tourism distribution system, tourism trends, and the tourism ecosystem. We are developing capacity for these projects to succeed as tourism ventures, and complimenting HTA's initiatives to strengthen workforce development in Hawai'i's visitor industry, assist nonprofits and small businesses with capacity-building tools to improve their ability to engage in tourism, and provide technical assistance training.

Proposals are received through a request for proposals process and are evaluated by committees comprised of HTA staff, visitor industry professionals, and community members. Each contract for each award is managed on HTA's behalf by Kilohana, and overseen by HTA staff from award to execution to final report. The news release announcing 2024 programs is attached.

Our community programs are a keystone of our efforts in regenerative tourism development. Should the responsibility for one or more of these programs be transferred to SFCA, we recommend continued HTA involvement to assist SFCA through the transition of the program and continue to advise on visitor industry matters.

Hawai'i Tourism Authority Continues Tourism's Reinvestment In Community
More than \$7.5 million to support 163 projects, programs and events statewide

HONOLULU – The Hawai'i Tourism Authority (HTA) is furthering its dedication to the community, announcing five key programs to support natural resources, culture and the community: Kahu 'Āina, Kūkulu Ola, Resort Area Hawaiian Culture Initiative, Signature Events, and Community Enrichment. In 2024, HTA is partnering to provide more than \$7.5 million in total funding to support 163 nonprofit organizations, community groups, practitioners, projects and events throughout the state.

"The community is the foundation of our visitor industry and the fabric of the experiences that mindful travelers want to have when they come to our shores," said Mufi Hannemann, HTA Board Chair. "To continue having a thriving, diversified industry that supports our other sectors we need to ensure that we strengthen what we all know makes Hawai'i special — our people, our living cultures, and the places that we hold dear — as without them there is no future."

"Reinvesting in Hawai'i's people, places and multi-cultural traditions remains central to HTA's regenerative tourism mission," said Daniel Nāho'opi'i, HTA's interim president and CEO. "We look forward to working closely with such a diverse range of qualified organizations and practitioners on each island to deliver these programs to our community and our visitors."

HTA has partnered with Kilohana to administer the following programs and contracts in 2024 as part of its focus on destination stewardship. Criteria included demonstrating how the proposed initiative aligns with the state's Aloha+ Challenge and 'Āina Aloha Economic Futures principles toward a circular economy, which HTA remains committed to advancing.

These programs complement HTA's initiatives to strengthen workforce development in Hawai'i's visitor industry, assist nonprofits and small businesses with capacity-building tools to improve their ability to engage in tourism, and provide technical assistance training.

2024 KAHU 'ĀINA PROGRAM

HTA's Kahu 'Āina (formerly known as Aloha 'Āina) program supports responsible community-based entities with an emphasis on 'āina-kānaka (land-human) relationships and knowledge that manage, preserve and regenerate Hawai'i's natural resources. Through the Kahu 'Āina program, HTA is reinvesting more than \$1.2 million (\$1,236,000) in the following 25 community groups and projects in 2024.
