The Department of Business, Economic Development and Tourism (DBEDT) strongly supports HB 2356 HD1 that increases the cap for awards to assist businesses applying for the Small Business Innovation Research (SBIR) Grant Program and the Small Business Technology Transfer (STTR) Grant Program and add additional eligible expenses for the Manufacturing Development Grant Program.

Aloha Chair Yamashita, Vice-Chair Kitagawa, and Members of the Committee:

I am Brian Miyamoto, Executive Director of the Hawai'i Farm Bureau (HFB). Organized since 1948, the HFB is comprised of 1,800 farm family members statewide and serves as Hawai'i's voice of agriculture to protect, advocate and advance the social, economic, and educational interests of our diverse agricultural community.

The Hawai'i Farm Bureau supports HB 2356, HD1, which increases the cap for awards to assist businesses applying for the Small Business Innovation Research Grant Program and the Small Business Technology Transfer Grant Program of the Hawaii Technology Development Corporation, adds purchasing of renewable energy systems as an eligible expense, and clarifies that training on both new and existing manufacturing equipment is an eligible expense, for the Manufacturing Development Grant Program.

As expenses rise, increases in farm revenues and profits are critical to the continued viability of farms and ranches. One way farmers can do this is by "adding value" to raw agricultural crops. Currently, off-grade and excess production is sometimes wasted due to market conditions. Converting them into value-added products will not only increase farm revenue but also provide new business opportunities, increase employment opportunities, and address Hawai'i's goals of increased self-sufficiency and sustainability.

High production costs are a major driver of narrow profit margins for Hawai'i's farmers and value-added food producers. Labor, taxes, land, transportation, utilities, and supplies are all costs of doing business that often result in value-added food producers just being able to break even.

Hawai'i is potentially losing millions of dollars because of the cost of processing agricultural crops into value-added products. HFB supports any program that supports the production of value-added products so that farmers can increase their income while allowing locally produced value-added goods can compete with imported products, strengthening our local economy.

The strength of Hawai'i's economy is dependent upon a diversity in commerce that is resilient to economic downturns and aggressive in creating new growth opportunities. The HTDC programs support this goal.

## TESTIMONY ON HOUSE BILL NO 2356HD1 / SENATE BILL NO. 3045, RELATING TO THE HAWAII TECHNOLOGY DEVELOPMENT CORPORATION

Please accept this testimony in **support** of this bill, to raise the cap and expand the scope of the HTDC Manufacturing Assistance Program and Small Business Innovation Research matching funding program.

Simonpietri Enterprises LLC is an O'ahu-based small business developing new ways to recycle waste generated in Hawaii into sustainable aviation fuel, green hydrogen, organic fertilizer, green cement, and other beneficial recycled-material products. We strongly support the HTDC's matching funding programs, as a powerful way to multiply the State's funding to accelerate innovation and facilitate local manufacturing investment. The requirement to match funding to federal funds awards in the HSBIR program is a prudent way to leverage federal agency technical expertise and reward innovation while maintaining a level playing field.

In part thanks to the coaching and proposal assistance from the HTDC, we received our first-ever Small Business Innovation Research award in late 2020. This was also the first SBIR awarded nationwide to any company to develop technology and processes to manufacture Sustainable Aviation Fuel. We have since gone on to win six additional SBIR awards, all for innovations focused on addressing Hawaii's hard-to-recycle waste streams like construction and demolition debris, and converting those wastes into locally manufacturable products that address imports that drive up Hawaii's cost of living, such as fossil fuel, fertilizer, and building materials.

We are now designing a small manufacturing facility, the Aloha Sustainable Materials Recycling and Fertilizer Facility (Aloha SMRFF) in Campbell Industrial Park in Kapolei, to divert over 200 tons per day of construction and demolition waste from the state's only C&D landfill, and remanufacture that waste to displace over 10,000 tons per year of imported fossil fuels, fertilizers, and building materials. This facility is the first step to demonstrating our Aloha Carbon manufacturing process to manufacture pipeline-quality renewable fuel from solid waste generated in Honolulu.

In the 3.5 years since launching our SBIR efforts, we have been awarded a total of \$60,000 in HSBIR matching funds and over \$4 million in federal research funds, a 66-times multiple on the State's funding. We used the HSBIR funds to apply for our first patent, and to hire five University of Hawaii undergraduate interns, three of whom are now full-time employees on our team.

We have now been selected for our first-ever federal manufacturing grant, to construct the fertilizer manufacturing line of our Aloha SMRFF project. State matching funds like the MAP are critical to allow us to actually bring in these federal funds and build the facility to employ 2 dozen skilled workers.



We appreciate the opportunity to testify on this measure, and urge your support for this bill.

HBI's drug development activities are focused on small molecule drugs that block intracellular and extracellular bacterial toxins. Product opportunities include anti-toxin drugs for the lethal factor from B anthracis and the botulinum toxin from C botulinum



Over the years HBI has been awarded over \$130 million in federal research and development grants and contracts. HBI currently has 17 employees and has projected annual revenues of \$5.5 mil. HBI strives to create as many high paying technology positions as possible and it is our mission to expand further and open new positions. In addition, HBI has been awarded matching funds from HDTC through the Hawaii Small Business Innovation Research (HSBIR) Program for some of our programs. The HSBIR program is instrumental to the company to further our research, support our current staff, fill gaps, and bolster our ability to secure additional federal funding.

HBI has demonstrated the quality of its vaccine candidates against complex viruses such as Dengue as well as the utility of vaccine technology platform. The dengue vaccine program was acquired by Merck & Co. HBI has also demonstrated a regulatory pathway for its vaccines though successful interactions with the FDA. Through our active West Nile virus vaccine program, HBI has established manufacturing capabilities in the Iwilei facilities. The West Nile vaccine project serves both to demonstrate these capabilities as well as advance the vaccine to human testing. It is important to note that with these efforts are done here in Honolulu and jobs and funds are kept in Hawaii rather than engaging a contract manufacturer on the mainland.
