1 **Fiscal Implications:** This measure will not impact the priorities identified in the Governor's  
2 Executive Budget Request for the Department of Health's (Department) appropriations and  
3 personnel priorities.

4 **Department Testimony:** The Department supports SB2119 to amend Hawaii Revised Statutes  
5 (HRS) Section 328-17.6(b) and (d) to allow out-of-state pharmacies to transfer prescription  
6 information to in-state pharmacies for the initial fill/dispensing of prescriptions.

7 Currently, an out-of-state pharmacy may only transfer prescription information to an in-  
8 state pharmacy for refilling purposes. When a visitor to the State requires acute medication like  
9 antibiotics while on vacation, additional steps are necessary for an in-state pharmacy to dispense  
10 the visitor's initial out-of-state prescription. This may potentially delay treatment.

11 Provided that all other prescription and dispensing requirements have been met, the  
12 Department supports reducing barriers and facilitating access to prescription medications  
13 originating from out-of-state pharmacies. Accordingly, the Department supports amending HRS  
14 Section 328-17.6(b) and (d) to permit out-of-state transfers of prescription information for initial  
15 fill/dispensing.

S.B. 2119, RELATING TO OUT-OF-STATE PRESCRIPTIONS**

Chair Nakashima and Members of the Committee:

My name is James Skizewski, and I am the Executive Officer of the Board of Pharmacy (Board). The Board supports this bill.

The purpose of this bill is to authorize out-of-state pharmacies to transfer prescription information to an in-state pharmacy for the initial fill of a prescription.

The Board has no issues with this bill amending Hawaii Revised Statutes (HRS) sections 328-17.6(b) and (d), to allow out-of-state pharmacies to transfer prescription information to in-state pharmacies for the initial fill/dispensing of prescriptions. This bill will align HRS chapter 328 with the Board's administrative rules. Specifically, Hawaii Administrative Rule (HAR) §16-95-84, Transfer of Prescriptions, states:

- (a) Transfers of prescription information for the purpose of initial fill or refill dispensing is permissible between pharmacies provided the pharmacist transferring the prescription provides all information necessary for a valid prescription, and records on the prescription, the name and location of the pharmacy receiving the prescription, the name of the pharmacist receiving the prescription information, the date of transfer, and the name of the pharmacist transferring the prescription, or notes the pharmacist's name on the electronic files, and records that the prescription is inactivated or made void for future refills at the location from which it is being transferred.
- (b) The pharmacist receiving the transferred prescription information shall indicate the name of the pharmacist transferring the prescription as well as the transferring pharmacist's or pharmacy name, the transferring pharmacy's name, location, and original prescription number, the original date the prescription was

written, the number of refills or quantity remaining on the prescription, and the last date the prescription was filled.

(c) All records of transferred prescriptions shall be maintained for a period of five years from the date of filling or refilling.

The Board acknowledges the importance of this bill, which will prevent the possible delay of treatment related to the access of prescription medication. Hawaii is a travel destination for many out-of-state visitors, and it is common for a patient traveling to the State, to be in need of an antibiotic or similar medication. Currently in this situation, pharmacists are required to get in touch with the patient's out-of-state practitioner for a verbal order. This practice creates an additional barrier to healthcare and delay in treatment. The bill will resolve this issue by providing clear and direct guidance, which permits the transfer of prescription information for the purpose of initial prescription dispensing and refills.

**Re: SB 2119, Relating to Out-of-State-Prescriptions**

Chair Nakashima, Vice Chair Sayama, and committee members, thank you for this opportunity to provide testimony on SB 2119, which authorizes out-of-state pharmacists to transfer prescription information for the initial fill of a prescription within Hawai'i.

**Kaiser Permanente Hawai'i SUPPORTS SB 2119.**

Kaiser Permanente Hawai'i is Hawai'i's largest integrated health system that provides care and coverage for approximately 271,000 members. Each day, more than 4,400 dedicated employees and more than 650 Hawai'i Permanente Medical Group physicians and providers come to work at Kaiser Permanente Hawai'i to care for our members at our 19 medical facilities, including Moanalua Medical Center, providing high-quality care for our members, and delivering on our commitment to improve the health of the 1.4 million people living in the communities we serve.

Kaiser Permanente Hawai'i manages a high volume of prescription drug fills and patient care responsibilities, and we regularly evaluate our pharmacy operations to eliminate waste and redundancy. Kaiser Permanente Hawai'i supports SB 2119 because permitting a Hawai'i pharmacy to accept a prescription transfer from an out-of-state pharmacy for an *initial fill* benefits the patient ***without*** increasing patient safety risk, aligns with state pharmacy rules (Haw. Admin. Rules §16-95-84) and avoids operational waste and redundancy.

It is common for a patient vacationing in Hawai'i to require an acute medication such as an antibiotic. When the patient contacts their physician, the prescription is sent to a pharmacy in the patient's home state. Currently, it is impermissible for a Hawai'i pharmacy to receive prescription information from an out-of-state pharmacy for dispensing the first fill in Hawai'i. A Hawai'i pharmacist must then contact the prescriber for a verbal order in order to fill the initial prescription in Hawai'i, resulting in treatment delays for the patient and workflow redundancy. This scenario occurs several times per week at Kaiser Permanente Hawai'i pharmacies. Given the high rate of



occurrence, SB 2119 will substantially benefit a large patient population by helping to decrease patient wait times, improve customer service, and enhance patient care overall.

Dear Chair Nakashima, Vice Chair Sayama, and Members of the Committee on Consumer Protection and Commerce:

We submit this testimony on behalf of Walgreen Co. (“Walgreens”). Walgreens operates stores at more than 9,000 locations in all 50 states, the District of Columbia, and Puerto Rico. In Hawaii, Walgreens has 17 stores on the islands of Oahu and Maui.

Walgreens is in **support** of this measure, which authorizes out-of-state pharmacists to transfer prescription information for the initial fill of a prescription medication.

Hawaii hosts many out of state visitors who often can require prescription medication while visiting. When an out-of-state patient requires prescription medication, the patient’s practitioner would typically issue the patient’s prescription to an out-of-state pharmacy. Because Hawaii’s pharmacy statute does not explicitly permit out-of-state pharmacies to transfer prescription information to in-state pharmacies for dispensing an initial prescription fill, local pharmacists must contact out-of-state practitioners for a verbal prescription order. This results in workflow redundancy for the pharmacy and the medical practitioner and ultimately can cause a delay in treatment for the out-of-state patient.

This measure makes it clear that an out-of-state pharmacy may transfer prescription information for both initial dispensing and refills. Walgreens supports making out of state transfers for initial fill prescriptions easier for pharmacists to reduce workflow redundancy and simultaneously simplify the process for patients to ensure timely administration of prescription medication. As such, Walgreens is in support of this measure and asks the committee to pass it as is.
