#### In consideration of **SENATE BILL 2143** RELATING TO THE DEPARTMENT OF LAND AND NATURAL RESOURCES

Senate Bill 2143 proposes to appropriate funds to the Wildfire Management Branch of the Department of Land and Natural Resources Division of Forestry and Wildlife to provide nonprofit organizations with grants for wildfire preparedness and mitigation programming. The Department of Land and Natural Resources (Department) strongly supports this measure.

The Department's Division of Forestry and Wildlife (DOFAW) is the primary responder for wildland fires across 1,368,002 acres of the State of Hawai'i's forested watersheds (or 26% of the land area in Hawai'i) and supports federal and county responders on remaining areas in the state. DOFAW is also tasked with coordinating prevention outreach and planning efforts, which includes assisting communities in developing Community Wildfire Protection Plans, encouraging communities to join the National Fire Protection Association's Firewise Community Program, as well as apply for federal grant programs like the United States Forest Service's (USFS) Wildland Urban Interface Grant Program and Community Wildfire Defense Grant Program. DOFAW does not have the staffing capacity or resources to adequately provide programming for all the State's wildfire preparedness needs, and instead partners with nonprofit organizations such as the Hawai'i Wildfire Management Organization to fill this gap. Wildfire prevention nonprofits cannot count on receiving federal grant funding annually through DOFAW and are often outcompeted by larger, national nonprofits for federal grants. Therefore, it is necessary to secure permanent State funding to support nonprofit partners that provide education, training, and support for communities and large landowners to manage fire risks through mitigation plans and projects. Providing permanent annual funding for wildfire prevention nonprofits through DOFAW will increase

the Department's capacity to assist communities to plan, prepare, and mitigate the potential impacts from future wildfires that are increasing in frequency, size, and duration due to increased periods of drought coupled with heavy loading of wildfire fuels on unmanaged lands. There is an urgent need for additional funding and resources for the State's fire service to do pre-suppression work such as fuel reduction and improved forest management, maintain readiness and capacity for fire suppression, and restore and recover landscapes in the aftermath of wildland fires. By funding pre-suppression and recovery, including wildfire preparedness and mitigation programming, public exposure to catastrophic wildland fire will be decreased.



Aloha Chair Wakai, Chair Inouve, and Vice Chair Elefante and Members of the Committees:

The Nature Conservancy (TNC) **supports** SB 2143, relating to the Department of Land and Natural Resources, which appropriates funds to the Wildfire Management Branch of the Department of Land and Natural Resources Division of Forestry and Wildlife to provide nonprofit organizations with grants for wildfire preparedness and mitigation programming.

Hawai'i's wildfire risk is growing, and new programs, policies, state positions, and partnerships are needed to respond to this threat. Extreme weather is becoming increasingly common, bringing massive rainfall and flooding in some regions and widespread heat and drought in others, with disastrous impacts on both humans and nature. To Senator Glenn Wakai, Chair of the Committee on Public Safety and Intergovernmental and Military Affairs and Senator Lorraine Inouye, Chair of the Committee on Water and Land:

I am submitting testimony in support of SB 2143 Relating to the Department of Land and Natural Resources (DLNR). I have been working at the University of Hawai'i at Mānoa in the field of wildfire science and management since 2013, however, I am submitting this testimony as an individual and not as an official University of Hawai'i (UH) spokesperson.

The proposed bill correctly recognizes the threat that wildfire poses to the state and defines a key need to support wildfire prevention statewide, namely funding for non-profit efforts that support all of our fire agencies, especially via critical pre-fire prevention, education, and risk mitigation.

As an active participant in Hawaii's 'wildfire community' since 2013, I can personally attest to the value and increased capacity that non-profit programs like Hawaii Wildfire Management Organization and the Watershed Partnerships bring to the DLNR in terms of supporting fire mitigation efforts and community health and safety. This has ranged from direct educational programs, to Community Wildfire Protection Plan development, to hazardous fuels removal and conversion, to the facilitation of federal grant programs and project funding, to facilitating relationships and lessons learned from national and international wildfire programs. This role has become critical to the success of wildfire mitigation and prevention programs by both DLNR and County Fire Departments and by providing a more reliable source of operational funds would dramatically increase the impact these kinds of programs are already having in the state.
