The Natural Energy Laboratory of Hawaii Authority (NELHA) is pleased to support SB 2291 as it relates to NELHA and establishes an advisory board focused on workforce development. We have been quite active in developing opportunities for workforce development over the past several years.

NELHA has been working with the University of Hawaii and the local schools on the island of Hawaii for the past several years to bring administrators, professors, and instructors to our facility in Kona to better explain the kinds of skills and training necessary for the businesses here. Based on these meetings we established an educational tour program and we have hosted over 300 students since starting school tour program last November. Students learn about NELHA and what companies occupy at the tech park and had a chance to tour the

research campus, talk to experts and participate in a scavenger hunt for an edible treat.

Activity books and internship brochures were also provided.

We also hosted meeting with Good Jobs Hawaii (GJHI) and HOST Park clients and community members learned about Good Jobs \$35 million workforce development initiative which is aiming to fill education gaps and provide support for internships and programs in select sectors including food security and ocean technology. NELHA based businesses also provided input and feedback on what skills are needed to meet their company objectives. We also met with the CEO of ClimbHI and are part of their CLIMBHI bridge program which connects Hawaii schools to businesses and other organizations.

Aloha Chair DeCoite, Vice-Chair Wakai, and Members of the Committee:

I am Brian Miyamoto, Executive Director of the Hawai'i Farm Bureau (HFB). Organized since 1948, the HFB is comprised of 1,800 farm family members statewide and serves as Hawai'i's voice of agriculture to protect, advocate, and advance the social, economic, and educational interests of our diverse agricultural community.

The Hawai'i Farm Bureau supports SB 2291, which establishes advisory boards, focused on workforce development, to the Agribusiness Development Corporation, Hawaii Technology Development Corporation, and Natural Energy Laboratory of Hawaii Authority.

Hawai'i's farmers and ranchers are aging. The average age of Hawai'i's farmers and ranchers exceeds 60 years old, and if they were in other professions would most likely be retired. Yet many of these farmers and ranchers are those who provide agricultural products to supermarkets, restaurants, hotels, farmers' markets, and the Farm to School program and truly make a difference in reducing imports.

Multigenerational commercial farms and ranches are facing the prospect of closure because succession plans do not exist. As these farmers and ranchers retire, their lands go out of agricultural production. There is an urgent need for curriculum, interns or apprentices who are willing to not only work on these farms but also take over their operations.

HFB requests that the President of the Hawai'i Farm Bureau be included as a member on the ADC Advisory Board.

This measure will provide support for the next generation of new farmers who are interested in developing the skills and knowledge needed to be successful agriculture businesses.
