Chair Wakai, Vice Chair Elefante, and members of the Committee:

The Department of Law Enforcement (DLE) supports Senate Bill 2236 with recommendations.

This bill requires the DLE to conduct a voluntary firearm buyback program in each county of the State and makes an appropriation to conduct the required buybacks.

The DLE recommends \$825,000 for the appropriation.

The DLE also recommends removing subsection (b) of SECTION 2 of the bill which requires the DLE to ". . . adopt rules in accordance with Chapter 91, Hawaii Revised Statutes, to implement the firearm buyback program." The adoption of administrative rules to carry out a gun buyback program is not needed and will take a prolong period of time to complete before any gun buyback program would be held. The DLE recognizes the need for accountability and recommends that a report to the Legislature would accomplish the goals of accountability to the Legislature and the community.

Chair Wakai and Members of the Committee

I am writing to provide a comment on behalf of myself and Hawaii Firearms Coalition on SB236.

Although we are against the concept of buyback programs due to their questionable effectiveness, we acknowledge the importance of providing a means for individuals to safely dispose of unwanted firearms. Therefore, we offer the following comments and suggestions, hoping they will be considered should this bill proceed.

First, I would like to outline the reasons for our opposition to buyback programs:

- Questionable Effectiveness in Reducing Crime: Buyback programs have not been
 proven to significantly impact crime rates, as the firearms typically surrendered are not
 those commonly used in criminal activities. Many surrendered firearms are old, broken,
 or otherwise unwanted. Notably, the majority of firearms turned in on Oahu were rifles,
 which are least likely to be used in crimes.
- Cost and Resource Allocation: The organization and funding of buyback programs are
 costly, diverting funds from potentially more effective uses. Recent buybacks on Oahu
 required substantial law enforcement resources, as well as expenses related to the
 purchase and disposal of the firearms.

- Impact on Law-Abiding Citizens: Buyback programs tend to attract law-abiding citizens
 rather than criminals, leaving the firearms most likely to be used in crimes in circulation.
 Moreover, individuals in lower-income communities, who may rely on firearms for
 self-defense, are often the ones to surrender their firearms for gift cards.
- **Symbolic Rather Than Substantive Change:** Without addressing deeper issues like illegal gun trafficking, gang violence, and socio-economic disparities, buyback programs serve more as symbolic gestures than real solutions to gun violence.
- False Sense of Security: Buyback programs can create a false sense of security by suggesting that a significant step has been taken towards reducing gun violence, while the underlying issues remain unaddressed. A serious examination of organized crime and gang violence in our communities is necessary for any real change to occur

Instead of a buy-back, we feel that a much better option would be an amnesty program that could operate in a similar method but would provide a year-round option for people to dispose of unwanted/needed firearms. We make the following recommendation for the proposed program.

Introduction to the Hawaii Continuous Firearms Amnesty and Accountability Act

In an effort to enhance community safety and reduce the prevalence of unsecured and unwanted firearms, We propose the Continuous Firearms Amnesty and Accountability Act. This pioneering legislation introduces a year-round, no-questions-asked program that allows individuals to surrender firearms in exchange for gift cards, ensuring anonymity and legal immunity for participants. The Act emphasizes not only the collection of firearms but also mandates a robust framework for accountability and transparency through regular reporting to the Attorney General's Office.

By providing a continuous, accessible avenue for firearm surrender, coupled with clear communication about the program's terms and the value of surrendered firearms, the Act aims to foster a safer environment for all Hawaii.

Section 1: Program Details

• The program operates year-round, offering a no-questions-asked, anonymous firearm surrender opportunity.

- All county police chiefs must put in place policies and procedures to accept the surrendering of unwanted firearms at any time during regular business hours.
- Firearms may be surrendered at any county police station or via collection by a police officer being called to a location to do so.
- Information about the program must be displayed at all county police departments and on any website operated by or for the police department.
- Individuals will not be required to provide identification or disclose information about themselves or the firearms but must state that they wish to surrender a firearm.
- Surrendered firearms will be exchanged for gift cards: \$200 for standard firearms and \$500 for short-barreled rifles, short-barreled shotguns, or automatic weapons.
- The program shall be funded through the state budget and potential federal grants.

Section 2: Reporting and Oversight

- Monthly Reporting: Each county's police department must submit a written report to the Attorney General's Office within 15 days of each month's end. This report should detail the number and types of firearms collected and the total cost incurred in the program.
- Annual Reporting: Additionally, a comprehensive annual report, including the same details, must be submitted within 15 days of the year's end.
- These reports aim to maintain transparency and allow for the assessment of the program's effectiveness and financial management.

Section 3: Participant Information and Legal Immunity

- Before accepting the surrender of a firearm, each individual shall receive a leaflet or flyer, which will include the following information:
 - Acknowledgment that the firearm is being turned in voluntarily.
 - Assurance of the program's anonymity and the individual's immunity from criminal prosecution regarding the firearm's previous ownership or use.
 - A statement indicating that the firearm might be of more value than the gift card amount and that other disposal options, potentially yielding more money, are available.

Section 4: Justification and Community Benefits

- The continuous availability of the program offers greater accessibility and flexibility, encouraging more individuals to participate.
- It contributes to public safety by continuously removing unsecured and unwanted firearms from the community and preventing potential misuse.
- The program's anonymity and legal immunity clauses are likely to build community trust and encourage participation.

• Regular reporting ensures accountability and helps in evaluating and improving the program's effectiveness.

Conclusion

We feel that implementing The Hawaii Continuous Firearms Amnesty and Accountability Act will not only reduce the number of unwanted firearms but also to ensure transparency and accountability in its execution. It provides a sustainable approach to enhancing public safety while respecting the rights and concerns of firearm owners.

Comments:

I disagree with the assertion that Gun Buybacks work to reduce gun related crimes, and there has been no evidence to show as such.

Typically a criminal will either dump, or resell their gun after using it in a crime, usually to whoever they bought it from Though some have used buybacks as a means to dispose of evidence by turning in guns that are 'too hot' for them to resell.

There has also been some controversy about buybacks recently, where parts from firearms that were supposedly destroyed after a buyback were found intact after the contractor responsible disassembled the firearms and legally resold parts. This isn't counting other incidents where contractors and even law enforcement officers have marked such firearms as destroyed, then turned around and sold them on the black market.

The only reason I don't stand in opposition to this bill is that it does offer a method for those who inherit firearms from a family member or loved one who have no idea what to do with them a means to safely dispose of them. However this often causes guns with historic provenance to be destroyed or be turned in for a petty fraction of what their worth is. Thus, I would like to propose the following changes:

- 1) Advertise and offer a year round turn in where the public can turn in firearms in their possession to their Police Department's Headquarters.
- 2) The Police Department will take custody of the firearms and check to make sure they are legal and not connected to a crime.
- a) should the firearm in question be connected to a crime or is otherwise illegal, they will be given whatever the standard payout is for the firearm turn in and the Police will properly dispose of the firearm.

b) should the firearm in question be otherwise legal to sell, Police will maintain custody of the firearm and provide information to the possessor on how to sell the firearm to a Federal Firearms Licensee (gun store). Once the Possessor finds a FFL willing to purchase the firearm and is processed, Police will turn over the firearm directly to the FFL and the FFL will pay the Possessor.

Senators of the PSM Committee,

I express my opposition to SB2346 (Relating to Firearms).

You Can't Buyback Something Never Purchased by You

SB2346 incorrectly suggests that a politicized "voluntary firearm buyback program" reduces criminal activities involving firearms. The so-called "voluntary firearm buybacks," which are erroneously named, only involve persons wishing to dispose of unwanted firearms. Criminals will continue to utilize any tools of opportunity within their local communities as long as the criminals are not secured in correctional facilities or otherwise apprehended by law enforcement officials. Violent criminal acts, by objective definition, don't require the use of a firearm, and can occur via any medium via any perpetrator, as recently demonstrated by the January 23, 2024 acid attack that occurred in the Ala Moana area:

In other parts of the island, perpetrators of violence do not care if they face non-law enforcement citizens or not. They'll use whatever they have against whoever stands against their criminally-bent will. "Buying back" a firearm won't magically stop all violent incidents like yesterday's violent attack in Makaha. If violence reduction and public safety are true priorities of the Hawaii State Legislator, then the corresponding full-spectrum of countermeasures to violence and detriments to public safety need to be prioritized and funded. The occasional sensationalized "voluntary firearm buyback" events won't stop the next hand-to-hand assault, the next acid attack, the next blunt-force trauma attack, the next stabbing, or the next act of arson, which are all acts of violence. Narrowly focusing on one threat vector such as firearm crimes and parading a self-declared success does not automatically constitute enhancement of public safety.

Using the term "voluntary buyback" is an incorrect assertion since the local state government did not perform the labor that allows a firearm to be "bought back" at all. Moreover, the appropriated funds used to acquire the surrendered firearms within the proposed bill are derived from the tax payers. If the funds were derived from individual legislators and individual supporters of this bill as part of a privatized mass purchase of voluntarily surrendered firearms, then, the term, buyback may be utilized since there is a private pool of funds being used. That is not the case with **SB2346**, which expressly uses public funds.

SB2346 furthermore does not articulate how surrendered arms will be appraised properly. The public is being persuaded to blindly trust that all of the individuals that surrender firearms will be properly compensated without articulating how such valuation would be defined.

For the reasons stated above, there is no reasonable means for me to support this proposed bill.
