RELATING TO EMERGENCY MANAGEMENT POWERS

The Department of Budget and Finance (B&F) offers comments on this bill.

Senate Bill No. 2512, S.D. 1, amends Section 127A-12, HRS, to set reporting requirements for the Governor for the transfer of contributions or grants received through the exercising of emergency management powers and make other non-substantive amendments.

While B&F supports improving government transparency, B&F notes that the proposed reporting requirements may be onerous to completely adhere to during a crisis and may interfere with the State's ability to efficiently respond to it. B&F is amenable to working with the Legislature to develop reporting processes for transfers via emergency management powers that would not require a statutory amendment.

Aloha Chairs Dela Cruz and Rhoads, Vice-Chairs Moriwaki and Gabbard, and Members of the Committee:

Thank you for the opportunity to submit testimony to **OPPOSE** on SB 2512 SD1.

This bill would amend HRS 127A-12 to establish a reporting requirement for the transfer of public monies by the Governor, pursuant to the Governor's Emergency Powers.

HI-EMA recognizes the value of transparency of government, especially during a disaster. The proposed reporting requirement which would amend HRS 127A-12, would be in direct conflict with the Governor's emergency powers and the ability to lead the state during a declared disaster.

The proposed amendments to HRS 127A-12 would establish reporting guidelines for reallocations or transferring of monies during a declared disaster. During a disaster, the Governor may request an expedient means of reallocating funding to provide lifesaving and property recovery efforts during a declared emergency.

The amendments recommended would require that during a disaster, a calculated request to reallocate of funds be made when weighting against the immediacy of response actions which affect life, safety, and the well-being of the public. This impedes the ability during a disaster to transfer monies and resources to fund the timely response efforts appropriately during a declared emergency.
