Chairs Lee and McKelvey and Members of the Committees:

The Department of the Attorney General offers the following comments.

The bill requires, effective January 1, 2026, each parking lot with public paid parking spaces in the State to accept payment of parking fees by credit card and debit card. It also requires that each parking meter that collects parking fees for any public paid parking space in the State be maintained in working order to accept payment by credit card and debit card. The bill does not prohibit a parking lot having public paid parking spaces or parking meters from accepting payment by cash. The counties are required to adopt ordinances to enforce these requirements.

Article VIII, section 5, of the Hawaii State Constitution states: "If any new program or increase in the level of service under an existing program shall be mandated to any of the political subdivisions by the legislature, it shall provide that the State share in the cost." Because the counties would need to either retrofit current machines or install new meters to comply with the requirements of this bill, it appears that there would be a cost to the counties. Because of the increase in the current level of service under an existing program, and insofar as the bill does not provide that the State share in any cost incurred by the counties, the mandated requirements in this bill may be subject to constitutional challenge.

Accordingly, we respectfully suggest that the Committees consider whether the counties must be mandated to implement and enforce the new parking meter requirements. If the Committees believe that the counties must be mandated to implement and enforce the new parking meter requirements, then we recommend that the bill be amended to provide for the State's share in any cost incurred by the counties.

Chairs Lee and McKelvey, Vice Chairs Inouye and Gabbard and Members of the Committees, thank you for the opportunity to submit testimony on S.B. 2896.

The Department of Accounting and General Services (DAGS) offer **comments** to S.B. 2896, which requires all parking meters that collect parking fees for any public paid parking space in the State to be maintained in working order to accept payment by cash, credit card, and debit card. DAGS continues the conversion in DAGS-managed parking facilities. Currently, 11 of the 12 DAGS-managed parking facilities on Oahu have been converted to pay stations or smart meters that accept payment by cash, credit card, and debit card. DAGS is currently working on upgrading eight (8) DAGS-

managed parking facilities on the neighbor islands. Pay stations and smart meters are

on-hand awaiting installation as funding allows.
