Senate Bill 3266 proposes to appropriate funds to the Department of Transportation for vegetation management projects to reduce the risks of wildfires across the State and declares that the general fund expenditure ceiling is exceeded. The Department of Land and Natural Resources (Department) supports this measure and offers the following comments.

The Department of Transportation should consult with the Departments' Division of Forestry and Wildlife and the county fire departments to prioritize areas where vegetation management will occur along State roadways to reduce wildland fire fuel loads and devise a maintenance schedule for these areas.
