# REQUESTING THE DEPARTMENT OF AGRICULTURE TO ESTABLISH A SUSTAINABLE FOOD SYSTEMS WORKING GROUP Senate Committee on Agriculture and Environment

The Office of Hawaiian Affairs (OHA) will recommend to the Board of Trustees (BOT) that it <u>SUPPORT SCR69/SR57</u>, which requests that the Department of Agriculture to establish a sustainable food systems working group, and **request an amendment**.

It is no coincidence that the Hawaiian words for land and food are so intertwined. The word for land, 'āina, is understood to mean that which feeds. Native Hawaiians have long understood and practiced both land stewardship and the cultivation of food systems here in our island home. Additionally, Hawaiians recognize that food is not just what fills our 'ōpū. It contributes to the health and well-being of individuals and communities.

It's this foundation that helped inform OHA's 15-year strategic plan, Mana i Mauli Ola. This strategic plan incorporates four directions: educational pathways, health outcomes, quality housing and economic stability. These directions are rooted in three foundations: 'ohana (family), mo'omeheu (culture) and 'āina. Based on these directions and foundations, our strategic plan recognizes that the economic stability, educational success, health and well-being of Native Hawaiians requires a vibrant food system, particularly one that is culturally grounded.

Hawai'i currently imports more than 85% of its food, leaving the state vulnerable to supply chain disruptions and external market forces. By bringing together invested partners from various sectors, including government agencies, non-governmental organizations, and academic institutions, the Sustainable Food Systems Working Group will serve as a catalyst for collaboration and innovation in advancing Hawai'i's food economy toward sustainability and vibrancy.

One key benefit of this resolution for the Native Hawaiian community is its potential to enhance food sovereignty and self-sufficiency. The inclusion of indigenous perspectives

and practices within the Sustainable Food Systems Working Group is essential for respecting the practices and traditions of the Native Hawaiian people. Traditional farming methods and crop varieties play a vital role in preserving biodiversity and promoting ecological sustainability. By engaging Indigenous experts and practitioners in the development of the interagency food systems plan, SCR69/SR57 ensures that the unique needs and values of the Native Hawaiian community are adequately represented and respected.

OHA stands ready to participate in this working group. We believe it aligns with our strategic plan and the work we're doing to carry it out. Thus, we respectfully request the following amendment to add our agency to the working group:

BE IT FURTHER RESOLVED that the Sustainable Food Systems Working Group is requested to consist of the following members;

- (1) The Deputy to the Chairperson of the Board of Agriculture, who is also requested to serve as chairperson of the Sustainable Food Systems Working Group;
- (2) A representative of the Department of Health, to be designated by the Director of Health;
- (3) A representative of the Department of Business, Economic Development, and Tourism, to be designated by the Director of Business, Economic Development, and Tourism;
- (4) A representative of the Office of Hawaiian Affairs, to be designated by the Chief Executive Officer;
- (45) A representative of the Office of Planning and Sustainable Development, to be designated by the Acting Director of the Office of Planning and Sustainable Development;
- (56) The Coordinator of the Hawaii Climate Change Mitigation and Adaptation Commission, or the Coordinator's designee;



## TESTIMONY OF SHARON HURD CHAIRPERSON, BOARD OF AGRICULTURE

SENATE CONCURRENT RESOLUTION NO. 69 AND SENATE RESOLUTION NO. 57 REQUESTING THE DEPARTMENT OF AGRICULTURE TO ESTABLISH A SUSTAINABLE FOOD SYSTEMS WORKING GROUP.

Chair Gabbard, Vice Chair Richards and Members of the Committee:

Thank you for the opportunity to testify on Senate Concurrent Resolution No. 69 and Senate Resolution No. 57 that request the Department of Agriculture (Department) to establish a Sustainable Food Systems Working Group (Working Group). The Department offers comments and has strong concerns.

The Working Group is requested to have 15 members, seven from the executive and legislative branches of State government, three from the University of Hawaii, and five representatives from private organizations.

The Working Group is requested to develop an "Interagency Food Systems Plan" (Plan) tied to "sustainable development goals" (not sourced) that address the following seven food system planning themes (Page 3, lines 19-32):

- (1) Food as a human right and healthy food for all;
- (2) Social equity and food justice;
- (3) Food system resilience;
- (4) Agriculture and food system sustainability;



- (5) Food at the center of a circular economy;
- (6) Sustainability education, workforce development, and fair labor; and
- (7) Good food governance.

The resolutions also request the Working Group to tie "sustainable development goals" to the following "food system planning elements". (Page 4, line 39 to page 4, line 33)

- (1) Public health and nutrition;
- (2) Household food security;
- (3) Food safety;
- (4) Social equity and food justice;
- (5) Secure and affordable land access;
- (6) Food system resilience, disaster preparedness, and response;
- (7) Biocultural restoration;
- (8) Ecological sustainability;
- (9) Land and water resource use;
- (10) Food waste;
- (11) Biosecurity;
- (12) Infrastructure and capital investment;
- (13) Sustainable economic development and local food economies;
- (14) Sustainable fisheries;
- (15) Education and food literacy;
- (16) Workforce development;
- (17) Fair labor; and
- (18) Good food governance

The Department notes the continued lack of operational definitions and existence of multiple redundancies between the "food system planning themes" and the "food system planning elements".

The Working Group is also requested to incorporate into the Plan "scientific indicators and a metrics system to track progress". (Page 4, lines 35-37)

The Plan and recommendations to implement the Plan are due to the 2025 Legislature. The Department is requested to provide administrative, and staff support to the Working Group and prepare the Plan.

The Department has strong concerns.

The Working Group has no representatives of production agricultural organizations or agricultural operators. The Interagency Food Systems Plan risks becoming an academic exercise without the full and sustained participation of local farmers who produce food that most, if not all, of the elements of the Plan will be based on.

As in past iterations, the seven "food system planning themes" remain undefined and the Working Group's task is made more complex with the addition of 18 "food system planning elements". The Plan is to include "scientific indicators and a metrics system to track progress" which demand unambiguous operational definitions of the "food system planning themes" and "food system planning elements".

The Department is requested to "provide administrative and staff support to the Sustainable Food Systems Working Group, including the preparation of the interagency food systems plan" (Page 5, lines 12-14). The Department is very concerned about the voluminous duties to the Department in establishing the Working Group, addressing the 7 themes and 18 elements, writing the Plan and recommendations for implementation of the Plan to the 2025 Legislature, providing staff support including any meetings that may have to be in accordance with Chapter 92, and writing and printing the Plan. These duties require the Department to redirect the already severely diminished professional staff resources away from the State's highest priority of increasing the

economic viability of existing agricultural businesses and assist in the establishment of new ones in direct support of increasing local food self-sufficiency and export.

The Department is very concerned that the Working Group and the Plan not become an academic exercise with no meaningful impact on the State's highest priorities of increasing the economic viability of existing agricultural businesses and assisting in the establishment of new ones in direct support of increasing local food self-sufficiency and exports.
