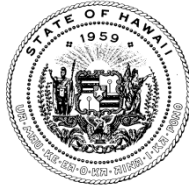

**RELATING TO MOTOR VEHICLES**

The Department of Transportation (DOT) supports H.B. 107, which authorizes the renewal of driver's licenses online or by electronic or digital means

The DOT recommends the same process for an application for renewal by mail and online, which requires the applicant to be examined by a licensed medical examiner, provide a notarized statement certifying the applicant does not possess any valid license issued by another licensing authority (unless license is concurrently surrendered), and any other information that is reasonably necessary to confirm the identity of the applicant and their fitness to continue to operate a motor vehicle.

SUBJECT: H.B. 107 - Relating To The Renewal of Driver's Licenses  
HEARING: Tuesday, February 28, 2023, 2:00 p.m.

The City and County of Honolulu, Department of Customer Services (CSD) supports  
this bill with amendments.

Pursuant to Section 6-402 of the Revised Charter of the City and County of  
Honolulu, CSD administers the motor vehicle registration program and issues driver's  
licenses for the island of Oahu.

This bill provides for the renewal of driver's license by mail and through electronic or  
digital means. However, the requirements for applicants renewing by mail should also  
apply to applicants renewing online. CSD supports this bill with an amendment whereby the  
requirements for a medical examination, notarized statement, and production of other  
information to verify the applicant's identity also be applied to online renewal applicants.

CSD also respectfully requests that the effective date be amended to July 1, 2025, to  
allow additional time for the counties to implement the program.
