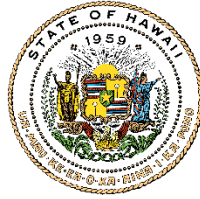
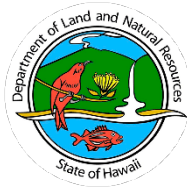

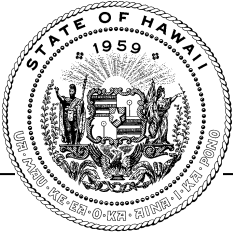

Chair Lee, Vice Chair Inouye, and Members of the Senate Committee on Transportation and Culture and the Arts:

The Office of Planning and Sustainable Development (OPSD) offers the following **comments** on SB 785 which codifies Sustainable Development Goals based on the United Nations' Global Goals and indicators within the Hawai'i State Planning Act. The OPSD strongly supports and promotes the U.N. Sustainable Development Goals (SDGs), and notes that the UN SDGs are now codified by reference within the Hawai'i State Planning Act. Hawai'i Revised Statutes §226-65 codified the [State's Climate and Sustainability Strategic Action Plan—the Hawai'i 2050 Sustainability Plan](#), within the Hawai'i State Planning Act. The 2021 publication of the Hawai'i 2050 Sustainability Plan aligned the U.N. Sustainable Development Goals (SDGs) with over 150 of the State of Hawai'i's laws and policies.

I wholeheartedly OPPOSE SB785 “ Relating to Sustainable Development Goals. The only thing sustainable about the United Nation’s Sustainable Development Goals (Agenda 21, Agenda 2030 and the updated Hawaii 2050 plan) is the impoverishment of the state and our residents as well as any other community that unwisely implements these goals. The original goals were approved in the 1990’s. The goal to move to 100% renewable energy using antiquated technologies such as wind and solar that are known for their unreliability, unavailability and high cost. “[Smart](#)” Cities are where everyone is under surveillance and controlled. I oppose any development of “Smart City” in Hawaii.

Unfortunately, most people have not been studying Agenda 21/2030 due to their very busy lives supporting their families in this high cost state (thanks to all the taxes created by our legislature and city councils). However, there are many of us who have been tracking this program in its 30 year lifetime. At first most of us thought it was a pipe dream, however, with every passing year

I oppose SB785. It lists a gigantic number of aggressive goals that I don't believe can be legislated into existence as this bill seems to be trying to do. The question that comes up again and again for me is HOW are you doing to do all these super ambitious goals. The details on the how are glaring and pretty concerning given this is a proposed *law*. That feels like a misunderstanding and misuse of our legislature.

According to the Cambridge dictionary, a law is a rule the government proposes...not a list of utopian goals. The first example cited in the definition include laws against drinking in the streets. It is a specific rule or a specific decree to put a certain amount of money towards a new policy, department or initiative.

In contrast, in SB785, is a laundry list of utopian "goals", many of which sound wildly unrealistic. For example, 5(B) "Eliminate all forms of violence against all individuals in the public and private spheres." That would be nice. Has any society achieved that ever? I don't think so. Should we also add a line about giving every child a pony?

Or 3(D) "Reduce by one-third premature mortality from non-communicable diseases through prevention and treatment and promote mental health and well-being." I mean, who wouldn't want that, but how are you going to achieve it? We are in a mental health crisis. What specific ideas do you have to promote mental health? A law should be outlining programs and policies, not a laundry list of fantasy goals.

Along the same lines, this bill tries to make law sweeping goals about eliminating poverty. But you can't just say you're going to solve poverty and have it be so. We provide many programs to support the poor and vulnerable – for example, food stamps, Quest for medical insurance, section 8, etc. If you think another one is necessary then propose a specific policy solution. Vs this long list of arguably not-realistic goals with little explanation of how they'll be achieved.

In 1(D), this bill demands that all poor and vulnerable people have the same access to economic resources and property ownership. I would like to see less inequality, but *how* is that going to happen? Is this achievable without mass property seizure by the government? The lack of details on the how is disconcerting.

Or 4 (A) “Ensure that all children complete and have access to equitable and quality primary and secondary education leading to relevant and effective learning outcomes;” or 4(D) “Substantially increase the number of people who have relevant skills, including technical and vocational skills, for employment and for entrepreneurship”,. Yes, that’d be great if everyone received quality education and more people had relevant skills for employment and entrepreneurship. Much easier said than done. *How* are you going to do it?

And then there are random things like “ Adopt measures to ensure the proper functioning of food commodity markets and their derivatives and facilitate timely access to market information”. Really? Who does that help? I don’t think the people of Hawaii.
