A BILL FOR AN ACT

RELATING TO LICENSE PLATES.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1	SECTION 1. Section 249-9, Hawaii Revised Statutes, is				
2	amended by	y amending subsection (a) to read as follows:			
3	"(a)	The number plates hereinabove referred to shall be			
4	used upon all vehicles for which a tax has been paid pursuant to				
5	sections 2	249-1 to 249-13. All [such] number plates shall:			
6	(1)	[Bear] If issued before January 1, 2025, bear the word			
7		"Hawaii" along the upper portion of the plate and the			
8		words "Aloha State" along the lower portion of the			
9		plate;			
10	(2)	If issued on or after January 1, 2025, for affixture			
11		on:			
12		(A) A zero-emission vehicle, bear the word "Hawai'i"			
13		along the upper portion of the plate and the			
14		words "Aloha State" along the lower portion of			
15		the plate and contain a colorful design			
16		reflecting the State's unique environment;			

1		(B)	A hybrid vehicle, bear the word "Hawai'ı" along
2			the upper portion of the plate and the words
3			"hybrid vehicle" on any portion of the plate as
4			may be determined by the directors of finance of
5			each county through majority consent and use the
6			rainbow design featured on number plates, except
7			special number plates, issued in the State
8			beginning in 1991; and
9		(C)	A gasoline-powered vehicle, bear the word
10			"Hawai'i" along the upper portion of the plate and
11			the words "gas vehicle" on any portion of the
12			plate and use the rainbow design featured on
13			number plates, except special number plates,
14			issued in the State beginning in 1991;
15	[(2)]	(3)	Have a distinct contrast between the color of the
16		plat	e and the numerals and letters thereon; and
17	[(3)]	(4)	Be of such shape, size, and color, and with such
18		arra	ngements of letters and numbers as may, subject to
19		sect	ions 249-1 to 249-13, be determined by the
20		dire	ctors of finance of each county through majority
21		cons	ent[-];

- 1 provided that effective January 1, 2024, all number plates
- 2 issued pursuant to subsection (a)(2) shall bear the word
- 3 "Hawai'i" along the upper portion of the plate and the words
- 4 "Aloha State" along the lower portion of the plate, and both
- 5 "Hawai'i" and "Aloha State" may either contain all uppercase or
- 6 lowercase letters or have the first letter of each word be
- 7 uppercase.
- 8 The numerals on all [such] number plates shall be not less
- 9 than three inches in height and the strokes thereof not less
- 10 than three-eighths inch in width, except in the case of
- 11 motorcycles, in which case the numerals shall not be less than
- 12 one inch in height and the strokes thereof not less than one-
- 13 eighth inch in width.
- 14 The director of finance of the city and county of Honolulu
- 15 shall contract annually on behalf of the counties for the
- 16 purchase of all number plates, tags, or emblems required. The
- 17 council of each county shall appropriate and cause to be paid
- 18 over to the party with whom the director of finance of the city
- 19 and county of Honolulu shall contract, or to the director of
- 20 finance of the city and county of Honolulu as the director may
- 21 direct, [such] the sum or sums as the director of finance of the

- 1 city and county of Honolulu shall determine to be the county's
- 2 proportionate share of the expense of [such] the contract and
- 3 the charges connected therewith. The contract shall be made by
- 4 the director of finance of the city and county of Honolulu as
- 5 agent of the several counties, and the proportionate liability
- 6 of each county shall be stated in the contract. Notwithstanding
- 7 any other provision of the law, the contract shall constitute a
- 8 valid obligation of each county for its proportionate share."
- 9 SECTION 2. The directors of finance of each county shall
- 10 issue a new series of number plates for any number plates issued
- 11 pursuant section 249-7, Hawaii Revised Statutes, for affixture
- 12 to hybrid vehicles pursuant to section 249-9(a)(2)(B), Hawaii
- 13 Revised Statutes, or gasoline-powered vehicles pursuant to
- 14 section 249-9(a)(2)(C), Hawaii Revised Statutes.
- 15 SECTION 3. Statutory material to be repealed is bracketed
- 16 and stricken. New statutory material is underscored.
- 17 SECTION 4. This Act shall take effect on June 30, 3000.

Requires license plates to include 'okina in the word "Hawai'i". Establishes requirements for number plates issued for zero-emission, hybrid, and gasoline-powered vehicles beginning 1/1/2025. Requires the continued use of the rainbow number plate design for hybrid and gasoline-powered vehicles. Effective 6/30/3000. (Proposed SD1)
