## A BILL FOR AN ACT

RELATING TO COMPENSATION FOR COURT-APPOINTED COUNSEL.

## BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1	SECTION 1. Section 802-5, Hawaii Revised Statutes, is		
2	amended by amending subsection (b) to read as follows:		
3	"(b) The court shall determine the amount of reasonable		
4	compensation to appointed counsel, based on the rate of [\$90]		
5	\$150 an hour; provided that the maximum allowable fee shall not		
6	exceed the following schedule:		
7	(1)	Any felony case	[ <del>\$6,000</del> ] <u>\$12,000</u>
8	(2)	Misdemeanor case-jury trial	[ <del>3,000</del> ] <u>\$6,000</u>
9	(3)	Misdemeanor case-jury waived	[ <del>1,500</del> ] <u>\$3,000</u>
10	(4)	Appeals	[ <del>5,000</del> ] <u>\$9,000</u>
11	(5)	Petty misdemeanor case	[ <del>900</del> ] <u>\$1,800</u>
12	(6) Any other type of administrative or		
13	judicial proceeding, including cases		
14		arising under section 571-11(1)[7	7] <u>or</u>
15		571-14(a)(1)[7] or [ <del>571-14(a)</del> ](2)	[ <del>3,000.</del> ] <u>\$6,000.</u>
16	Payment in excess of any maximum provided for under		
17	paragraphs (1) to (6) may be made whenever the court in which		

- 1 the representation was rendered certifies that the amount of the
- 2 excess payment is necessary to provide fair compensation and the
- 3 payment is approved by the administrative judge of that court."
- 4 SECTION 2. In accordance with section 9 of article VII, of
- 5 the Constitution of the State of Hawaii and sections 37-91 and
- 6 37-93, Hawaii Revised Statutes, the legislature has determined
- 7 that the appropriation contained in this Act will cause the
- 8 state general fund expenditure ceiling for fiscal year 2024-2025
- 9 to be exceeded by \$ , or per cent. The reasons
- 10 for exceeding the general fund expenditure ceiling are that the
- 11 appropriation made in this Act is necessary to serve the public
- 12 interest and to meet the needs provided for by this Act.
- 13 SECTION 3. There is appropriated out of the general
- 14 revenues of the State of Hawaii the sum of \$2,500,000 or so much
- 15 thereof as may be necessary for fiscal year 2024-2025 to carry
- 16 out the purposes of this Act.
- 17 The sum appropriated shall be expended by the department of
- 18 budget and finance for the purposes of this Act.
- 19 SECTION 4. Statutory material to be repealed is bracketed
- 20 and stricken. New statutory material is underscored.
- 21 SECTION 5. This Act shall take effect on July 1, 2024.
