# A BILL FOR AN ACT

RELATING TO LABELING OF MACADAMIA NUTS.

**BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:**

1           SECTION 1. The legislature finds that Hawaii-grown  
2 commodities of the State are an important sector of Hawaii's  
3 economy and the branding of these commodities is critical to  
4 protect and safeguard consumers. The macadamia nut production  
5 industry in Hawaii is one such example. According to statistics  
6 from the United States Department of Agriculture National  
7 Agricultural Statistics Service, the value of the macadamia-nut  
8 crop in Hawaii in 2022 totaled \$33,200,000.

9           Accordingly, the purpose of this Act is to enhance,  
10 preserve, and protect the premium brand and cachet of Hawaii-  
11 grown macadamia nuts by clarifying the labeling requirements for  
12 macadamia nuts, including requiring the country of origin to be  
13 included on the principal display panel of a consumer package of  
14 raw or processed macadamia nuts.

15           SECTION 2. Section 486-120.5, Hawaii Revised Statutes, is  
16 amended as follows:

17           1. By amending subsections (a) and (b) to read:



1           "(a) If a label on a consumer package contains language or  
2 branding that all of the raw or processed macadamia nuts  
3 contained in the package were grown in [~~Hawaii,~~] the State, the  
4 label shall be worded, "100% Hawaii-Grown Macadamia Nuts",  
5 "Hawaii-Grown Macadamia Nuts", "100% Hawaiian Macadamia Nuts",  
6 or "Hawaiian Macadamia Nuts", and shall appear on the principal  
7 display panel of the package.

8           (b) If a label on a consumer package contains language or  
9 branding that a portion of the raw or processed macadamia nuts  
10 contained in the package [~~was~~] were grown in [~~Hawaii,~~] the  
11 State, the label shall be worded "Hawaii-Grown Macadamia Nuts",  
12 preceded by the per cent by weight of the macadamia nuts  
13 contained in the package that were grown in [~~Hawaii,~~] the State,  
14 and shall appear on the principal display panel of the package.  
15 The per cent by weight of the macadamia nuts in the package  
16 shall be the percentage calculated by dividing the weight in  
17 pounds of the macadamia nuts grown in [~~Hawaii~~] the State that  
18 are in the package by the weight in pounds of all macadamia nuts  
19 in the package and multiplying the quotient by one hundred. A  
20 listing of the countries of origin of the portion of the  
21 processed macadamia nuts not grown in the State that are



1 included in the package shall also be shown on the principal  
2 display panel pursuant to section 304 of the Tariff Act of 1930  
3 (19 U.S.C. 1304), as amended."

4 2. By amending subsections (d) and (e) to read:

5 "(d) Any person keeping, offering, displaying, exposing  
6 for sale, or soliciting for sale, any raw or processed macadamia  
7 nut product[~~, which~~] that represents or [~~which~~] is branded or  
8 labeled that all or a percentage or portion of the macadamia  
9 nuts were grown in [~~Hawaii,~~] the State, shall make available to  
10 the administrator, upon demand, documented proof that the amount  
11 of macadamia nuts represented to be grown in the State[~~, was~~]  
12 were grown in the State.

13 (e) It shall be a violation of this part[+] to use a  
14 label:

15 (1) [~~To use a label containing~~] Containing the words,  
16 "100% Hawaii-Grown Macadamia Nuts", "Hawaii-Grown  
17 Macadamia Nuts", "100% Hawaiian Macadamia Nuts", or  
18 "Hawaiian Macadamia Nuts", or similar wording, or to  
19 otherwise represent that all of the macadamia nuts in  
20 the package were grown in [~~Hawaii,~~] the State, if any



1 portion of the macadamia nuts contained in the package  
2 [~~was~~] were not grown in the State;

3 (2) [~~To use a label, as~~] As provided for under subsection  
4 (b), containing the words "Hawaii-Grown Macadamia  
5 Nuts" preceded by a percentage, if less than the  
6 specified percentage or none of the macadamia nuts in  
7 the package [~~was~~] were grown in the State; or

8 (3) [~~To use a label representing~~] Representing that any of  
9 the macadamia nuts contained in the package [~~was~~] were  
10 grown in the State, if none of the macadamia nuts  
11 contained in the package [~~was~~] were grown in the  
12 State."

13 SECTION 3. Statutory material to be repealed is bracketed  
14 and stricken. New Statutory material is underscored.

15 SECTION 4. This Act shall take effect on July 1, 3000.

Clarifies labeling requirements for macadamia nuts. Requires the country of origin to be included on the principal display panel of a consumer package of processed macadamia nuts.
