
A BILL FOR AN ACT

RELATING TO SUMMER ELECTRONIC BENEFITS TRANSFER FOR CHILDREN PROGRAM.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1 SECTION 1. Chapter 302A, Hawaii Revised Statutes, is
2 amended by adding to subpart C of part II a new section to be
3 appropriately designated and to read as follows:

4 "§302A- Summer electronic benefits transfer for children
5 program. The department shall:

6 (1) Work with the department of human services to maximize
7 participation in the federal summer electronic
8 benefits transfer for children program established
9 pursuant to the federal Consolidated Appropriations
10 Act, 2023, P.L. 117-328;

11 (2) Share all data determined by the departments to be
12 necessary to adhere to the requirements of title 42 of
13 the United States Code section 1762, and section 346- ;
14 and

15 (3) Follow the federal guidelines and regulations
16 established pursuant to section 502 of title IV of
17 division HH of the Consolidated Appropriations Act,

1 2023, P.L. 117-328, to maximize flexibility to
2 distribute summer meals through non-congregate
3 distribution."

4 SECTION 2. Chapter 346, Hawaii Revised Statutes, is
5 amended by adding to part II a new section to be appropriately
6 designated and to read as follows:

7 "§346- Summer electronic benefits transfer for
8 children program. (a) Subject to the availability of funds,
9 the department may implement the federal summer electronic
10 benefits transfer for children program. To implement the
11 program, the department shall work with the department of
12 education to maximize participation in the federal summer
13 electronic benefits transfer for children program established
14 pursuant to the federal Consolidated Appropriations Act, 2023,
15 P.L. 117-328.

16 (b) To the extent that appropriations or private funds are
17 made available, the department may contract with one or more
18 providers to administer the summer electronic benefits transfer
19 for children program. Any contract executed pursuant to this
20 section shall be exempt from the competitive procurement
21 processes of chapters 103D and 103F.

1 (c) The department may accept grants, donations, and
2 contributions from private or public sources for the purposes of
3 this section, which may be expended consistent with the
4 grantors' or donors' wishes."

5 SECTION 3. There is appropriated out of the general
6 revenues of the State of Hawaii the sum of \$53,500 or so much
7 thereof as may be necessary for the fiscal year 2024-2025, and
8 one permanent full-time equivalent (1.0 FTE) program specialist
9 position SR-24 to implement the summer electronic benefits
10 transfer for children program; provided that no funds shall be
11 made available under this Act unless the federal government
12 provides matching funds of \$53,500 for the purposes for which
13 this sum is appropriated.

14 The sum appropriated shall be expended by the department of
15 education for the purposes of this Act, including the hiring of
16 staff, system modifications, and operating expenses.

17 SECTION 4. There is appropriated out of the general
18 revenues of the State of Hawaii the sum of \$2,050,000, or so
19 much thereof as may be necessary for the fiscal year 2024-2025,
20 and one permanent full-time equivalent (1.0 FTE) program
21 specialist position SR-24 to implement the summer electronic
22 benefits transfer for children program; provided that no funds

1 shall be made available under this Act unless the federal
2 government provides matching funds of \$2,050,000 for the
3 purposes for which this sum is appropriated.

4 The sum appropriated shall be expended by the department of
5 human services for the purposes of this Act, including the
6 hiring of staff, system modifications, and operating expenses.

7 SECTION 5. New statutory material is underscored.

8 SECTION 6. This Act shall take effect upon its approval.

Establishes the Summer Electronic Benefits Transfer for Children Program. Makes appropriations.

JUSTIFICATION SHEET

DEPARTMENT: Human Services

TITLE: A BILL FOR AN ACT RELATING TO SUMMER ELECTRONIC BENEFITS TRANSFER FOR CHILDREN PROGRAM.

PURPOSE: To implement the federal Summer Electronic Benefits Transfer for Children Program (Summer EBT).

MEANS: Add new sections to subpart C of part II of chapter 302A, Hawaii Revised Statutes (HRS), and to part II of chapter 346, HRS, and make appropriations.

JUSTIFICATION: The Consolidated Appropriations Act, 2023, P.L. 117-328, authorized a permanent, nationwide Summer EBT beginning in 2024. Summer EBT is intended to reduce hunger and food insecurity for children who lose access to free and reduced price meals through the National School Lunch Program and School Breakfast Program during the summer when school is not in session. The U.S. Bureau of Labor Statistics included in its September 2023 report that over the previous 12 months, food prices in Hawaii increased 5.3 percent.

Participation in the federal program requires a 50/50 match of state funds. To develop and implement this new program, the Departments of Education and Human Services will need additional general funds to modify data systems and administrative processes and funds for additional human resources.

Impact on the public: Providing additional nutrition assistance benefits to families with children when they are not in school during the summer will help reduce child hunger.

Impact on the department and other agencies: The Departments of Education and Human

Services will need to collaborate and develop appropriate data-sharing agreements, an application portal, and communication plans to implement the new program, with the assistance of the Department of the Attorney General.
